- 1. Learned counsel for the appellant present. Mr. Fazal Shah, Additional Advocate General alongwith Mr. Hashmat Khan, Superintendent for respondents No. 1 and 2 and Miss. Farkha Aziz Khan, Advocate/Legal Advisor for respondents No. 3 and 4 present.
- 2. On 22.11.2022 the appeal was admitted to full haring by a bench of this Tribunal suspending the operation of the impugned order in respect of the recovery of executive allowance putting the respondents on notice, who were duly served through TCS but they did not put appearance on the next date i.e. on09.12.2022. On 09.12.2022 the learned Adll; AG sought some time to submit reply and the matter was fixed for 30.01.2023. On 30.01.2023 learned counsel for respondent No.4 filed wakalatnama and sought time while none of the other respondents filed reply nor made any request for adjournment. It was then a last opportunity was granted on payment of Rs. 10000/- cost for filing reply as well as arguments before D.B but today again neither reply was filed nor the cost was deposited rather adjournment was again sought with no good ground. However, Miss. Parkha Aziz Khan, Advocate/Legal Advisor of Excise and Taxation submitted an application and sought adjournment saying that joint parawise
