That appellant is the permanent residents of Khyber pakhtunkhwa and is an employee/civil servant of Respondents Department. (Copy of CNIC is attached as Annexure "A"). That the appellant was promoted to the post of

superintendent in the year 2018.

That in 2021 the Respondent No. 2 to 4 made requisition to the Respondent No.5 to 7 for recruitment on the post of Assistant Director (Admin) BPS-17 Commissionerate of Mines, Labour Welfare, KP which was accordingly advertised through KPPSC as per rules of 2017.(Copy of Advertisement is attached as annexure "B")

That it is pertinent to mention here that there is only a single post of Assistant Director (Admin) Commissionerate of Mines, Labour Welfare, KP and as per old rules notified on $22/\overline{11}/2017$ the post was to be filled " Initial Recruitment". (copy of old rules notified on 22/11/2017 is attached as annexure "C")

That the competent Authority i.e Standing Service Rules Committee (SSRC) amended the rules and notified the same on 05/05/2023 according to which the recruitment process was amended from "by initial recruitment" to "by promotion on the basis of seniority-cum-fitness, from amongst the holders of the posts of superintendents(BPS17), having two years' service as such", (Copy of New Rules notified on 05/05/2023 is attached as annexure "D").

That in the light of the amended rules the appellant being competent, eligible, fit and having the right to be promoted to the said post made his departmental representation to competent authority. (Copy of departmental Representation is attached as annexure 'E")

That the respondent No.3 forwarded the departmental representation of the appellant to respondent No.2(Copy of letter is attached as annexure "F")

That respondent No.2 wrote letter to the establishment department vide letter No. SO(E)/MDD/2-8/2023/Vol-IV/7702-04 dated 25/05/2023 in response to which Establishment departed responded and vide letter No. Kc. SO(O & M) E & AD/10-1/2023 dated 26/06/2023 refused to withdraw the said post from KPPSC.(Copy of letters attached as Annexure "G" and "H").

9) That appellant is constrained to approach to the Hon'ble Tribunal for redressal of his grievances inter alia on the following grounds:

Grounds:

8)

A. That the act and omission of the respondents/department is illegal, unconstitutional, without jurisdiction, without lawful authority against facts and materials on the record therefore, needs the interference of this Hon'ble Tribunal.

B. That the act and omission of the department is not only factually incorrect and legally untenable but also is against the principles of natural justice.

C. That sending requisition for recruitment of the post by the department to the KPPSC and its advertisement of the same does not create any right in favour of the persons applied rather the competent authority has always the discretion to increase or decrease the number of posts and to withdraw the same hence the authority malafidely omitted to exercise its authority by denying to the appellant the right of the appellant due to which the appellant will suffer a lot.

D. That the appellant has performed duties efficiently, honestly and without giving any chance of complaint to his superior which fact also goes in his favor and there is no law which permits the respondents to continue with the process of recruitment under old rules after the amendment in the rules.

E. That the appellant is civil servant and legal and constitutional guarantee is available to him to be dealt

with in accordance with law he however, has not been treated as such.

- F. That the act and omission of the department and respondents is in clear violation/disregard of the fundamental rights of the appellant, Therefore, the said act and omission of the department is not effective on the right of the appellant and the same has caused gross miscarriage of justice to the appellant.
- G. That the department is legally/constitutionally bound to follow the directions of law, rules and justice.
- H. That the respondents have failed to apply their independent/administrative mind to the matter and therefore have reached to an erroneous conclusion which is not sustainable in the eye of law.
 - That after amendment in the rules filling of the post of Assistant director admin on initial recruitment is without any justification is the clear violation of law and rules which is not the mandate of law and as per superior courts judgments it has strictly been prohibited.
- J. That when the appellant is otherwise fit and competent they cannot be bypassed in such a manner and in this regard record needs to be examine in order to bring truth to surface.
- K. That it is the constitutionally guaranteed right of appellant to be treated with equality but here the appellants are being discriminated and was neglectedwithout applying the proper procedure.
- L. That appellant seek permission of this Honorable Tribunal to raise other grounds at the time of hearing of the instant appeal.
