
*The appellant submits as follows:*

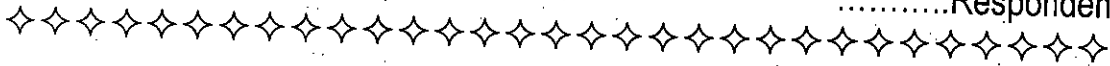



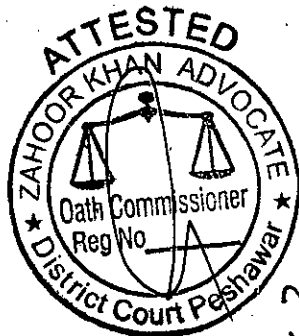
