

RESPECTFULLY SHEWETH,

That the Respondent No. 01 and 02 humbly submit as under:

- 1- That the Respondent /Appellant has filled besides other the subject service appeal, in which the date of hearing has been fixed on 27/07/2023.
- 2- That the Applicant came to know later on that this honorable tribunal has passed an order under Rule-12 of the KP Service Tribunal, 1974 and placed the Applicants ex-parte and their right to file the reply was struck off. (Copy of the order dated: 05/06/2023 is Annexure-A)
- 3- That the Applicants are aggrieved with this order and if they are not provided the right of reply and defense, great miscarriage of justice is likely to be caused to them. Moreover, it is very respectfully submitted that the right of defense has been struck off purportedly under the

provision of Civil Procedure Code, 1908 which is not stricto sensu applicable on the proceedings of this honorable tribunal.

- 4- That the law stresses upon the principle that applications and appeals may be decided on merit and they may not be dismissed on technical grounds. The principle of natural justice also requires that before passing an order, parties to the case may be given opportunity of proper hearing and defense.
- 5- That this honorable tribunal is vested with enormous powers to make such orders as may be necessary for the ends of justice and prevent the abuse of the process of the tribunal.
- 6- That the Applicants further seek permissions to assist this honorable tribunal with further arguments if required.

Prayer:

In view of the above submissions, this honorable tribunal may recall the order dated: 05/06/2023 and provide the right to reply and defense in the subject service appeal for the ends of justice and fair play.



APPEAL UNDER SECTION-4 OF THE SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED OFFICE ORDER NO. 602/3/10/DA DATED 14.04.2022 PASSED BY THE RESPONDENT NO.2 WHEREBY MINOR PENALTY OF WITHHOLDING PROMOTION FOR A PERIOD OF THREE YEARS HAS BEEN IMPOSED UPON THE APPELLANT & AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITH IN THE STATUTORY PERIOD OF NINETY DAYS.
