APPEAL U/S-4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974.

Respectfully Sheweth:-

Appellant humbly submits as under

1. That the appellant was initially appointed as Police Constable on 29-06-1993 in the Police Department, District, Nowshera and is serving the department with full zeal and zest and to the entire satisfaction of his superiors.

- 2. That the appellant did passed Lower Examination from PTC Hangu and then was promoted as Head Constable.
- 3. That in the year, 2012 the appellant did passed Intermediate Examination and then was promoted as ASI on 15-04-2014 and was confirmed as ASI in the year, 2017. (Copy of Intermediate Examination list is attached as ANNEX-A).
- 4. That the appellant also did passed Upper Course Examination in the year, 2022 however the appellant being qualified, eligible and entitled in all respect has been deprived and ignored from his right of promotion thus the appellant along with some other officers (ASI's) immediately filed joint application before respondent No-3 which was finally decided vide letter number 9549-54 dated 05-07-2019 passed by respondent No-3 after getting some legal opinion/guidance from AIG, Legal and the appellant along with some other aggrieved were given their inter-se seniority with their Colleagues with whom they underwent Intermediate Examination Course. (Copies of letter dated 05-07-2019 along with some other necessary documents are attached as ANNEX-B).
- 5. That it is worth mentioned here that despite the letter ibid and all other facts pertains to the seniority, requisite criteria, ACR in the light of Standing Order and fulfillments of requirements courses number ie 09, the appellant have been ignored and deprived from promotion and confirmation by the respondents.
- 6. That the appellant being qualified, eligible and entitled for Upper College Course Training was sent to PTC, Hangu in the year, 2022 being ASI, but it is to be added that no doubt the appellant has been given the seniority

with his colleagues but his other colleagues have been promoted as SI's and were sent for training ibid.

8. That the department was required to promoted and confirmed the appellant with his batch mates/colleagues for enabling him to meet the requirement/necessary trainings/courses/period for enlistment "List-F" but the department badly failed and junior then the appellant were given chance for completion of the requirements of list-F thus the appellant being aggrieved filed an departmental representation before respondent No-3 but of no avail hence the instant appeal on the following amongst other grounds; (Copy of departmental appeal is attached as ANNEX-C).

GROUNDS;

- A. Because, the act, commission and omission of the respondents by way of ignoring and depriving the appellant from his due right of promotion and confirmation to the rank of Sub-Inspector and further from all necessary completion of period towards enlistment in list 'F are illegal, unlawful, without lawful authority, of no legal effect and also against the law, rules and regulations governing the subject matter.
- B. Because, the appellant has been discriminated as the other colleagues and even junior then the appellant were given promotion and confirmation to the rank of Sub-Inspector, but the appellant has been deprived for no any good reason and justification.
- C. Because, under Examination Rules, 1950, the eligibility for promotion has been settled and the competent authority has the discretion to relax

some condition which were extended to the other colleagues of the appellant.

- D. Because, the respondents are bound down under the law to hold DPC twice a year, but in the case in hand, no DPC held since the year, 2019 which badly affected the appellant along with other colleagues who all are due for promotions and confirmations which is no fault of individual rather it is/was the responsibility of the department.
- E. Because, the appellant earned good name amongst other colleagues which is evident from the unblemished service record of the appellant and there is/was no any inquiry or complaint whatsoever pending or decided against the appellant hence the non holding of DPC and further depriving the appellant from promotion and other service benefits is nothing, but just to harass and humiliate the appellant from his due right of promotion.
- Because, if this time too, the appellant has not been promoted/confirmed as Sub-Inspector and subsequently not placed in list 'F', then the appellant will suffer with irreparable losses which will not be count in shape of coins for the reason as the other colleagues of the appellant getting handsome service benefits also towards pension, but the appellant likely to be retire as ASI's which is unjust and unfair and discrimination.
- G. That any other ground which has not been mentioned may also be permitted to rise at the time of hearing.

It is, therefore, most humbly prayed that on acceptance of the instant appeal,



- i. Declare the act commission and omission of respondents of non holding DPC in respect of appellant as illegal, unlawful and direct the respondents to promote and confirm the appellant as Sub-Inspector from his due date by way of holding special DPC with all back benefits.
- ii. Respondents further be directed to comply/implement with the letter dated 05-03-2019 pertains to the seniority of the appellant and extend benefits the same to the appellant with his batch mates/colleagues with all back benefits.
- iii. Direct the respondents to place the name of appellant in List "F" being qualified and if there are some deficiencies, the same may kindly be exempt and relax including the required period which is no fault of the appellant.
- iv. In alternate conditional order may graciously be pass for enlisting the appellant in List "F" and further posted him to enable to complete/fulfill the requirements of List "F" towards further promotion as Inspector with all ancillary benefits.

Any other remedy which has not been specifically asked for and is fit in the circumstance may also be allowed in favor of appellant against the respondents. Appellant




