

**SERVICE APPEAL UNDER SECTION 4 OF THE NWFP
SERVICE TRIBUNAL ACT 1974 FOR THE PROMOTION OF
THE APPELLANT WITH ALL BACK BENEFITS.**

Respectfully Sheweth.

1. That the appellant is the permanent resident of Mohallah Moosa Khail village Adina Tehsil Razar District Swabi and belong to a respectable family.
2. That the appellant was appointed as Laboratory Attendant on 21-02-2004 in the department of respondents and is presently serving as Lab Attendant in Government Girls Primary School (GGPS) Adina (Copies of the service certificates, metric to MA certificates, computer skill certificates and typing skill certificates are attached as Annexure A to K respectively).
3. That the appellant served in the office of respondents to the entire satisfaction of his superiors throughout his career and no complaint whatsoever has been filed by any one.
4. That in order to promote and implement 33 % quota of different categories of class IV i-e Naibqasid, Chowkidar, Sweeper and Lab Attendant to Junior Clerk, the respondent No. 3 issued a seniority list wherein the appellant was enlisted at serial No 135 whereas the appellant has passed MA, BA, PTC, CT, B.ED, Med and has passed computer skill etc and participated other courses while the junior employs who were illiterate or have not passed metric examination or passed metric but in 3rd Division were enlisted as senior from the petitioner, in fact the petitioner is senior amongst all the Class IV and was in the promotion zone to the post of Junior Clerk (BPS-07) Copy of the final seniority list is attached as Annexure "L".
5. That on 09-03-2023. A meeting of Departmental Selection Committee (DSC) regarding the appointment of Junior Clerk was held, the minutes of the said meeting shows that the name of the

appellant has been deleted and not included in the list of recommended candidates by the Departmental Selection Committee (DSC) on the pretext that the selected class-IV has passed the examination. It is proper to note that there is no test provided in the rules and regulations.

6. That on 10-03-2023 the respondent No.3 issued a promotion order of six class-IV employs wherein the respondents No. 4 to 9 who were junior to the appellant were promoted and senior class-IV have been dropped including the appellant. Copy of the promotion order is attached as Annexure "M".
7. That the total vacant posts were 10 in numbers, the appellant was not considered, despite the fact that the seniority of the appellant suggest that the appellant be appointed as Junior Clark.
8. That the appellant time and again requested the respondent No.2 and 3 to appoint the appellant on the said vacant post as the appellant was senior not only from the promoted candidates but also from the candidates who were shown as senior in the final seniority list issued by the respondents, but they have not considered the same. The appellant had filed a departmental appeal to the respondent No.2 which was not considered. Copy of the appeal is attached as Annexure "N".
9. That the appellant having no other efficacious remedy but to constrained the doors of this Hon'ble tribunal on the following amongst other grounds:-

GROUND:

- a. That the conduct of respondents is violative of the provisions of the constitution of the Islamic Republic of Pakistan, 1973, including Article. 4 of the constitution which mandates that every citizen is to be treated in accordance with law. This being

the case, the petitioner is entitled to be declared as selected for the post of Junior Clark.

- b. That the act of the respondents is against the law and the provisions of law have not been properly interpreted.
- c. That the action of the respondents is arbitrary, Mechanical and without application of mind to the facts and circumstances of the case hence need the interference of this august court.
- d. That the action/not considering the appellant's name by the respondents is the outcome of hast and as tainted with malice and the element of malafide reflects, there in which begs attention of this august court so that injustice could be brought to an end.
- e. The treatment matted out to the petitioner is discriminating and as an utter of the constitution and the respondents can't quote any law which permit them to treat the petitioner differently.
- f. That if any grounds are available to the petitioner, which will be argued during the arguments of the case, with the permission of this august Court.

It is, requested that, on acceptance of this appeal an appropriate order may kindly be issued declaring;

- a) The final seniority list of class-IV as illegal, incorrect and inoperative upon the rights of the appellant.
- b) The official respondents are directed to appoint the appellant as Junior Clark.

5

Interim Relief :-

It is further prayed that till the final disposal of this appeal, respondents No 1 to 3 be directed to suspend the operation of impugned order Dated 10-03-2023 and the said respondents may be directed to keep one post as vacant, as four posts are still vacant.

Respectfully Sheweth.

1. That the appellant is the permanent resident of Mohallah Dawat Khail village Adina Tehsil Razar District Swabi and belong to a respectable family.
2. That the appellant was appointed as Labortary Attendant on 21-02-2004 in your esteemed department and is presently serving as Lab Attendant in Government Girls Higher Secondary School (GGHSS) Adina.
3. That the appellant served in your esteemed department to the entire satisfaction of his superiors throughout his career and no complaint whatsoever has been filed by any one. Copy of the certificate of appreciation is attached.
4. That in order to promote and implement 33 % quota of different categories of class IV i-e Naib qasid, Chowkidar, Sweeper and Lab Attendant to Junior Clerk, your esteemed department issued a seniority list wherein the appellant was enlisted at serial No 135 whereas the appellant has passed MA, BA, PTC, CT, B.ED, M.Ed and has passed computer skill etc and participated other courses while the junior employs who were illiterate or have not passed metric examination or passed metric but in 3rd Division were enlisted as senior from the appellant, in fact the appellant is senior amongst all the Class IV and was in the promotion zone to the post of Junior Clerk (BPS-07) Copy of the final seniority list is attached.
5. That on 09-03-2023. A meeting of Departmental Selection Committee (DSC) regarding the appointment of Junior Clerk was held, and according to the outcome of the said meeting, the name of the appellant has been deleted and not included in the list of recommended candidates by the Departmental Selection Committee (DSC) on the pretext that the selected class-IV has passed the examination. It is proper to note that there is no test provided in the rules and regulations.
6. That on 10-03-2023 your esteemed department issued a promotion order of six class-IV employs wherein the candidates who were junior in service length to the appellant were promoted and senior class-IV have been dropped including the appellant. Copy of the promotion order is attached.
7. That the total vacant posts were 10 in numbers, the appellant was not considered, despite the fact that the seniority of the appellant suggest that the appellant be appointed as Junior Clerk.

8. That the appellant time and again requested the DEO (Female) Swabi to appoint the appellant on the said vacant post as the appellant is senior not only from the promoted candidates but also from the candidates who were shown as senior in the final seniority list issued by the DEO (Female) Swabi but they have not considered the same. That the appellant having no other efficacious remedy but to constrained the doors of your goof office on the following amongst other grounds:-

GRUNDS:

- a. That the act of the DEO (Female) Swabi is against the law and facts and the provisions of law have not been properly interpreted, this being the case, the appellant is entitled to be declared as selected for the post of Junior Clark.
- b. That the action of the DEO (Female) Swabi is arbitrary, Mechanical and without application of mind to the facts and circumstances of the case hence need the interference of your goof office.
- c. The treatment matted out to the appellant is discriminating and as an utter of the constitution and the DEO (Female) Swabi can't quote any law which permits them to treat the appellant differently.



It is, requested that, on acceptance of this appeal an order may kindly be issued declaring;

- a) The final seniority list of class-IV issued by DEO Swabi (F) as illegal, incorrect and inoperative upon the rights of the appellant.
- b) The DEO (Female) Swabi is directed to appoint the appellant on the post of Junior Clark.


