

SAID RULE I.E 17(4) AND NON UNIFORMITY IN SENIORITY LIST OF FOREST GUARD OF THE DIFFERENT FOREST DIVISION OF THE PROVINCE IS AGAINST THE LAW AND FACTS AND LIABLE TO BE REVISED AND TO BE PREPARED A FRESH IN ACCORDANCE WITH RULE AND LAW ACCORDINGLY.

PRAYERS:

ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL THE IMPUGNED SENIORITY LIST ORDER DATED 23.05.2023 AND 19.06.2023 OF FOREST GUARD IN RESPECT OF ORAKZAI FOREST DIVISION HANGU MAY KINDLY BE SETASIDE AND THE SENIORITY LIST DATED 23.05.2023 MAY KINDLY BE REVISED ACCORDING TO THE RULE 17 (4) OF THE KP CIVIL SERVANT APPOINTMENT, PROMOTION & TRANSFER RULES 1989 IN UNIFORMITY WITH OTHER FOREST DIVISION OF KPK ANY OTHER RELIEF WITH THIS HON'BLE TRIBUNAL DEEM FIT AN APPROPRIATE MAY ALSO BE GRANTED TO THE APPELLANT IN THE BEST INTEREST OF JUSTICE.

RESPECTFULLY SHEWETH,

The appellant submits as under:-

1. That the appellant is appointed as forest guard 03.11.2016 in Orakzai Forest Division. (Copy of appointment order is attached as Annexure "A").
2. That after appointment the appellant perform his official duty with zeal, devotion and excellent track record and no complaint against the appellant.
3. That respondent no. 3 chief conservator of forest Kohat circle forest Peshawar issued a seniority

position in letter dated 15.12.2022 wherein the appellant at serial no. 1 and the private respondent's no. 5 to 10 were junior to the appellant. (Copy of letter 15.12.2022 is attached as annexure "B").

4. That the respondent department issued final seniority list in 2020 in which the appellant is at serial no. 15 while private respondent no. 5 at serial no. 23, respondent no. 6 at serial no. 19 respondent no. 1 at serial no. 24 respondent no. 8 at serial no. 16 respondent no. 9 serial no. 26 and respondent no. 10 at serial no. 18. (Copy of Seniority list 2020 is Annexure "C").
5. That the respondent no. 4 issued a seniority list of forest guard dated 23.05.2023 according to the initial recruitment / appointment list rather than rule 17 (4) of Kpk civil servant appointment, promotion & transfer rules 1989. (Copy of Seniority dated 23.05.2023 list of forest guard is attached as Annexure "D")
6. That appellant feeling aggrieved from the impugned seniority list of forest guard Orakzai division Hangu dated 31.05.2023 assailed the impugned list through file departmental appeal, which was turned down dated 19.06.2023 communicated to the appellant on 12.07.2023. (Copy of Departmental Appeal & Rejection order are attached as Annexure "E & F")
7. That it is pertinent to mention here that seniority list of forest guard of different forest division of the province were prepared according to the Rule 17 (4) of the KP Civil Servant appointment, promotion and transfer rules 1989 which clearly shows that non uniformity while preparing the seniority list of

forest guard in the province. (Copy of Seniority list of forest guard Dirr Kohistan Forest division forest guard list are attached as Annexure "G")

8. That feeling aggrieved from the order of appellate forum and this service appeal has been filed inter-alia on the following strength grounds amongst others.

**GROUND:-**

- A. That the seniority list dated: 23.05.2023 of the forest guard in respect of Orakzai Forest Division Hangu is illegal, unlawful, arbitrary hence liable to be set aside.
- B. That the seniority list forest guard in respect of the Orakzai Forest Division Hangu is perverse against the principle of natural justice and guaranteed rights of the appellant hence, liable to be revised.
- C. That it is astonishing that all forest division in the province prepares seniority list of forest guard according to the rule 17 (4) of KPK Civil Servant appointment promotion and Transfer Rules 1989 and respondent no. 4 prepare according to his own whims and wishes which is illegal and non-uniformity for preparing a seniority list of the forest guard in the province.
- D. That the impugned seniority list of forest guard in respect of Orakzai forest division Hangu is against the law, rules, policy on the subject hence, not tenable in the eyes of law.
- E. That any other legal and factual points shall be agitated at the time of arguments with the prior permission of this Hon'ble Tribunal.

*It is, therefore, most humbly prayed that on acceptance of the instant service appeal the impugned seniority list order dated 23.05.2023 and 19.06.2023 of forest guard in respect of Orakzai Forest Division Hangu may kindly be set aside and the seniority list dated 23.05.2023 may kindly be revised according to the rule 17 (4) of the KP civil servant appointment, promotion & transfer rules 1989 in uniformity with other forest division of kpk.*

*Any other relief with this Hon'ble tribunal deem fit an appropriate may also be granted to the appellant in the best interest of justice.*






