## **Respectfully Sheweth:**

## **Preliminary Objections:**

- i. That the appellant has got no cause of action/locus standi.
- ii. That the appellant has not come to this honorable court with clean hands.
- iii. That the instant appeal is based upon, malicious/vexatious, frivolous grounds.
- iv. That the appellant is estopped by his own conduct to file the instant appeal.
- v. That the instant appeal is against the relevant rules/policy.
- vi. That the instant appeal is bad for mis-joinder and non-joinder of the necessary parties.
- vii. That the instant appeal is badly time barred.
- viii. That the instant appeal is not maintainable in its present form.

#### **ON FACTS:**

- 1. Pertain to record.
- 2. Correct up to the extent that the appellant has been appointed after following the process of selection issued/established by the Government. Moreover, the final seniority list was properly issued on dated 01-03-2021. (Annex-A)
- 3. Pertain to record.

- 4. Incorrect, the respondent Village Secretaries were promoted on the final seniority list already prepared and circulated vide office order AD/LG&RDD/NSR/2021/849 dated 01-03-2021 (Annex-A). Moreover, the Departmental Promotion Committee meeting was held and minutes drafted and circulated thereof, it is further added that no concealment of the final seniority list was made.
- 5. The appellant had submitted an appeal regarding the cancellation of the promotion order, but the same was disposed of being not based on fact/genuine, because the whole process of promotion was carried out in a very transparent manner, after the fulfillment of all codel formalities. (**Order Annex-B**)
- 6. Incorrect, the seniority list was prepared/chalked out according to the prescribed rules and regulation, which was initially tentatively prepared and displayed for objections within 15 days given time and then it was converted into final list after including the suggestions and objections, raised by the concerned Village Secretaries.

#### **ON GROUNDS:**

- A. Incorrect, The final seniority list was prepared according to the established rules and regulation in a very transparent manner, if the appellant was aggrieved of regarding the seniority list he would have objected during the 15 days period, when the tentative seniority list was displayed, the appellant failed to raise any objection on the displayed seniority list during the 15 days' time.
- B. The seniority list was prepared strictly in accordance with the ESTA Code instructions.
- C. Incorrect, all the procedure during the preparation of seniority list and later on promotion process of the respondent were carried out in a very transparent manner and strictly in accordance with the rules prescribed in ESTA Code, no illegal/unlawful act/step has been taken during the above process.
- D. Explained as above in Para B&C.
- E. The merit list was properly prepared after following the laid down procedure and fulfillment of all codel formalities.
- F. As replied above.
- G. As replied above.
- H. All the process of final seniority list preparation and promotion was carried out transparently and in accordance with the law and neither any malafide intention were involved nor the appellant kept in dark regarding the subject matter.

I the respondents seek leave to raise additional grounds during the hearing.

It is humbly prayed that the appeal of the appellant may be dismissed being baseless and not based on fact/not genuine.


