JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS No: 1 to 3.

The Respondents No. 1-3 submit as under:

PRELIMINARY OBJECTIONS.

- 1 ***That*** the appeal in hand is based on mala fide intentions for illegal service benefits to the extent of his adjustment against the DDEO/Deputy Director (MC/BS-18) post in violation of Section-8 of Civil Servant, Act-1973 read with Service Rules notified vide Notification No. (SM) E&SED/3-2/2016/SSRC of MC dated 02-07-2018.
(Copy of Notification/Service Rules dated 27-03-2019 is Annx-A)
- 2 ***That*** the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan 1973 read with section-4 of Khyber Pakhtunkhwa service Tribunal Act-1974.
- 3 ***That*** the Appellant is not entitled for the relief he has sought from this Honorable Court as he is falling at S.No. 54 in the final seniority list of the SDEOs/ADs (Male/MC) in BPS-17 notified on 10-10-2022, meaning thereby, there are 53 SDEOs/ADs are senior to appellant which have legal rights to be promoted to the post of DDEOs/Deputy Directors (BS-18). Moreover, SDEOs/ADs form S.No. 1 to 53 who will suffer irreparable loss, have not been made respondents of the instant appeal which was in clear violation of law & rules as no one can be condemned un-heard under the law of land.
(Copy of the Final Seniority List dated 10-10-2022 is Annx-B)
- 4 ***That*** the lien allowed vide Notification dated 04-03-2021 has already been expired & no further extension has been given to the appellant by the Department. If the appellant is so interested for working against the MC post, he was required to have joined his original post of SDEOs/ADs in BPS-17 during his lien period, however, he miserably failed to do so.

- 5 **That** currently the Respondent Department has advertised the 08 vacant posts DDEO/Deputy Director (MC/BS-18) through KPPSC vide advertisement No. 04/2023(S.No.1) the under 20% reserved quota for open market, whereas, the remaining posts for the said cadre are reserved for Departmental Promotions under 80% reserved quota, where against the appellant is not entitled to be adjusted in view of his low seniority position i.e. falling at S.No.54. (Copy of the advertisement No. 04/2023 is Annx-C).
- 6 **That** the appellant is taking shelter of those Notifications of the Respondent No. 2 which were made on purely on stop gape arrangements till the arrival of the incumbent of the post.
- 7 **That** the appellant is liable to serve the Department against the principal/vice principal post (BS-18/TC) in view of his inter se seniority No. 34 notified by the KPPSC in response to the adv No. 03/2018(S.No. 22).

ON FACTS.

- 1 **That** Para-1 pertains to the service record of the appellant which is not disputed as per prayer of the appellant in the titled appeal. Furthermore, pursuant to the National Education Policy, 2009 the Provincial Government of KP introduced Management Cadre in E&SE Department through KPPSC, where against, the appellant also applied for appointment as ASDEO (BS-16/MC) & consequently, he was recommended & appointed against the noted post vide Notification dated 05-05-2011 along with his adjustment in circle Pubbi Nowshera.
- 2 **That** Para-2 is correct to the extent of the promotion of the appellant vide order dated 26-09-2018 from ASDEO (BS-16) to SDEO/AD (BS-17) MC along with his adjustment against the SDEO (M) Pubbi Nowshera by the competent authority.
- 3 **That** Para-3 is also correct that on dated 09-02-2018 the Respondent Department through the KPPSC invited applications from the eligible candidates for the appointment against the 204 vacant posts of Principal/Vice Principal (BS-18/TC) through advertisement No. 03/2018 wherein the appellant also applied & was recommended against the Vice Principal post by retaining lien against his original post of SDEO (BS-17/MC) along with the seniority upon joining the Vice Principal post in the Department.
- 4 **That** Para-4 is correct that vide Notification dated 05-05-2020 the appellant was appointed against the post Principal/Vice Principal (BS-18) in Teaching Cadre in the Respondent Department.
- 5 **That** Para-5 is correct that in view of the Notification dated 05-05-2020, the appellant was relieved from the post of SDEO (BS-17/MC) for

taking over charge of duty as Principal/Vice Principal (BS-18/TC) by retaining the lien against his original post of SDEO (BS-17/MC) for initial period two year vide Notification dated 04-03-2021.

- 6 **That** Para-6 is incorrect as no application has been filed by the appellant for the extension of lien against the SDEO (BS-17/MC) post, as a result thereof, the already sanctioned period of lien against the SDEO post has been expired, hence, the plea of the appellant is illegal & liable to be rejected.
- 7 **That** Para-7 is also incorrect & denied on the grounds that the lien of the appellant has already been expired and now he is legally bound to utilize his expertise and professional experiences in uplifting the standard of education being a Principal (BS-18/TC) not DDEOs/Deputy Directors (BS-18/MC). Furthermore, it is the right of senior most SDEOs/Assistant Directors of Management Cadre to be promoted to the post of DDEOs/Deputy Directors (BS-18/MC) not the appellant. The appellant, being a Teaching Cadre officer/Principal (BS-18), is not entitled to be adjusted as DDEOs/Deputy Directors (BS-18) MC post on the basis of merely qualification and experience.
- 8 **That** Para-8 is also incorrect & mis-leading on the material grounds that the appellant is falling at Seniority No. 54 of the SDEOs (M) BS-17/MC when he got appointed as Principal (BS-18) in Teaching Cadre and retained lien against the SDEO (BS-17/MC) post, meaning thereby, currently, 53 SDEOs/ADs are senior to appellant which have legal rights to be promoted to the post of DDEOs/Deputy Directors (BS-18) in pursuance of Section-8 of Civil Servant, Act-1973 read with Service Rules notified vide Notification No. (SM) E&SED/3-2/2016/SSRC of MC dated 02-07-2018. If the plea of the appellant is accepted then the senior most SDEOs/Ads, falling at S.No. 1 to S.No. 53 of the seniority list will suffer irreparable loss which will be violation of their basic rights guaranteed by the constitution of Islamic Republic of Pakistan, 1973 and this would open a floodgate for the other similarly placed officers of different cadres to join MC post which will be violation of the Service Rules of Management Cadre notified vide Notification No. (SM) E&SED/3-2/2016/SSRC of MC dated 02-07-2018.

It is further added that currently the Respondent Department has advertised the 08 vacant posts of DDEO/Deputy Director (MC/BS-18) through KPPSC vide advertisement No. 04/2023(S.No.1) under 20% reserved quota for open market, whereas, the remaining posts for the said cadre are reserved for Departmental Promotions under 80% reserved quota, where against the appellant is not entitled to be adjusted in view of his low seniority position i.e. falling at S.No.54 in the SDEOs/Assistant Directors (BS-17/MC) notified on dated 10-10-2022 by the Respondent Department.

9 That Para-9 is also incorrect as the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan 1973 read with section-4 of Khyber Pakhtunkhwa service Tribunal Act-1974, hence, the titled appeal is liable to be rejected on the following grounds inter alia: -

ON GROUNDS.

- A. **Incorrect & not admitted**, the plea of the appellant is illegal on the grounds that the lien of the appellant has already been expired on 05-05-2022 with no extension by the competent authority therein till date, hence, the appellant has no legal right to claim his presence against the SDEO post already extinguished by the appellant, hence, he can not be adjusted as DDEO/Deputy Director (MC/BS-18) in view of the above made submissions by the Department
- B. **Incorrect & not admitted**. The act of the Department with regard to the non-adjustment of the appellant as DDEO/Deputy Director (MC/BS-18) is legal & even in compliance of the provisions of Articles 4 & 25 of the constitution of 1973 because he can not be adjusted & promoted against the legal & constitutional rights of the SDEOs/Assistant Directors falling from S.No. 1 to 53, whom the appellant has not made them Respondents in clear violation of law & rules as no one can be condemned un-heard under the law of land.
- C. **Incorrect & not admitted**. The cited service rule of Management Cadre dated 03-07-2018 are not applicable upon the case of the appellant of being framed for management cadre only.
- D. **Incorrect & not admitted**, the plea of the appellant is against the facts and policy under reference, hence, denied in view of the above made submissions by the Department.
- E. **Incorrect & not admitted**, the plea of the appellant is against the facts and policy under reference, *furthermore, the stand of the appellant regarding the adjustment of the officers of TC in BS-18 against the DDEO (M) BS-18 MC is illegal as perusal of the Notifications dated 31-08-2022, 18-08-2022 would show that the adjustment orders have been passed as staff gape arrangement, till the arrival of the regular incumbent i.e an officer of MC in BS-18 instead of an officer like the appellant TC in BS-18* hence, denied in view of the above made submissions by the Department.
- F: **Incorrect & not admitted**. The cited appeal No. 1444/2019 titled Mohib Ur Rehman Vs Govt decided on 03-09-2021 by the Honorable Service Tribunal is at variance with the titled appeal on the grounds that the


contention of the appellant was to place them in the bottom of the DDEO/Deputy Director (BS-18/MC) Management Cadre with a valid lien as against the appellant in terms of FR-14 (A). Furthermore, all the badge mates/colleagues of Mohib Ur Rehman had already been promoted to the post of the DDEO/Deputy Director, whereas, the appellant in the present appeal is junior to 53 SDEOs/Assistant Directors, hence, plea of the appellant is against the legal provision of law & rules, deserves to be rejected.

- G. Incorrect & not admitted, the act of the Department by not adjusting the appellant as DDEO BS-18 MC is legal & liable to be maintained.
- H. Incorrect & not admitted, the act of the Department by not adjusting the appellant as DDEO BS-18 MC is legal & liable to be maintained
- I. Incorrect & not admitted the act of the Department by not adjusting the appellant as DDEO BS-18 MC is legal & liable to be maintained on the grounds of being in accordance with the provision of Article-21-A of the General clauses Act-1897 as amended in 1956.
- J. Incorrect & not admitted the appellant has no valid case of action to file the titled appeal before this Learned Tribunal. Therefore, the Respondents No. 1-3 also seek leave of this Honorable Tribunal to submit additional record grounds and case law on the date fixed

PAYERS:

Therefore, in view of the above made submissions, the appeal in hand may kindly be rejected in favor of the Department in the interest of justice.
