## PARAWISE REPLY BY RESPONDENTS 1 & 2.

RESPECTFULLY SHEWETH.

#### **PRELIMINARY OBJECTIONS:-**

1. That the appeal is badly barred by law & limitation.

2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.

3. That the appellant has no cause of action and locus stand to file the instant appeal.

4. That the appellant has not come to this Honorable Tribunal with clean hands.

5. That the appellant is estopped due to his own conduct to file the instant Service Appeal.

6. That the appellant is trying to conceal the material facts from this Honorable Tribunal.

#### FACTS:-

- 1. Para No.1 Pertain to the appellant record needs no comments.
- 2. Pertain to record.
- Ocrrect to the extent that the appellant while posted for emergency duties at District Swat deserted/absented himself from lawful duties with effect from 03.06.2008 till the date of his removal from service i.e 21.10.2008 for total period of 04 months and 18 days, without any leave or prior permission of the competent authority.
- 4. Incorrect, the appellant was deserted from his official duty by showing extreme cowardice act and intentionally remained absent from lawful duties with effect from 03.06.2008 till the date of his removal from service i.e 21.10.2008, without prior permission or leave, while his other colleagues bravely faced with every odd and paid their assigned duties in letter with spirit for maintaining the law and order situation in the area.
- 5. Incorrect, on the allegations of willful absence he was served with Charge Sheet alongwith Statement of Allegations and Mr. Tahir Khan the then RI was nominated as Enquiry Officer to conduct departmental enquiry against him and after fulfillment of codal formalities he was removed from service.

- Moreover, the appellant was well known about his removal from service and it is evident from Charge Sheet and Show Cause Notice as well.
- 6. Correct, to the extent that departmental appeal submitted by the appellant was thoroughly examined and rejected on sound grounds.
- 7. Incorrect, that a copy of rejection order has already been indorsed to the appellant on his home address vide Endst: No. 5483-84/EC, dated 23.07.2010. (Copy attached as annexure "A").
- 8. Incorrect: That all deserters' officials of Police Force, including the appellant who deserted from their duties by showing extreme cowardice were proceeded against departmentally and finally all of them had been removed from service after adopting all codal formalities. Later on in the light of directions of the high ups the all ex-officials concerned to Malakand Range including the appellant were called for joining their duties. Thus those Exofficials who came back within stipulated period were reinstated in service. But the appellant did not turn up and disappeared for a long period about more than 16 years, which he deliberately failed to avail the opportunity of reinstatement in service.
- 9. Incorrect, the cases mentioned by the appellant in the Para are not at par with the case of the appellant. It is pertinent to mention here that every case has got its own and peculiar facts and merits. Therefore, anticipating similar result in case with diverse facts would amount to miscarriage of justice as the entire building cannot be tarred with one and the same brush.

#### **GROUNDS:-**

- 1. Pertain to the appellant record. However the appellant while posted for emergency duty at Swat remained absent from his lawful duty without prior permission or valid leave.
- 2. Incorrect. The Police Force is legally obligated to perform the duty in all situation for maintaining of law & order situation in the area, while the appellant deserted/absented himself from his assigned duty by showing extreme cowardice act and intentionally remained absented himself from lawful duties with effect from 03.06.2008 till the date of his removal from service i.e 21.10.2008 for total period of 04 months and 18 days, without any leave or prior permission of the competent authority. Moreover, the appellant was being a member of Police Force instead to protect life, property and liberty of citizen absconded himself from his assigned duty.
- Incorrect. As explained in the preceding Paras of facts that all ex-officials concerned to Malakand Range including the appellant were called for joining their duties. Thus those Ex-officials who came back within stipulated period were reinstated in service. But the appellant deliberately failed to avail the opportunity of reinstatement in service.

- Incorrect. As the appellant was remained absent from duty for a long period of 04 months and 18 days and after adopting the laid down procedure as per law, he was removed from service.
- Incorrect. As the appellant was willfully remained absent from his lawful duty without any leave or prior permission of the competent authority. The willful absence from duties and that too at a critical time was absolutely unwarranted and contrary to police Rules 1934 read with Police disciplinary Rules 1975 amended in 2014. Moreover, the eligible/entitled Ex-officials who were come back in the earliest were reinstated into service by the respondents and Honorable Tribunal on merit basis. After lapse of more than 15 years the appellant is not deserved/entitled for reinstatement in service.
  - Incorrect. The appellant was remained absented himself from lawful duties without prior permission of the competent authority. In this regard proper departmental enquiry was initiated against him as he was issued Charge Sheet alongwith Summary of Allegations and Muhammad Tahir Khan the then RI was nominated as Enquiry Officer to conduct proper enquiry against him. The Charge Sheet was served upon his brother namely Muhammad Alam S/o Mumtaz, through special messenger on his home address, but he failed to submit his reply before the Enquiry Officer. (Copy of charge sheet attached herewith as annexure "B"). After completion of enquiry the Enquiry Officer submitted his findings, wherein the appellant was found guilty of the charges leveled against him and recommended for ex-pate action. (Copy of enquiry report attached herewith as annexure "C"). Upon the findings of Enquiry Officer, he was issued Final Show Cause Notice and served upon his father namely Mumtaz through special messenger and his signature was obtained as token of its receipt, but the appellant deliberately failed to submit his reply. (Copy of Show Cause Notice attached herewith as annexure "D"). Thus after fulfillment of all codal formalities required the appellant was awarded major punishment of removal from service as per law/rules.

## **PRAYERS:-**

It is therefore, most humbly prayed that in the light of aforesaid facts/submission the instant service appeal may kindly be dismissed with cost.

#### SUMMARY OF ALLEGATIONS
