### Reply on behalf of Respondent No.1 & 2 in compliance with order sheet dated 11.5.2023 of Service Tribunal Khyber Pakhtunkhwa

The arguments in case of Appeal No.907/2022 against respondents is pending before Hon'ble Tribunal which is fixed for 31.07.2023.

During the year 2015, the total sanctioned strength of posts of Assistant Food Controllers (B-11) was 49 (Forty-Nine Posts) in Food Department Khyber Pakhtunkhwa, out of which 12 (Twelve) posts fall in the share of 25% initial recruitment quota and 37 posts comes in share of 75% promotion quota as per ratio fixed in the Service Rules of Food Department Khyber Pakhtunkhwa (Annex-I)

Due to deficiency of prescribed length of service of (07) seven Assistant Food Controllers, who were appointed to the post of District Food Controllers / Storage & Enforcement Officers / Rationing Controller Peshawar on acting charge basis, vide Food Directorate Office Order No. 4085/G-275-DPC-2013 dated 26-04-2013 (Annex-II) resultantly (07) seven Foodgrain Inspectors were also promoted as Assistant Food Controllers on acting charge basis vide Food Directorate Office Order No. 4911/G-275-DPC dated 31-05-2013 (Annex-III).

It is settled principle of law as laid down, in the Appointment, Promotion and Transfer Rules 1989 that acting charge appointment does not as appointment by promotion on regular basis for any purpose including seniority and also does not confer any vested right for regular promotion to the post held on acting charge basis (Annex-IV).

During the year 2014-15, the clear vacant posts of Assistant Food Controllers (B-11), the detailed break-up of the posts of Assistant Food Controller (BS-11) placed vide (Annex-V), therefore, on clear availability of above posts of AFC reserved against 75% quota for regular promotion, the case was placed before the Departmental



Promotion Committee of Food Department Khyber Pakhtunkhwa in its meeting held on 22.04.2016, the appellant with other eligible Foodgrain Inspectors were recommended by the DPC and accordingly promoted to the post of Assistant Food Controller on regular basis by an office order No.2288-A/G-275-DPC dated 22.04.2016 (Annex-VI)

As the eligibility for promotion of the appellants before the appointment of the private respondents recruited through initial recruitment is concerned, it is clarified that during the year 2013, 10 (Ten) clear vacant posts reserved against 25% quota for initial recruitment were advertised through Khyber Pakhtunkhwa Public Service Commission (Annex-VII). In response of above, the Director Recruitment Khyber Pakhtunkhwa Public Service Commission vide letter No.081965 dated 04.06.2015 (Annex-VIII), sent recommendation of (Ten) 10 Assistant Food Controllers (B-11) for appointments. After due process, the recommendees of the Khyber Pakhtunkhwa Public Service Commission were accordingly appointed as Assistant Food Controller (B-11) on 07.08.2015 against 25% quota in share of initial recruitment vide office order No.3936/AC-240-PSC-AFC-2015 dated 07-08-2015 (Annex-IX), so the private respondents were appointed through Khyber Pakhtunkhwa Public Service Commission 07-08-2015 i.e. well before the regular promotion of the appellant.

(1) Where the appointing authority considered it to be in the public interest to fill a post reserved under the rules for departmental promotion and the most senior civil servant belonging to the cadre or service concerned, who is otherwise eligible for promotion, does not possess the specified length of service the authority may appoint him to that post on acting charge basis;

<sup>37</sup>Provided that no such appointment shall be made, if the prescribed length of service is short by more than <sup>38</sup>[three years].

- (2) So long as a civil servant holds the acting charge appointment, a civil servant junior to him shall not be considered for regular promotion but may be appointed on acting charge basis to a higher post.
- (3) In the case of a post in Basic Pay Scale 17 and above, reserved under the rules to be filled in by initial recruitment, where the appointing authority is satisfied that no suitable officer drawing pay in the basic scale in which the post exists is available in that category to fill the post and it is expedient to fill the post, it may appoint to that post on acting charge basis the most senior officer otherwise eligible for promotion in the organization, cadre or service, as the case may be, in excess of the promotion quota.
- (4) Acting charge appointment shall be made against posts which are likely to fall vacant for period of six months or more. Against vacancies occurring for less than six months, current charge appointment may be made according to the orders issued from time to time.
- (5) Appointment on acting charge basis shall be made on the recommendations of the Departmental Promotion Committee or the Provincial Selection Board, as the case may be.
- (6) Acting charge appointment shall not confer any vested right for regular promotion to the post held on acting charge basis.






