#### Respectfully Sheweth,

#### **Preliminary Objections:**

- 1. That the appellant has got no cause of action/locus standi to file the instant appeal.
- 2. That the Honorable Tribunal has no jurisdiction to entertain the instant appeal having factual controversy.
- 3. That the appellant has not come to this Tribunal with clean hands.
- 4. That the appellant has concealed material facts from the Honorable Tribunal.
- 5. That the conduct of the appellant estopped himself to bring the instant appeal.
- 6. That the service appeal of the appellant is badly time barred.

#### RESPECTFULLY SHEWETH

- 1. Pertains to record.
- 2. Incorrect, in the year 2014 the appellant was on duty in Govt. Higher Secondary School Ghallanai District Mohmand, the appellant was arrested by Mohmand Rifles on dated 10-11-2014. He was not suspended by competent authority, later on his suspension/ reinstatement was consider under CSR.194 and E&D rule-6, he was remained in custody/internment center. The appellant was hand over to the District Administration on 20-08-2020 for further process and released on bail on 20-11-2018. He was charged in criminal charge (BLACK) mention in their provided documents (copy attached) (Annex-A-B). The internment center of Mohmand Rifle not provided detail criminal record to District Administration. The appellant was not filed any application/complaint for trail against his criminal charges in



- the competent court, therefore appellant was not acquitted criminal (BLACK) charge on him.
- 3. Incorrect, that after release of the appellant respondent No. 02 issued a letter to respondent No. 01 for guidance copy of the letter is attached (Annex-C).
- 4. Incorrect, As his case is still pending for trail and release on bail has not been met acquitted by the trail court, however appellant was in the custody of Mohmand rifle internment center, therefore 04 years leave without pay by the respondent No. 02 being not on duty.
- 5. Incorrect. As in Para -04 the period of absence of the appellant was treated as leave without pay with the approval of competent authority. Copy of the letter is attached. (Annex .D).

#### **Grounds:**

- A. That the order 25-03-2022 is legal and lawful.
- B. That the appellant has been treated according to law, rules and constitution of Islamic Republic of Pakistan
- C. Incorrect, the appellant is not entitled of salary for a period he remained in jail.
- D. Incorrect, under rule-06 of the Khyber Pakhtunkhwa Government Service (E&D) Rules 2011, a Government Servant against whom action is proposed to be initiated may be placed on the suspension for a period of 90 days.
- E. As stated a Para-04 of the facts above.
- F. Incorrect, order dated 25-03-2022 is according to law/rules.
- G. Incorrect, the appellant was remained in the custody of Mohmand Rifles and a period of 04 years and release him on bail on strong surety bond of the local elders.
- H. All the proceedings have been carried out accordingly to law.
- I. Incorrect, hence denied.
- J. No comments. .
- K. That the respondent will also seek the permission for further additional grounds at the time of arguments.
