Respectfully Sheweth,

PRELIMINARY OBJECTIONS.

- 1. That the appellant has got no locus standi to file the instant service appeal.
- 2. That no discrimination / injustice has been done to the appellant.

3. That the instant service appeal is bad in the eye of law.

4. That the appellant has not come to this Tribunal with cleaned hands and has concealed material as well as legal facts.

5. The appeal is based on distortion of facts and is not tenable in eye of law.

6. That the appellant has been estopped by his own conduct to file the service appeal.

7. The present service appeal is based upon malicious/vexations and frivolous grounds.

8. That the service appeal is based on conjecture and surmises.

9. That the service appeal is not maintainable in its present form.

10. That the service appeal is bad for mis-joinder and non-joinder of the necessary parties.

11. That the appellant has filed the present service appeal contrary to Law and facts.

12. That Rule 9 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 clearly laid down the procedure of willful absence which is "Notwithstanding anything to the contrary contained in these rules, in case of willful absence from duty by a Government Servant for seven or more days, a notice shall be issued by the competent authority through registered acknowledgement on his home address directing him to resume duty within fifteen days of issuance of the notice. If the same is received back as undelivered or no response is received from the absentee within stipulated time, a notice shall published in at least two leading newspapers

- directing him to resume duty within fifteen days of the publication of that notice failing which an ex-parte decision shall be taken against the absentee. On expiry of the stipulated period given in the notice, major penalty of removal from service may be imposed upon such Government Servant.
- 13. That proper procedure was adopted by the competent authority while passing the removal order of the appellant.
- 14. That the appellant was unable to show any cogent reason for remaining absent from 28-10-21 till filing of her departmental appeal dated 12-05-2022 which is almost 6 months and 15 days she had been absent without any prior information/permission.
- 15. That the Competent Authority has issued a notice through registered AD vide letter No. 1(7)/Admn/2021-22/2901-05 dated 03-01-2022 by clearly explain the reason of her willful absence within 15 days from issuance of notice. Copy of the letter alongwith, registered receipt is attached as (<u>Annex-A & B</u>).
- 16. That the Competent Authority after completing the codal formalities of rule-9 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 issued a show cause notice to her in two daily newspapers (Daily Aaj & Daily Chand Swat) dated 27.01.2022 attached as (<u>Annex-C & D</u>). The appellant had not paid any heed to such notices and had not bothered to join/resume nor present herself before the authority as mentioned in notice published in two daily newspapers.
- 17. That the Competent Authority after completing all the codal formality imposed major penalty of "Removal From Services" upon the appellant. Copy of the removal order is attached as (<u>Annex-E</u>).
- 18. That Fundamental Rule 67 provided that leave could not be claimed as of right and an application for leave should not be anticipated as grant of leave. Rules, Regulations and office procedure provided that a civil servant requiring leave was supposed to apply formally for it and as a matter of principle he could not and should not absent himself from office prior to sanction of leave. Mere submitting an application for leave ipso facto could not be construed to be sanction of leave. Prospective presumption had to be



based on some legal ground. Civil Servant could leave his headquarter/ office only with prior approval of the competent Authority in order to avoid subsequent complications.

- 19. That the service appeal is time barred and warrants dismissal as the services appeal.
- 20. That the delay of each day is required to be explained by the appellant in filling of the petition beyond the limitation period. In this regard 1998 SCMR 1863 is referred.
- 21. That the appellant is required to give justifiable reasons for delay of each day. In this regard 1995 SCMR 1419 is referred.
- 22. That the appellant has neither explained nor made any attempt to explain the delay of each day. In this regard 1974 SCMR 425 & 1974 SCMR 492 are referred.

<u>ON FACTS</u>.

- 1. Para 1 of the Service Appeal pertains to record.
- 2. Para 2 of the Service Appeal is incorrect. The appellant had not served with zeal and zeal. During her service; the appellant had been frequently remained absent from official duty as evident from her service record/personal file which reveals that number of times explanations followed by subsequent warnings and even show cause notices were called from her during the time period of different DPWOs (District Population Welfare Officers). The detail are given below:
 - i. Number of explanation called 18 times,
 - ii. Number of warning issued 09 times
 - iii. Inquiries conducted 03 times.

Copy of documents/letters are attached as <u>Annex-F</u> consist of 59 pages.

The appellant was awarded minor penalty of stoppage of one annual increment for two years alongwith deduction of pay and allowances for the absent period.

3. Para 3 of the Service Appeal is incorrect. The appellant was called to explain willful absence during the period w.c.f 03-04-2021 to 30-04-2021 vide letter No 1(7)/Admn/2020-21/675-79 dated 18-05-2021 the appellant confessed her guilt not to inform the competent authority about her absence wherein she did not mentioned any ailment vis a vis Covid-19. The appellant mentioned the fact that her relative has died

in Karachi and the appellant left for Karachi in haste. (Reply of the Appellant is attached at Annex-G). A proper inquiry was conducted against the appellant and a minor penalty of stoppage of one annual increment for two years along with deduction of pay and allowances for the absent period was awarded. (Copy of Inquiry is attached as Annex-H)

- 4. Para 4 of the Service Appeal is incorrect. The incident i.e Criminal case under section 295-B PPC dated 17-08-2021 took place in the month of August 2021 wherein the appellant was called upon explanation about her absence from duty vide office letter No. 1(7)/Admn/2020-21/2131-35 dated 05-10-2021 (Annex-I). The appellant has admitted in her reply that the situation is now normal and she will perform duties regularly (copy of her reply as well as report of the inquiry officer is attached at Annex-J & K). It is important to mention here that the appellant was awarded major penalty of removal from service on the absenteeism from the month of October 2021 and onwards which is evident from the notice issued to the appellant.
- 5. Para 5 of the Service Appeal is incorrect. A proper procedure under rules-9 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 in case of willful absence has been adopted and a proper Notice through registry has been issued. The appellant was well aware of the proceedings initiated against her. After fulfilling all the formalities. Rules-9 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 a notice was issued to her home address vide letter No. 1(7)/Admn/2020-21/2701-5 dated 03-01-2022 through registered acknowledgment directing her to resume duty within (15) days of the receipt of notice. The official concerned failed to report within the stipulated period so, a notice was published in Daily "Aaj Peshawar" on 27-01-2022 and Daily "Chand Swat" on 27-01-2022 directing her to resume duty within 15-days of publication of the notice and to intimate the cause of her absence. The stipulated period expired on 10.02.2022 the official did not resume her duty. The competent authority impose major penalty of "Removal from Service" upon the official under Rule-9 of the rule ibid. The appellant is habitual absconder as per her past service history the allegation leveled against the appellant based on real

facts and been proved. The decision has been taken as a last resort after full filling all the codal formalities of law and justice under rule (9) of the rule ibid.

- 6. Para 6 of the Service Appeal is Incorrect. The Competent Authority has completed all the codal formalities mentioned in rule-9 of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011 in case of willful absence and departmental appeal before the appellate authority has been filed being time bared.
- ON GROUNDS
- I. Para-I of the Service Appeal is incorrect. The appellant has been removed from service by keeping the norms of justice, facts and record.
- II. Para-II of the Service Appeal is incorrect. The appellant is habitual and chronic case of absenteeism as evident from her previous record. Detail reply has already been given in Para No. 5 of the facts. Moreover the appellant has been dealt according to law and no discrimination has been done to the appellant. The respondents has time and again showed and taken a very lenient view on her absenteeism therefore she was given
 - i. Number of explanation called 18 times,
 - ii. Number of warning issued 09 times
 - iii. Inquiries conducted 03 times.
- III. Para-III of the Service Appeal is Incorrect. The state of Pakistan and its Federation Units knows better public interest at large and doing it as per Law. Misinterpretation without reference to the contexts will give way to one according to his wishes to articulate. Furthermore not even a single right of the appellant has been violated nor the respondents acted against the Law.
- IV. Para-IV of the Service Appeal is incorrect. Detail reply is given in Para-4 of the facts.
- V. Para-V of the Service Appeal is incorrect. No such Applications were made nor requested for transfer and as far as the punishment is concerned it is completely according to law.
- VI. Para-VI of the Service Appeal needs no comments as it is not relevant to the respondents.
- VII. Para-VII of the Service Appeal is incorrect. Detail reply is given in Para-5 of the facts.
- **VIII.** Para-VIII of the Service Appeal needs no comments. However the respondents seeks permission to raise any other ground at the time of arguments.

as deployed here in Swat; all of them were not satisfied with her which are proved from their explanations and warnings asked due her absence and low performance.


RECOMMENDATIONS:





Provided that dismissal in these cases shall be with ²[....] effect from the date of conviction by a court of law; and

(b) proceed against the Government servant under rule 5, where he has been convicted of charges other than corruption or moral turpitude.

9. <u>Procedure in case of wilful absence.</u> Notwithstanding anything to the contrary contained in these rules, in case of wilful absence from duty by a Government servant for seven or more days, a notice shall be issued by the competent authority through registered acknowledgement on his home address directing him to resume duty within fifteen days of issuance of the notice. If the same is received back as undelivered or no response is received from the absentee within stipulated time, a notice shall be published in at least two leading newspapers directing him to resume duty within tifteen days of the publication of that notice, failing which an *ex-parte* decision shall be taken against the absentee. On expiry of the stipulated period given in the notice, major penalty of removal from service may be imposed upon such Government servant.

10. <u>Procedure to be followed by competent authority where inquiry is necessary.</u> (1) If the competent authority decides that it is necessary to hold an inquiry against the accused under rule 5, it shall pass an order of inquiry in writing, which shall include-

- (a) appointment of an inquiry officer or an inquiry committee, provided that the inquiry officer or the inquiry committee, as the case may be, shall be of a rank senior to the accused and where two or more accused are proceeded against jointly, the inquiry officer or the convener of the inquiry committee shall be of a rank senior to the senior most accused;
- (b) the grounds for proceeding, clearly specifying the charges along with apporticnment of responsibility;
- (c) appointment of the departmental representative by designation; and
- (d) direction to the accused to submit written defense to the inquiry officer or the inquiry committee, as the case may be, within reasonable time which shall not be less than seven days and more than fifteen days of the date of receipt of orders.

(2) The record of the case and the list of witnesses, if any, shall be communicated to the inquiry officer or the inquiry committee, as the case may be, along with the orders of inquiry.

(3) In a case where preliminary or fact finding inquiry was conducted, and the competent authority decides to hold formal inquiry, the inquiry officer or the inquiry committee for the purpose of conducting formal inquiry shall be different from the inquiry officer or the inquiry committee which conducted the preliminary.

11. <u>Procedure to be followed by inquiry officer or inquiry committee.</u>—(1) On receipt of reply of the accused or on expiry of the stipulated period, if no reply is received from the accused, the inquiry officer or the inquiry committee, as the case may be, shall inquire into the charges and may examine such oral or documentary evidence in support of the charges or in defense of the accused as may be considered necessary and where any witness is produced by one party, the other party shall be entitled to cross-examine such witness.

(2) If the accused fails to furnish his reply within the stipulated period, the inquiry officer or the inquiry committee, as the case may be, shall proceed with the inquiry ex-parte.

(3) The inquiry officer or the inquiry committee, as the case may be, shall hear the case on day to day and no adjournment shall be given except for reasons to be recorded in writing, in which case it shall not be of more than seven days.

(4) Statements of witnesses and departmental representative(s), if possible, will be recorded in the presence of accused and vice versa.

(5) Where the inquiry officer or the inquiry committee, as the case may be, is satisfied that the accused is hampering or attempting to hamper the progress of the inquiry, he or it shall administer a warning and if, thereafter, he or it is satisfied that the accused is acting in disregard to the warning, he or it shall record a finding to that effect and proceed to complete the inquiry in such manner as may be deemed expedient in the interest of justice.

(6) If the accused absents himself from the inquiry on medical grounds, he shall be
