

The National Curriculum Council (NCC) Secretariat is steering curriculum reforms (ECE to Grade 12) with the aim of promoting quality education for all children across Pakistan. In response to a call for experts to support this consultative and comprehensive exercise, the NCC Secretariat received nominations of subject experts from multiple public, private and local non-profit organizations. We are thankful for sharing nominations from your esteemed department.

2. After successful completion of the curriculum standards for ECE-Grade 8, work on standards for Grades 9-12 has been initiated. In this regard, a series of policy-dialogues was held in sixteen different cities across Pakistan. First Inter-Provincial Curriculum Workshop (IPCW) on Standards for Grades 9-12 on November 14-17, 2022 was another milestone in this direction aimed at gathering feedback from the ground. Based on the 1st IPCW, the NCC team coordinated the development of key curricular documents for Grades 9 - 12 with the concerned subject experts.

3. <u>Second Inter Provincial Curriculum Workshop (IPCW) on Standards for</u> <u>Grade 9-12, will take place virtually on February 21-23, 2023.</u> Online meeting links for subjectwise sessions will be shared later. Participation in these sessions is on an invite-only basis. The aim of the  $2^{nd}$  IPCW is to introduce the curricular documents to regional stakeholders and experts and provide a way forward for a detailed regional review, feedback incorporation, and finalization. The guiding questions, schedule and session breakdown for the  $2^{nd}$  IPCW are attached at Annex-A.

4. Moving forward, a further series of workshops is proposed to evaluate and finalize the drafts of curricular documents for Grades 9 - 12. The concept note attached explains the overall process, gives more information on the upcoming  $2^{nd}$  UPCW with a detailed schedule and guiding questions, and outlines the timeline for the project under the Standards vertical (Annex-B).

5. The NCC Secretariat is looking forward to hosting provincial/area experts and engaging them for a productive session.

#### Overview and background

Annex

The National Curriculum Council (NCC) Secretariat is steering curriculum reforms (Early Childhood Education (ECE) to Grade 12) with the aim of promoting quality education for all children across Pakistan. In response to a call for experts to support this consultative and comprehensive exercise, the NCC Secretariat received nominations of subject experts from multiple public, private and non-profit organizations. Standards for ECE - Grade 8 have been successfully updated and notified, owing to the insight and guidance provided by numerous development and implementation experts from all provinces and areas. The NCC Secretariat is currently in the process of developing and finalizing the draft of Standards for Grades 9-12, for which NCC has engaged subject experts from across Pakistan.

#### Engagement through Curriculum Workshops

The ongoing curricular reforms have four components: 1) Standards, 2) Textbooks, 3) Teachers and 4) Assessments. Development of standards for Grades 9-12 comes under the Standards vertical. To ensure regional involvement and receive valuable feedback and direction on Standards for Grades 9-12, representation and ownership from provinces/areas, the NCC Secretariat is working with all regions through in-person and online engagements. The two types of curriculum workshops proposed by NCC for this purpose are detailed as follows:

#### Inter Provincial Curriculum Workshops (IPCWs)

- Inter Provincial Curriculum Workshops (IPCWs) are held at the Federal level, either virtually or in-person.
- Provincial/area representatives convene together and provide their input on relevant curricular content which can be related to standards, teacher and learning material, capacity building and assessment reforms.
- Representatives from provincial/area education departments, curriculum and subjects experts from the public, private and local non-profit sector may attend the IPCWs.

#### **Regional Curriculum Workshops (RCWs)**

- The NCC Secretariat recognizes that each province/region of Pakistan carries a multitude of contexts, needs, challenges and strengths. Therefore, Regional Curriculum Workshops (RCWs) are a means to further strengthen the curriculum development process by soliciting in-depth feedback and analysis.
- The RCWs are in-region workshops that are to be organized by the relevant provincial/regional body.
- These can be in-person or online.
- Representatives from the respective provincial/area education department, curriculum and subjects experts from the public, private and local non-profit sector in the region may attend the RCWs
- The RCWs can be organized based on subject, thematic area, functional area, or more.
