Respectfully Sheweeth:

1. That the Appellant was appointed in B.P.S-7 as Against Vacant Industrial Home Post on Contract Basis for a period of three years on 31.08.2005.

2. That thereafter in the year 2012 the post of PST working in BPS-5,6,7, 8, 9 10 & 12 were upgraded to BPS-12 vide Notification dated.30.08.2012.

3. That the Respondents circulated Final Seniority list of PST Female of FR Kohat wherein the Appellant stood at serial No.101 but when the working paper for promotion of PST B-12 to 14 & 15 was prepared, the name of Appellant was not included in the Working paper despite the fact that Appellant has almost fifteen years of service to her credit.

4. That to the utter shock & dismay of Appellant, the candidates at Serial 100 & 102 (Respondent No.5) were promoted to BPS-12 on 17.10.2019 and on the very next day the same were again promoted to BPS -15 vide Notification dated.18.10.2019.

5. That the Appellant against the promotion of the Respondent No.5 junior to Appellant filed representation but to no avail.

6. That the Appellant against the Order of promotion dated 17.10.2019 & 18.10.2019 is filing the instant Appeal on the following grounds:


GROUND:

- a. That the Acts of Respondents are unlawful, illegal and against the well settled principles of natural justice which needs to be set aside.
- b. That the Appellant has a total of 15 years service to her credit and despite the fact that no inquiry or any other proceedings are pending against the Appellant but still she has been ignored in promotion which is totally against Law.
- c. That denying promotion to the Appellant without any reason is not only violative of the fundamental rights of Appellant but also against the settled principles of Law.
- d. That the malafide of Respondents can be judged from this fact that the candidates placed serial No.100 & 102 (Respondent No.5) were promoted to BPS-14 on 17.10.2019 & on the very next day i-e 18.10.2019 they were promoted to B.P.S-15.

It is therefore humbly requested that on acceptance of this Appeal, the Impugned Notification of promotion of Respondent No.5 being junior to Appellant may kindly be set aside and the Appellant may kindly be promoted to BPS-15 from the date when the other candidates were promoted with all consequential benefits.
