

Preliminary Objection:

1. That the appellant has got no cause of action to file the instant appeal.
2. That the appellant has not come to this Hon'ble Tribunal with clean hands.
3. That the petition is bad in law and facts.
4. That appellant concealed the material facts from this Hon'ble Tribunal.
5. That appellant being citizen of Pakistan, enjoying all his due and fundamental rights incorporated under constitution of Islamic Republic of Pakistan, 1973.
6. That the appeal in hand is not maintainable and incompetent in the eyes of law.
7. That the appellant is estopped by his own conduct.
8. That the appeal is mis-constructed and mistakenly drawn, hence liable to be rejected.

On facts:

Incorrect, both establishment and Excise department are different departments, having different cadre and set of rules, standard of induction, method of recruitment & promotion etc. pertinent to mention here that excise Department is governed by its own set of rules namely called 2018 rules (**Annexure-A**). on the other hand, PMS is different cadre runs under 2007 rules namely called PMS rules 2007. Its parent department is establishment & Administration department, having different nomenclature, schedule, promotion, training and induction method (**Annexure-B**).
If directorate of Excise & Taxation has not its own syllabus of training Modules, then they should frame its own syllabus & Training Module.
4. Correct. And under this power the Directorate of Excise has been established an attached Department and ETO's are working under this Directorate.

- 5. Incorrect. The appellants are working in Directorate of Excise which is the attached department of Excise Department and they work under its administrative control Excise Department.
- 6. That appellants admitting the fact in para 09. The Finance Department vide (NO.SOSR-IV/FD/1-13/2021/E&TD) Dated 15-08-2022 said, "The officers of Excise Directorate are not covered under the provision of the Department's notification as they are neither PAS, PCS, PMS Officers nor posted against the scheduled posts but are inducted through KP-PSC as ETOs. In view of above, it is clear that they were/are not entitled for executive allowance. (Copy of Notification is annexed C)
- 7. Correct to the extent that Govt. of Khyber Pakhtunkhwa, Finance Department vide notification dated 02-02-2018 sanctioned Executive Allowance to the tune of 1.5 initial Basic pay per month on the pay scale 2017 to PAS/PCS & PMS officers against the schedule posts of Establishment and Administration Department with some conditions mentioned in the above cited notification, the Provincial Government vide Notification dated 07-07-2021 granted Executive Allowance to all officers of PAS, PMS & PCS working in Establishment and Administration Department against Scheduled posts w.e.f. 01-07-2021 @ 150% of the running basic pay (Annex-D). Similarly, the appellants admitted that being PCS qualified Officer they have already taken the said allowance, which is sheer violation on part of appellants, That they have taken this allowance without the Government approval.
- 8. Correct to the extent that representation of the appellants was received, processed. But the appellants themselves has admitted that it was regretted.
- 9. Finance Department vide letter dated 15-08-2022 replied that provincial Govt. vide notification dated 07-07-2021 in supersession of previous notification granted Executive allowance @150% of running basic pay from 01-07-2021 to all officers of PAS, PCS PMS working in Establishment and Administration Department against scheduled posts whether they are posted or not. Furthermore, the said allowance is admissible to all officers posted against scheduled posts in the Province irrespective of their service cadre.

The officers of Excise Directorate are not covered under the provision of this department's notification as they are neither PAS, PCS, PMS officers of Establishment & Administration Department nor posted against the scheduled posts but are inducted through KP-PSC as ETOs.

In view of the above, it is clear that they were/ are not entitled for Executive Allowance and have drawn Executive Allowance from July, 2021 to April, 2022


irregularly therefore the same may be recovered from them under intimation to this Department (Annex-E)

No.SOE.II(ED)2(14)2007.---In exercise of the powers conferred by section 26 of the ²[Khyber Pakhtunkhwa] Civil Servant Act, 1973 (³[Khyber Pakhtunkhwa] Act XVIII of 1973), the Chief Minister of the ⁴[Khyber Pakhtunkhwa] is pleased to make the following rules, namely:

THE ⁵[Khyber Pakhtunkhwa] PROVINCIAL MANAGEMENT SERVICE RULES, 2007

1. Short title and commencement.---(1) These rules may be called the ⁶[Khyber Pakhtunkhwa] Provincial Management Service Rules, 2007:

(2) These rules shall come into force at once.

2. Definitions.---In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say:

(a) "appointing authority" means the appointing authority as specified in rule 5 of these rules;

(b) "Commission" means the ⁷[Khyber Pakhtunkhwa] Public Service Commission;

(c) "Department" means the Establishment and Administration Department;

(d) "Departmental Examination" means the prescribed examination to be conducted by the Department for confirmation within probationary period or for promotion to higher post, as the case may be;

(e) "Departmental Training" means any training prescribed by Government, the successful completion whereof is necessary for promotion to BS-18 and BS-19;

(f) "Schedule" means the Schedule appended to these rules;

(g) "Service" means the Provincial Management Service;

(h) "Secretariat" means the ⁸[Khyber Pakhtunkhwa] Civil Secretariat as defined in rule 2(r) of the ⁹[Khyber Pakhtunkhwa] Government Rules of Business, 1985; and

(i) "share" means the share specified for distribution between All Pakistan Unified Group and Provincial Officers as per Schedule-III.

3. Nomenclature of the posts.---The Service shall consist of the posts as specified in Schedule-I.

4. **Method of recruitment.**---(1) The method of recruitment, minimum qualification, age limit and other matters related thereto for the Service shall be as given in Schedule-I.

(2) Fifty per cent of posts in BPS-17 shall be filled in by initial recruitment through Commission and remaining by promotion. Ten percent of Secretariat posts in BPS-17 to 19 shall be reserved for officers of technical departments on reciprocal basis. Government may reserve twenty per cent posts for leave, deputation and training etc in each pay scale.

(3) Posts specified in Schedule-II shall be filled in by Officers borne on Provincial Management Service and All Pakistan Unified Group in the ratio prescribed in Schedule-III.

¹⁰**[4-A. Training.**--- On appointment to the post borne on the service in BS-17, whether by initial recruitment or by promotion, every officer so appointed shall successfully complete one and a half year's mandatory training including one year training at the Provincial Services Academy as per Module specified in Schedule-IV and six months training attachment as specified in Schedule-V. The training will be followed by Departmental Examination to be conducted by the Provincial Services Academy as specified in Schedule-VI.

5. **Appointing Authority.**---The Chief Minister, ¹¹[Khyber Pakhtunkhwa] shall be the appointing authority for posts borne on the Provincial Management Service specified in Schedule-I.]

7. **Transitional:**- The condition of graduation as laid down in para 2(a) and (b) of column-5 against serial No. 1 of Schedule-I shall not apply for a period of seven years from the date of coming into force of these rules to the existing incumbents for promotion against BS-17 posts.

8. **Repeal.**---The ¹⁴[Khyber Pakhtunkhwa] Provincial Civil Service (Secretariat/Executive Group) Rules, 1997 shall stand repealed after the retirement of existing incumbents of both the cadres.
