APPEAL UNDER SECTION 4 OF THE KPK SERVICE TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED ORDER DATED 30/12/2022 DEPARTMENTAL APPEAL OF THE APPELLANT DATED 17.01.2023 REGARDING THE CORRECTION OF SENIORITY LIST HAS BEEN REJECTED AND FOR SAME RELIEF WHICH IS GIVEN BY THE DEPARTMENT TO THE PRVIATE RESPONDENTS.

Respectfully Sheweth:

Short Facts given rise to the present appeal are as under:-

The appellant respectfully submits as under:

- That the appellant belongs to a respectable family at Chitral and qualified degree holder from concern University. (Copy of educational documents are attached herewith marked "A").
- That on the basis of his qualification, the appellant was appointed as Patwari in the new settlement Khyber Pakhtunkhwa on contract basis. (Copy of the appointment order is attached herewith marked "B").
- 3) That now, the appellant is working as Qanoongo in Revenue Department Chitral.
- That the Government of Khyber Pakhtunkhwa has regularized the service of appellant from contract to regular basis through an Act of Assembly, which was approved by than Government. The service of appellant has been regularized from the date of his initial appointment. (Copy of regularization order is attached as herewith marked "C").
- (Respondent No. 3) prepared the seniority list on the basis of seniority cum fitness and on the basis of appointment year according to which the appellant was senior to the private respondents. Astonishingly, at the time of regularization the private respondents

were made senior and placed him in higher rank of seniority list.

- That the private Respondents illegally, unlawfully, transfer regularized and promoted, to Higher rank while the private respondents most junior then, petitioner (order of the private respondents is marked).
- 7) That during the process of regularization, the service of appellant was not considered without any cogent reason and placed him below in merit list.
- Phat feeling aggrieved from, the appellant filed a Departmental Appeal on 17.01.2023 which was not answered by the respondent without cogent reasons which were best known to them. (Copy of Departmental Appeal is attached as Annexure-E).
- remainder application on 26.04.2023 from getting information about the decision on appeal filed by the appellant but has not been provide the detail of order to appeal hence feeling aggrieved from, the appellant approached this tribunal/forum for redressal of his grievance inter alia on the following grounds:- (Copy of reminder application is attached-F).

GROUNDS OF APPEAL

A). That the impugned order dated 30.12.2022 and not answering the Departmental Appeal dated 17/01/2023 are against the law, facts and against

without lawful

the rules and regulations, without lawful authority thus liable to be set aside.

- B) It is well settled law that equal treatment is the fundamental right of every citizen by virtue of Article-25 of the Constitution of Islamic Republic of Pakistan 1973 to similarly placed employees cannot be treated differently. But the authority blatantly violated the such provision of Constitution Republic of Pakistan 1973 by not considering the appellant qua. similarly placed employees 8 to 11.
- C). That not considering the period of service of the appellant from his due service which was based on seniority-cum-fitness is against the policy and law given by the superior court and by laws of the concern Department. The question needs kind consideration of this Hon' able Tribunal and on this score, the impugned order/seniority list dated 30/12/2022 and not answering the Departmental Appeal of the appellant are against the law, facts and liable to be set aside.
- D). That it is also worth perusal and required consid. ation that rules are also supporting the stance of appellant, hence the impugned order/seniority list dated 30.12.2022 and mentioning the merit of appellant below from the private respondents is against the fundamental rights of the appellant which is sheer violation of fundamental right, rules and regulation protected

F). That the present appeal is well within time and this Hon' able Tribunal may entertain this appeal.

down polices, hence invites consideration of this

- G). That the impugned order of the respondents without adopting proper criteria and codal requirements by the respondents is against worthy ruling of the Hon' able Super Courts of Pakistan and therefore the same is illegal practice adversely affects efficiency of incumbents and also reduces their confidence and faith in public, hence the impugned order and reduction of seniority of be un-held on this score.
- H). That any other grounds which has not been specifically mentioned will be agitated at the time of arguments with kind permission of this Hon' able court.

PRAY R

In view of the above narrated facts and grounds, it is therefore humbly prayed that on acceptance of the instant appeal, the appellant may graciously be regularized from the date






