



Appeal against the notification vide No, SOE(AD)II(2) 429/2011 dated 20/01/2014 whereby post of the Research Officers are confined to initial recruitment and quota of 25% by promotion amongst the filed assistant having prescribed qualification has been deleted which was earlier existed in the rules of 1981.

Respectfully sheweth,

1. That appellant is serving in Agriculture Department (Research Wing) in the capacity of mentioned against their names.
2. That appellant has rendered services to the satisfaction of the public and authorities without any dent.
3. That earlier appellant's service was regularized by the Service Rules of 1981 wherein an opportunity of promotion was allowed to the senior incumbent with certain conditions.
4. That respondent No, 1 issued above mentioned Notification regarding Service rules in two different sets for the employees of the Agriculture Department (Research Wing) in the Province of Khyber Pukhtunkawa. (Copy of Rules are annexed as annexure A)
5. That it is pertinent to mention here that since the issuance of the impugned Notification appellant was never permitted to have a copy of the same and on the departmental application respondents kept the application as in process but take months in moving the same from one office to other, hence appellant was remain ignorant of the fact of the impugned Notification.
6. That appellant being an employee of the Agriculture Department (Research Wing) came to know about the above-mentioned notification when they found missing the quota of the appellant for appointment through promotion as Research Officers.
7. That appellant feeling aggrieved of the above notification, submitted a departmental representation through proper channel but the same was moving in the offices of the respondents without

substantive result for years. (Copy of the appeal is annexed as annexure B)

8. That it is worth mentioning here that in other wings of the Agriculture department i.e Agriculture Extension and soil conservation, there is proper criteria for promotion of filed Assistant/Research Supervisor/Research Inspector with identical qualification and nature of Job but appellants are constantly kept deprived of their right to be promoted as Research officers. (Copy of Service rules of the said wings are annexed as annexure C)
9. That since the above appeal no response whatsoever has been received to the appellants despite several visits to the office of respondents.
10. That as appellant filed an appeal in respect of his grievances to the respondents but of no avail, so left with no option except to file instant appeal on the following grounds.

#### Grounds:

- A. That striking off quota of the petitioners for the post of Research Officer from the rules is against the law and rules
- B. That issuing of the said rules through an impugned notification is tantamount to a violation of fundamental rights envisaged in the constitution of Pakistan 1973 hence not tenable in the eyes of Law.
- C. That by the impugned rules appellants has been discriminately treated and deprived of fundamental right and the same are also not in parity with other incumbents of the Agriculture department, so only on this score the rules are not sustainable and are against basic principles of service rules.

- D. That on the basis of the impugned rules only one category of employees is treated in strange manners as there is no recruitment of Research officers by promotion so the impugned rules are equal to alteration in the statute which is not permissible, so be set at naught out rightly.
- E. That framing of service rules for the appellants are against the prescribed service rules hence violation of the law of the land.
- F. That appellants are well at par with the other incumbent of the agriculture department in all respects, but the attitude of the respondent is discriminatory and petitioners are being deprived from their constitutional right.
- G. That impugned rules are an example of discrimination with incumbents who served in their respective fields for years and acquired experience and due to the impugned rules they have been deprived of their rights
- H. That conduct of the respondents is irritating and is against the principle of natural justice and equity.
- I. That Article 4 of the constitution of the Islamic Republic of Pakistan is guidance for the authorities to deal with the right of the according with law but the respondent failed to do so.
- J. That Article 25 of the constitution of the Islamic republic of Pakistan speak to the equality of the citizen but respondents discriminated against the appellants and kept them in a static position since the issuance of the impugned rules, which is a violation of law.






*Departmental Representation against the notification vide No,SOE(AD)II(2) 429/2011 dated 20/01/2014 whereby post of the Research Officers are confined only to initial recruitment and quota of 25% by promotion amongst the filed assistant having prescribed qualification has been deleted which was earlier existed in the Service rules of 1981.*

*Respected Sir,*

- 1. That appellant is serving in Agriculture Department (Research Wing) in the capacity of mentioned against his names.*
- 2. That appellant has rendered services to the satisfaction of the public and authorities without any dent.*
- 3. That earlier appellant's service was regularized by the Service Rules of 1981 wherein an opportunity of promotion to the level of Research Officer was allowed to the senior incumbent of the same category with certain conditions.*

4. That department issued above mentioned Notification regarding Service rules in two different sets for the employees of the Agriculture Department (Research Wing) in the Province of Khyber Pukhtunkawa.
  5. That it is pertinent to mention here that since the issuance of the impugned Notification appellant was never permitted to have a copy of the same and whenever the appellant approached the authorities with applications through the representative of the appellant, the authorities concerned kept the application pending for months, hence appellant was remained oblivious of the fact of the impugned Notification for a reasonable period.
  6. That appellant being an employee of the Agriculture Department (Research Wing) came to know about the above-mentioned notification just a few months back and when go through it he found missing the quota appellant for promotion as Research officers.
  7. That appellant feeling aggrieved of the above notification, submitted this departmental representation on the following grounds.

**Grounds:**

- A. That striking of quota of the appellant for the post of Research Officer from the rules is against the law and Civil Servant Act.
- B. That issuing of the said rules through an impugned notification is tantamount to a violation of fundamental rights envisaged in the constitution of Pakistan 1973 hence not tenable in the eyes of Law.

C. That by the impugned rules appellant has been discriminately treated and deprived of fundamental right and the same are also not in parity with other incumbents of the Agriculture department, so only on this score the rules are not sustainable and are against basic principles of service rules.

D. That on the basis of the impugned rules only one category of employees (that is appellant) is treated in strange manners by mentioning no recruitment of Research officers through promotion so the impugned rules are equal to alteration in the statute which is not permissible, so be set at naught outrightly.

E. That framing of service rules for the appellant is against the prescribed service rules, hence is in violation of the law of the land.

F. That appellant is well at par with the other incumbent of the agriculture department in all respects, but the impugned rules are discriminatory and the appellant is deprived of his constitutional right.

G. That impugned rules are a bad example of discrimination as other incumbents of the Agriculture Department are treated altogether in different manners which sheer violation of equality and equity.

H. That Article 4 of the constitution of the Islamic Republic of Pakistan is guidance for the authorities to deal with the right of all incumbents of the department with equality but unfortunately, the impugned Notification is issued in utter disregard to the provision of the constitution.

I. That Article 25 of the constitution of the Islamic Republic of Pakistan enshrined the golden principle of equality of the citizen but through the discriminated service rules

mentioned above for the Agriculture Research wings are against the *ibid* provision of the constitution.

In the lights of the above facts and grounds, it is humbly submitted that by accepting this appeal, the impugned rules may kindly be declared void, illegal and against the law and kindly insert criteria of appointment of Research Officers through promotion as it was mentioned in the Service rules of 1981, along with any other appropriate remedy which is not specifically asked for.
