3. That the valuable right of respondents are attached to and if right of defense has not been restored, it may likely to cause irreparable loss/damages to the respondents/defendants.


4. That the respondents are ready to file the written reply which has already been delayed due to the procedure pending before various departments.

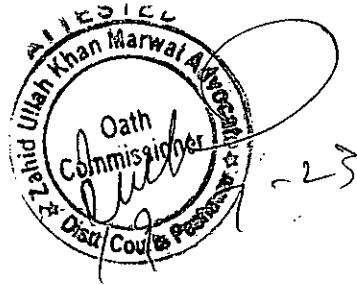


