

**Preliminary Objections**

- 1;- That the Appellant has got no cause of action to file the instant petition.
- 2;- That the Appellant has concealed material fact from the Honorable Tribunal.
- 3;- That the Appellant has es-stopped due to her own conduct to file the present petition.
- 4;- That the Appellant has got no locus stand to file the petition.
- 5;- That the Petition is not maintainable in present form.
- 6;- That the Petition is liable to be dismissed for mis-joinder of unnecessary and non-joinder of necessary parties
- 7;- That the Appellant being a civil servant must obey the directions/orders of the competent authority

## **ON FACTS**

1;- That Para 1 of the facts is correct that the appellant is working as SST General under the supervision of the respondent No 1 to 3, while it is incorrect that the appellant is working on the basis of transfer order dated 13-6-2022 at GGHS Jalala, as the said order has been withdrawn/recalled and the appellant is directed to take charge in her old station/School i.e. GGMS Karkani Khar.

2;- That Para -2 of the facts pertains to record, needs no comments.

3;- That Para-3 of the fact is correct that the appellant was transferred from GGMS Karkani Khar to GGHS Jalala Vide Order dated 13-06-2022, but due to complaints/appeal against the ibid transfer order a proper inquiry committee, the transfer order dated 13-6-2022 was withdrawn, and the appellant and respondent No 4 were directed to take over charge in their previous Schools accordingly. (Copy of the inquiry committee is attached is ( " A" )

4;- That Para-4 of the facts is correct details have been submitted in the above para's.

5;- That Para-5 of the facts is correct details have been submitted in the above para's.

6;- That Para -6 of the facts is incorrect, hence denied and further stated that the order dated 12-12-2022 has been issued as per law rules and policies, as well as on the basis of the recommendation of the inquiry committee, in detail again it is stated that Respondent No 4 was promoted from SCT to SST General BPS 16 and was adjusted at GGHS Badam Baghicha and Vide Order dated 11-02-2019, two post of SST including the post of the respondent No 4 was /shifted from GGHS Badam Baghicha to GGHS No2 Batkhela on need base but the position code of the post concerned was not changed due to some issues, while the post of SST General at GGHS Badam Baghicha was also filled by inter District Transfer by Anisa Chand, Vide Order No 1335-38/A-17/PF/Aneesa Chand/SST/Dir Lower dated 20-7-2020, after filling of the post of SST General at GGHS Badam Baghicha by Mist; Anisa Chand, the respondent No 4 become surplus, thus she was re-adjusted/transfer to GGHS Jalala Vide Order Endst No 20135-41 dated

E;- Para "E" is incorrect, and further stated that the appellant has not challenged the inquiry till date, thus claim/objection of the appellant is rejected.

F;- Para "F" needs no comments.

G;- Legal, however the respondent also seeks permission for additional Grounds during arguments.

It is, therefore, humbly prayed that on acceptance of the above submission, the Service Appeal may very graciously be dismissed in favor of the answering respondents with cost.



**INTRODUCTION:**

In response to DEO (F) office letter No.2358-61 dated 21/11/2022. The inquiry committee visited DEO (F) office and studied the relevant record and also investigate the concerned teacher MISS SHABNAM BEGUM personally. During the course of enquiry the committee has come to the following facts and findings.

**FACTS:**

1. The applicant was promoted from SCT to SST (G) and transferred to GGHS BATHKHELA vide order No.1155-59/promotion of AT/CT/DM/PST to SST Dated BATHKHELA, the 26/02/2019 (Anexture-1) along with post as two posts of SST, one SST (G) and one (M/P) were shifted from GGHS BADAM BAGHICHA THANA to BATHKHELA No.2 vide DEO office letter No.788 Dated 11/02/2019. (Anexture-2)
2. Another teacher ANISA CHAND SST(G) transferred from GGHS DARA RAMORA DIR LOWER to GGHS BB THANA vide order No.1335-38/A-17/PF/Anisa Chand/SST/Dir Lower Dated 20-07-2020. (Anexture-3) on that post of SST (G) which was already shifted to GGHS BATHKHELA No.2.
3. The applicant SHABNAM BEGUM served there in GGHS BATHKHELA NO.2 for three years and three months and then transferred to GGHS JALALA vide order No. 20135-41 Dated 07-05-2022 (Anexture-4) with the claim that the applicant SHABNAM BEGUM is surplus here and the post of SST(G) is not sanctioned. The applicant took over charge in GGHS JALALA and draw salary for the month of June and July there.

2. Transfer order of the applicant SHABNAM BEGUM was cancelled vide order No. 20690-96 Dated 11/06/2022 (Anexture-5) and the applicant was again transferred from GGHS BATKHELA No 2 to GGCMS KARKANI KHAR (Anexture-6) while the relieving chit (Anexture-7) of the applicant dually signed by the Headmistress of GGHS JALALA reveals that she was serving in GGHS JALALA and was relieved from there and not from GGHS BATKHELA No.2.
5. In the same transfer order No. 20697-702/Dated 13/06/2022 Miss SHAZIA SST(G) was transferred from GGCMS KARKANI KHAR TO GGHS JALALA.

**FINDINGS:**

1. According to the applicant SHABNAM BEGUM Post of SST(G) was transferred from GGHS BB THANA to GGHS BATKHELA No.2 while the record study shows that these posts were not actually shifted as Miss ANISA CHAND from DIR LOWER was transferred on that post.
2. Negligence on the part of handling staff of GGHS BATKHELA No.2 cannot be ignored as why they handed over charge to the applicant when the post was not sanctioned or shifted from somewhere else and when the post was not shifted there then how the said teacher drawn salaries from GGHS BATKHELA No.2? From where the position code come when the post was not shifted?
3. DEO FEMALE Office is also equally responsible for all this as they did not reconcile these posts with Finance Department for a long period of three years.
4. When the applicant was surplus in GGHS BATKHELA No.2 and transferred to GGHS JALALA, why was her transfer cancelled without any sound base?

**RECOMMENDATIONS:**

The inquiry committee after studying the relevant record recommends that

1. The applicant MISS SHABNAM BEGUM SST(G) suffered for a long time because of the carelessness of DEO (F) OFFICE and handling staff of GGHS BATKHELA No.2 and being resident of the area she may either be transferred to GGHS BADAM BAGHICHA OR GGHS JALALA.
