The Respondents submit as under:-

### PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi to file the instant appeal.
- 2 That the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of 1973 Islamic Republic of Pakistan.
- 3 That the appellant has concealed material facts from this Honorable Bench.
- 4 That the Appellant has not come to this Honorable Court with clean hands.
- 5 That the appeal in hand is based on mala fide intentions for illegal service benefits.
- 6 That the appeal in hand is barred by law in view of the law of limitation.
- 7 That a CPLA has already been filed by the Respondent Department in the Supreme Court of Pakistan against the judgment dated 14-07-2021 in Service Appeal No. 1266/2018 Afzal Shah SST VS Govt; which is also identical with the titled case.

### ON FACTS.

- 1 That Para-1 pertains to the Academic record of the appellant.
- 2 That Para-2 also pertains to the appointment against the CT (M) post of the appellant appointed vide order dated 19-09-1998, whereas, the plea regarding his promotion to the post of SST along with his adjustment at G.I.S.H.S District Kurram is subject with production cogent proof & record which lies upon the shoulders of the appellant.
- 3 That Para-3 is correct that vide Notification bearing No. SO(PE)/4-5/SSRC/Meeting/2013/TC dated 24-07-2014, the criteria for promotion/upgradation in the upper scales to the Teaching Staff working in the Khyber Pakhtunkhwa was framed & Notified by excluding the Teachers of Ex-FATA/NMDs which were directly falls within the administrative authority of the Federal Government & was merged into Khyber Pakhtunkhwa through the 25<sup>th</sup> amendment in the constitution of 1973

through the National Assembly endorsed by the Senate of Pakistan & approved by the president of Pakistan.

Therefore, the appellant does not falls within the ambit of aforesaid service rules dated 24.07-2014 as the cases have been proceeded by the Director Ex-FATA in the year 2017 after the approval of the Federal Government copy of the service rules dated **2**4.07-2014 attached as *Annexure-A*.

- 4 That Para-4 is correct that vide letter dated 07-08-2014, all the DEOs (M/F) throughout Khyber Pakhtunkhwa were directed to process the cases of Teaching Cadre working in the settled areas of Khyber Pakhtunkhwa in view of the service rules under reference.
- 5 That Para-5 is incorrect as the Respondent No.2 is mainly responsible for processing the cases of Teachers for promotion & upgradation to the post of SST (BPS-16) under the service rules who are working in the Khyber Pakhtunkhwa (Settled Areas) during the period w.e.f. 2014 to 2017 excluding the Teaching Staff of Ex-FATA due to the lack of jurisdiction by the then Government of Khyber Pakhtunkhwa.
- 6 That Para-6 subject to the proof & record to the extent of the letter dated 31-10-2014 of the then District Education Officer (Male) Hungu attached as *Annexure-B*.
- 7 That Para-7 is correct that vide letter dated 09-03-2015 all concerned have been directed to process  $\phi$  the cases of Teaching Staff for promotion to the post of SST under the rules by the authority concerned attached as Annexure-C.
- 8 That Para 8 is also incorrect as the act of the Respondent No. 3 & 4 is within legal sphere in view of the submissions in made in para 3 of the present reply by the Department.
- 9 That Para-9 is incorrect as the act of the Respondent No.3 with regard to the Seniority & promotion of the appellant & all other Teachers working Ex-FATA/NMDs is within legal parameter of even in accordance with the Notification dated 13-11-2012 attached as Annexure-D.
- 10 That Para-10 is correct to the extent of order dated 28-02-2017, whereby, upgradation in view of the Notification dated 24-07-2014 was allowed w.e.f. 2017 to the teaching staff Ex-FATA upon the approval of the Federal Government. (Copy of the Notification dated 28-02-2017 is Annexure-E).
- 11 That para-11 is also incorrect as the service rules dated 24-07-2014 was not extended to the Ex-FATA/NMDs during the period w.e.f. 2014 to 2017 rather it was extended & implemented w.e.f. 2017 & whereby, the appellant was promoted vide order dated 11-10-2017 by the Department
- 12 That Para-12 is incorrect, as no Departmental appeal has been filed against the order dated 11-10-2017 by the appellant till date, hence, got finality under the law.
- 13 That Para 13 is subject to the proof & record.
- 14 That Para-14 is subject to the proof & record which is lies upon the appellant.
- 15 That Para-15 is correct to the extent of the judgment dated 14.07.2021 of this Honorable Tribunal rendered in Service Appeal No. 1266/2018 Afzal Shah SST VS Govt; which is not applicable upon the case of the appellant.

16 That Para 16 is also incorrect, hence, denied on the grounds that the appellants is not an aggrieved person within the meaning of Article 212 of the constitution of 1973, therefore, the case in hand is liable to be dismissed on the following grounds inter alia:-

### ON GROUNDS.

- I. <u>Incorrect & not admitted</u>, the appellant has been treated as per law & rules.
- II. Incorrect & not admitted. As reply to this ground has been given above.
- III. Incorrect & not admitted. As reply to this ground has been given above.
- IV. <u>Incorrect & not admitted.</u> The act of the Department is legal with no discrimination to words the appellant in the titled case.
- V. <u>Incorrect & not admitted.</u> The Notification dated 24-07-2014 is not applicable upon the case of the appellant during the period of w.e.f. 2014 to 2017.
- VI. <u>Incorrect & not admitted.</u> As reply to this ground has been given above.
- VII. <u>Incorrect & not admitted.</u> Hence, needs no further comments.
- VIII. <u>Incorrect & not admitted.</u> The stand of the appellant is illegal as is not entitled for promotion as SST w.e.f. 24-07-2014 under the rules.
  - IX. <u>Incorrect & not admitted</u>. However, the Respondents also seek leave of this Learned Bench to submit additional grounds record & case law at the time on date of hearing.

Therefore, in view of the above made submissions, the appeal in hand may kindly be dismissed in favor of the Department in the interest of justice.
