**Subject: Joint Para-wise comments/reply on behalf of Respondent No.01 to 04
are as under**

Respectfully Sheweth;

Preliminary Objections:

- i. That the appellant has got no cause of action/locus standi.*
- ii. That the instant appeal is badly time barred.*
- iii. That the appellant has concealed the material facts from this honorable tribunal, hence liable to be dismissed.*
- iv. That the appellant has not come to this honorable tribunal with clean hands.*
- v. That the appellant has filed the instant appeal just to pressurize the respondents.*
- vi. That the appellant has filed the instant appeal on malafide motives.*
- vii. That the instant appeal is against the prevailing law and rules.*
- viii. That the appellant is estopped by his own conduct to file this instant appeal.*
- ix. That the present appeal is not maintainable in the present form and also in the present circumstances of the case.*
- x. That the appeal is bad for misjoinder and non joinder of necessary parties.*

Objection on Facts

1. That the appellant is completely ignorant from the fact that the Police and Prisons are different Departments. The appellant states that he was inducted into Police Department while the fact is that he was inducted into Prisons Department.
2. Incorrect and not admitted. The appellant in the very beginning had took no seriousness in his job and created hurdle for the administration, being sensitive force service such like lethargic attitude toward his designated duty is unwarranted and undesirable. The statement of the appellant is wrong as his actual performance has been unsatisfactory, resulting in major penalties. The following penalties

including major penalties were awarded to the appellant during his service:-

II	Stoppage of one annual increment without future effect vide superintendent HQ prison Bannu No. 2755 dated 30.07.2011
III	Awarded major penalty of Removal from Service for his long absence and presenting fake / bogus medical certificates vide HQ Prison D.I.Khan No. 7768-73 dated 19.11.2012
IV	Awarded major penalty of Removal From Service vide superintendent HQ prison D.I.Khan No.409 dated 16.01.2014
V	Awarded minor penalty of Censure vide HQ prison D.I.Khan No. 621 dated 04.12.2019
VI	Stoppage of one increment for one year and absence period from 26.11.2019 to 04.12.2019 treated as Leave Without Pay vide HQ Prison D.I.Khan No. 698 dated 05.03.2020.
VII	Major penalty of Compulsory Retirement from service vide HQ D.I.Khan No. 2509-12 dated 25.06.2021

From the perusal of the above aforementioned penalties, it is crystal clear that the appellant had no interest in his service which leads to his Compulsory Retirement from Service.

3. That the appellant is habitual absentee and did not take interest in duties. The appellant violated the provision of Khyber Pakhtunkhwa Prison Rules 2018 Rule 1083 (**Annex-A**) which indicate that in case of wilful absence due to unavoidable circumstances a mechanism of granting of leave has been provided while the appellant not followed the same line and remained absent without the approval of the competent authority.
4. Incorrect. That the respondent No.03 reported against the appellant vide No. 1640 dated 26.05.2021 (**Annex-B**) regarding the absence of the appellant. The appellant is malingerer who always absented himself from duties on one pretext or other as is evident from his past record. He was served show cause notice vide No. 2004 dated 28.05.2021 with personal hearing date fixed for 04.06.2021 (**Annex-C**).
5. Incorrect. That as mentioned at Para-04 of objection on facts, the appellant was awarded opportunity of personal hearing on 04.06.2021 before Respondent No.04 and then another opportunity of personal hearing was afforded by Respondent No.02 on 25.08.2021.
6. Pertains to record. That the appellant was awarded major penalty of

Compulsory retirement from service being habitual of absence and not taking interest in duties by respondent No.04 vide No. 2508 dated 25.06.2021 **(Annex-D)**.

7. Incorrect. That the appellant filed departmental appeal before Respondent No.02 **(Annex-E)** on dated 14.07.2021 which was decided by the respondent No.02 vide No. 27644 dated 27.08.2021 **(Annex-F)**. It is pertinent to mention here that the actual appeal which was filed by the appellant before Respondent No.02 was filed on 14.07.2021 and written in Urdu while the appellant has shown departmental appeal before the Honourable Service Tribunal (placed at page No.19 of the appeal) is in English language **(Annex-G)** and completely different from the original departmental appeal. This again shows that the appellant is not true in his statement and even malingering before the Honourable Court.
8. Incorrect. The Inspector General of Prisons Khyber Pakhtunkhwa Peshawar being the appellate authority after examining the material facts available on record and views provided by respondent No.04 as mentioned in Para-07 on objection on Facts the departmental appeal has been rejected by the Respondent No.02 vide No.27644 dated 27.08.2021 **(Annex-H)**

OBJECTION ON GROUNDS


- A. Incorrect. The orders of compulsory retirement from service passed by the respondent No.04 vide No. 2508 dated 25.06.2021 is lawful, legal and based on facts.
- B. As elaborated in Para-A of objection on grounds.
- C. Incorrect. Legal proceedings have been carried out against the appellant. Ample opportunities were granted to the appellant to defend himself. Proper disciplinary proceedings were carried out vide No. 2003-04 dated 28.05.2021 with opportunity of personal hearing before the respondent No.04 on dated 04.06.2023 and another opportunity of personal hearing was granted before the respondent No.02 vide No. 27644 dated 27.08.2023 on 25.08.2023.
- D. As elaborated in Para-02 & 04 of objection on facts.
- E. Incorrect. That the departmental appeal was filed by the appellant on

dated 14.07.2021 before Respondent No.02. The appellant appeared before the Respondent No.02 for personal hearing on 25.08.2023. His departmental appeal was rejected by the Respondent No.02 vide No. 27644 dated 27.08.2023 being without any substance and habitual offender.

- F. That the appellant is habitual offender and do not deserve for any leniency.
- G. Incorrect. The appellant is habitual offender. His past record mentioned in para-02 of objection on facts speaks about his past adverse record.
- H. Incorrect. The appellant do not deserve to be re-instated being habitual offender and not fit for the sensitive force service which requires strict discipline and regularity which do not fulfil by appellant concerned.
- I. The respondents seek leave to raise additional grounds at the time of arguments.


PRAYER :


It is therefore most humbly prayed that on the acceptance of above Joint Para-wise comments on behalf of respondent No. 01 to 04, the appeal of the appellant may graciously be dismissed being devoid of merit and against the law.

1080. Prohibition against business and pecuniary transactions.---(1) No prison officer shall directly or indirectly engage in any trade, business or employment other than his legitimate duties.

(2) No prison officer shall lend money to, borrow money from, enter into any pecuniary transaction with, or incur any obligation in favor of any other officer or any prisoner.

1081. Residential quarters.---(1) Rent free residential quarters shall ordinarily be provided at each prison for the Superintendent, Deputy Superintendent, Senior Assistant Superintendent, Assistant Superintendents, Senior Medical Officer, Medical Officer, Pharmacy Technician, Assistants and Clerical Staff, Storekeepers, Instructors, Teachers, Head Warders and the Warders.

(2) Every prison official for whom the residential quarters are not available in prison shall reside within such distance from the prison as the Superintendent may direct,

1082. Leave to Subordinate Officers.---(1) No subordinate officer shall, at any time, without the permission of the Deputy Superintendent, if such officer is subordinate to him, and, in any other case, of the Superintendent, be absent from the prison premises, whether by day or night.

(2) The Deputy Superintendent shall not, without the sanction of the Superintendent, grant leave of absence to any subordinate officer, or permit any such officer to remain absent, for any period exceeding four hours at any one time.

(3) Whenever any leave is granted by the Deputy Superintendent to any subordinate officer he shall, at the time the leave is granted, record the fact, and the period of leave in his report book.

(4) Every subordinate officer shall immediately on return from leave report the fact to the Deputy Superintendent, who shall forthwith record his arrival in his report book.

(5) The Deputy Superintendent shall similarly record in his report book, all leave granted by the Superintendent and all reports made of return from leave.

(6) Fifteen (15) days recreation leave shall be granted to every employee of Department once in a calendar year on rotation basis.

1083. Absence caused by illness or other unavoidable cause.---
Whenever any subordinate officer is at any time prevented by sudden illness or other unavoidable cause, from attending the prison or performing his duties he shall forth-with give notice to the Superintendent along with his reasons for absence. The Superintendent shall then make suitable arrangements for the due performance of his duties.

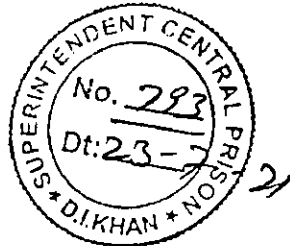

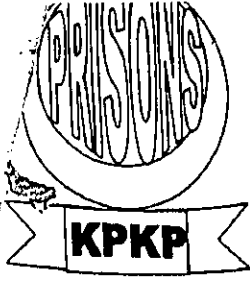

The said Ex-warder appeared for personal hearing on fixed date i.e 04.06.2021 however he could not produce satisfactory reply.

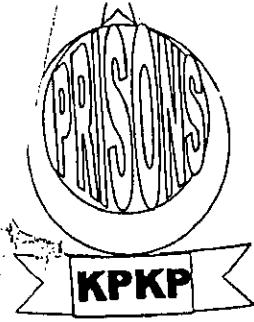
Keeping in view his previous record, unsatisfactory reply and least interest in his duties the said ex-warder was awarded major penalty of compulsory retirement from service.



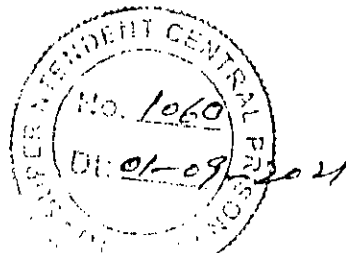
