



Prayer:

That on acceptance of the appeal, proforma promotion for the post of Instructor (BPS-17) Cooperative Training College and then for the post of Principal Cooperative Training College (BPS-18) or Deputy Registrar Technical (BPS-18) may graciously be granted to the appellant with due date of time, with all back benefits.

Respectfully Sheweth:**ON FACTS:**

1. That on 28th October 1984, the appellant was initially appointed as Senior Auditor (BPS-11) in the office of the Accountant General Pakistan Revenue (Sub-Office) Peshawar. He worked there, till After-noon of 25/04/1989. (Annexure "I").
2. That thereafter, on recommendation of the NWFP (Khyber Pakhtunkhwa) Public Services Commission, the appellant joined the Cooperative Department, as Assistant Registrar (BPS-16) on 26/04/1989 (Fore Noon). (Annexure "II").

3. That for 31-years period, the appellant worked in the same scale of BPS-16. However, with effect from 07/05/2020, the post of Assistant Registrar Cooperative Societies, was upgraded to BPS-17 and as a result, the scale of the appellant was also upgraded from BPS-16 to BPS-17. (Annexure "III").
4. That in addition to his own duties, the appellant worked as Deputy Registrar Technical (BPS-18) and Deputy Register Admn; (BPS-18) simultaneously, for the period mentioned against each.

5. That the following posts were/ are lying vacant in the department from the dates given against each

4	Principal Cooperative Training College (BPS-18)	06/09/2022

And, that the appellant was fully entitled for promotion to the said post of Instructor and then to the post of Principal or Deputy Registrar (Technical) on seniority cum fitness basis. But, due to non-issuance of final seniority list of Assistant Registrars by the Administrative Department (Respondent No. 4) the promotion case of the appellant was not processed in time and as a result, he was kept deprived from his due right of promotion. Seniority List of Assistant Registrars and Notified Service Rules of the office of the Registrar Cooperative Societies, are attached as annexure "VI" & "VII".

6. That on attaining the age of superannuation, the appellant was retired from Government Service on 09/04/2023, without any promotion, throughout his service 38 years period. (Copy of the retirement order is attached as Annexure "VIII" and no PSB recommendation is made throughout service carrier.
7. That for granting proforma promotion, the appellant filed 02-appeals dated 3rd and 6th April 2023, before

the Secretary, Livestock, Fisheries and Cooperative Department, but in vain. (Annexure "IX" & "X").


8. That the Final Seniority List of Instructor is issued in which the appellant is Senior to one Waseem Ullah, due to his prematuration to BPS-18.

GROUND:


- A. That the appellant was not treated by the respondents, fairly and in accordance with the law.
- B. That besides the above, service structure of the Cooperative Department is also weak and the appellant got no promotion, throughout his service career.
- C. That despite lapse of more than ample time, the respondents did not pay heed to the appeals of the appellant and thus he was compelled to file the instant appeal before this Hon'ble Tribunal.
- D. That the illegal acts of the respondents, are against the canon of law and natural justice.

- E. That valuable rights of the appellant are involved in the case, hence the appeal deserves to be accepted and decided on merits.
- F. That the appellant never ever remained disobedient to the respondents, in his entire service and that there is no single adverse remarks or bad entry in his service record as unblemish.
- G. That further grounds will be agitated at the time of arguments with kind permission of this Hon'ble Tribunal.

It is, therefore, humbly prayed that Appeal of the appellant may kindly be accepted and the respondents may be directed to grant proforma promotion to the appellant, as prayed for with effect from due date of time. Besides, any other suitable remedy which the Hon'ble Court deems appropriate may also be granted in larger interest of the justice, please.




1. That the above tiled Service Appeal is being filed before this Hon'ble Tribunal in which no date of hearing has yet been fixed.
