And, that the appellant was fully entitled for promotion to the said post of Instructor and then to the post of Principal or Deputy Registrar (Technical) on seniority cum fitness basis. - 7. That for granting proforma promotion, the appellant filed 02-appeals dated 3rd and 6th April 2023, before

the Secretary, Livestock, Fisheries and Cooperative Department, but in vain. (Annexure "IX" & "X").

8. That the Final Seniority List of Instructor is issued in which the appellant is Senior to one Waseem Ullah, due to his prematuration to BPS-18.

GROUNDS:

- A. That the appellant was not treated by the respondents, fairly and in accordance with the law.
- B. That besides the above, service structure of the Cooperative Department is also weak and the appellant got no promotion, throughout his service career.
- C. That despite lapse of more than ample time, the respondents did not pay head to the appeals of the appellant and thus he was compelled to file the instant appeal before this Hon'ble Tribunal.
- D. That the illegal acts of the respondents, are against the canon of law and natural justice.

E. That valuable rights of the appellant are involved in the case, hence the appeal deserves to be accepted and decided on merits.

F. That the appellant never ever remained disobedient to the respondents, in his entire service and that there is no single adverse remarks or bad entry in

his service record as unblemish.


