1. That the appellant has no cause of action or locus standi to file the instant service appeal and is also estopped by his own conduct to file the instant service appeal in this Hon'ble Tribunal.
2. The appellant has not come to the court with clean hands. The appeal is frivolous and baseless with malafide intentions to block the process of promotion of Class-IV.
3. That the appeal in hand is bad for non-joinder and mis-joinder of necessary parties.
4. That the appellant has concealed material facts from this honorable court and hence the Service Appeal is not maintainable on this score alone.
5. That the petition is badly time barred.

FACTS.

1. It is correct with further clarification that the appellant was appointed as Sweeper on 30-04-2019.
2. It is correct with further clarification that as per old Service Rules-2017 of Directorate of Youth Affairs his name was not included in the seniority list because for promotion to the post of Junior Clerk BPS-11 only Naib Qasid, Chowkidar and Mali BPS-03 having FA/F.Sc certificate were eligible. The same is re reproduced for ready reference:-

“Twenty-five percent by promotion, on the basis of seniority-cum-fitness, from amongst Naib Qasids / Chowkidars / Malies in the Directorate of Youth Affairs with at least two years’ service as such, who have passed F.A / F.Sc Examination.

Note:- Provided that where no official is available for promotion the vacancy may be filled in by initial recruitment.(Annexure-A)

Some of the Sweepers filed Service Appeal No.35332021 and 3524/2021 titles Yasir Khan and Jamil Sweeper of Directorate of Youth Affairs in the Service Tribunal Khyber Pakhtunkhwa under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act. 1974 for striking down the Service Rules 2017 to the extent of Junior Clerk BPS-11 by not including the Sweeper BPS-03 for promotion. Later

on they requested for withdrawal of the appeals. **(Copy attached as Annexure-B)**
The department proposed certain amendments in the Service Rules, 2017 and after series of meetings of SSRC comprising of **Administrative Secretary of the Department, Additional Secretary (Regulation) E&A Department, Additional Secretary (Regulation) Finance Department, Additional Secretary Law Department, Director Youth Affairs Department** have been held and discussed the same in detail and approved the Service Rules. In the amended Service rules 2022, method of promotion for the post of Junior Clerk is as under: -

- (a) *Forty (40%) percent by promotion, on the basis of seniority-cum-fitness, from amongst holders of the posts of Naib Qasid, Chowkidar, Mali, Sweeper, Cook, Generator Operator, Security Guard, Waiter, Tubewell Operator, Dispatch Rider, Electrician, Daftari cum Duplicate Machine Operator and other equivalent posts possessing F. A/F.Sc qualification or its equivalent qualification from a recognized Board with two (2) years service as such; and*
- (b) *sixty percent by initial recruitment:*

Note: *A joint seniority list of the holders of the posts of Naib Qasid, Chowkidar, Mali, Sweeper, Cook, Generator Operator, Security Guard, Waiter, Tubewell Operator, Dispatch Rider, Electrician, Daftari cum Duplicate Machine Operator shall be maintained for the purpose of promotion with reference to the dates of appointment or acquiring the F.A/F.Sc qualification, whichever is later:*

Provided that-

- (i) *If two or more officials have acquired the F.A/F.Sc qualification in the same session, the inter-se-seniority in the lower post shall be maintained for the purpose of determining seniority in the higher post; and*
- (ii) *where a senior official does not possess the requisite qualification at the time of filling up a vacancy, the official next junior to him possessing the requisite qualification shall be promoted in preference to the senior official or officials:*

Provided further that the condition of F.A/F.Sc or its equivalent qualification from a recognized Board, as laid down at clause (a) shall not apply till the expiration of the period specified in the second proviso of Column No. 5 against Serial No. 4 of the Establishment Department's amendment Notification No. SOE-IV(E&AD)/1-35/2014, dated: 18.07.2019 to the existing matriculate incumbents of the posts of Naib Qasid, Chowkidar, Mali, Sweepers Cook, Generator Operators, Security Guards, Waiters, Tubewell Operators, Dispatch Riders, Electricians, Daftaris cum Duplicate Machine Operators including holders of the equivalent posts for promotion to the post of Junior Clerk (BPS-11). (Annexure-C)

- 3. It is correct with further clarification that in the Notification No. SOE-IV(E&AD)/1-35/2014 dated 18.07.2019 the Matriculate Class-IV were exempted from the condition of FA or equivalent qualification for promotion to the post of Junior Clerk BPS-11 for a period of 04 years which is now expired on 19-7-2023. **(Annexure-D)**

4. Tentative Seniority was circulated amongst the incumbents with the direction to check the Provisional Seniority and if there is any objection, the aggrieved person should route an appeal supported by documentary proof within 30 days of the issuance of the seniority list. It is pertinent to mention that the appellant does not object on the provisional seniority list.
5. It is incorrect. The applicant was rightly placed at Sr. No.76. In the provisional seniority list the appellant was at Sr.No.36 which was incorrect, and it was accordingly corrected in the final seniority list in accordance with the Service Rules, 2022 of the Directorate of Youth Affairs Khyber Pakhtunkhwa.
6. It is incorrect. The Provisional Seniority list was circulated amongst the incumbents vide letter No. DYA/ADMN/Seniority/2022/1913 dated 10-03-2022. **(Annexure-E)** The aggrieved incumbents filed objections on the seniority which were considered accordingly. **(Annexure-F)** It is pertinent to mention here that the appellant does not file any objection on the provisional seniority list.
7. It is incorrect. The appellant did not file any objection on the provisional Seniority list. The Provisional Seniority List was issued vide letter No. DYA/ADMN/Seniority/2022/1913 dated 10-03-2022 and the final Seniority list was issued on 13.04.2022. **(Annexure-G)**
8. It is incorrect. All the promotions done by the department are in accordance with the prevailing rules and regulations.
9. As explained in the preceding para.

GROUND.


- A. Incorrect, misleading, the final seniority list has been issued by the competent authority after fulfilling all codal formalities in the best public interest. The plea of the appellant is not based on facts, it is the lame excuse to term such lawful order as an law full order.
- B. It is incorrect in view of the reply given in the preceding paras.
- C. It is incorrect. The appellants have been treated in accordance with the prevailing rules and regulations and no fundamental rights of the appellant have been violated.
- D. It is incorrect. The appellants have been treated in accordance with the prevailing rules and regulations.
- E. It is incorrect in view of the reply given in the preceding paras.
- F. Incorrect as explained in preceding paras on facts supra. The appellants have been treated in accordance with the prevailing rules and regulations. The plea of the appellant is not based on facts, it is the lame excuse to term such lawful

order as un law full order. It is further stated that the appellant is matriculate and, in the Notification, No. SOE-IV(E&AD)/1-35/2014 dated 18.07.2019 the Matriculate Class-IV were exempted from the condition of FA or equivalent qualification for promotion to the post of Junior Clerk BPS-11 for a period of 04 years which is now expired on 19-7-2023. After expiry his name will be excluded from the seniority list being not eligible for promotion to the post of Junior Clerk BPS-11.

- G. It is incorrect in view of the reply given in the preceding paras.
- H. It is incorrect in view of the reply given in the preceding paras.
- I. The respondents may also assist this honorable court with additional grounds at the time of argument.

In view of the above the instant appeal is not maintainable and without any merit, therefore, the appellant does not deserve any relief as prayed for in this appeal. The instant appeal may be dismissed in the public interest.
