APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE INACTION OF THE RESPONDENTS BY NOT ISSUING/PREPARING JOINT AND INTER-SE-SENIORITY LIST OF THE MINISTERIAL STAFF I.E. JUNIOR/SENIOR CLERKS OF THE HEALTH DEPARTMENT AND AGAINST THE UN-NOTIFIED NOTIFICATIONS DATED 29.03.1982 AND 22.06.1983 AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS

PARYER:

That on acceptance of this appeal the respondents may very kindly be directed to issue/prepare joint and inter-se-seniority list of the Ministerial Staff of Health Department and the Un-Notified Notifications dated 29.03.1982 and 22.06.1983 may be declared as illegal, unlawful and void-ab-initio. Any other relief which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

- 1- That appellant is the employee of Health Department and is serving as Junior Clerk (BPS-11) at DHQ Hospital, District Kohat quite efficiently and upto the entire satisfaction of his superiors. Copy of the appointment order is attached as annexure.....A.

- 2- That appellant is the senior most employee of Health Department and is serving against the same post i.e. Junior Clerk from the date of initial appointment and the Department has never granted a single benefit of promotion to the appellant till date.
- 3- That it is pertinent to mention that the Health Department unlawfully divided the Ministerial Staff into two cadres i.e. DG Health Services cadre and sub cadre (Sub Offices) of Health Department and in this respect issued separate seniority lists of the employees i.e. working at the strength of DG Health Office and in Sub Offices of Health Department. Copies of the seniority lists of DG Health Service cadre and Sub Cadre are attached as annexure.....**B, C & D.**
- 4- That the most junior employees who are working in the Directorate of Health Department have availed the benefit of promotions to the post of Senior Clerk and subsequent promotions to the post of Assistant (BPS-16) while the appellant and all those employees who are working in the Sub Offices/Hospitals are still working against the post of Junior Clerk (BPS-11). Copies of the promotion orders are attached as annexure.....**E & F.**
- 5- That it is also worth mentioning here that the authority concerned illegally and without any lawful authority divided the single cadre of Ministerial Staff into two cadres i.e. DG Health Services Cadre and Sub Cadre only to accommodate those employees who are working on the disposal of Directorate and this illegal and unlawful act which continuously affect the future services of the appellant.
- 6- That in this regard the appellant and his other colleagues preferred several applications/objections to the higher authorities for issuance/preparing joint and inter-se-seniority lists which were properly sent to the Worthy Director General Health Service Department, Khyber Pakhtunkhwa, Peshawar alongwith covering letters for preparing a draft of new service rules as well as joint and inter-se-seniority list of the Ministerial Staff of Health Department on the analogy of Elementary & Secondary Education Department and Higher Education Department but the respondent No.4 totally ignored the same. Copies of the correspondence are attached as annexure.....**G.**
- 7- That the respondent No.3 issued clear instructions to the respondent No.4 i.e. DG Health Services Department through letters dated 06.03.2023, 20.03.2023 and 24.03.2023 regarding submission of joint and inter-se-seniority list of the Director General Service cadre and sub cadre but in vain. Copies of the letters are attached as annexure.....**H, I & J.**

- 8- That the above mentioned cadres have been divided on the basis of un-notified notifications dated 29.03.1982 and 22.06.1983 which are not tenable in the eye of law and rules and as such the same are void-ab-initio. That even the separate seniority lists are issued without the support of any law, and even the un-notified Notifications and law under which the Supra notifications are allegedly issued, has also been repealed. Copy of the service rules alongwith Notifications dated 29.03.1982 and 22.06.1983 are attached as annexure.....K.
- 9- That the appellant feeling aggrieved from the action and inaction of the respondent No.4 by issuing separate seniority lists of the above mentioned cadres and not issuing joint and inter-se-seniority list preferred departmental appeals but no reply has been received so far from the quarter concerned. Copy of the departmental appeal is attached as annexure.....L.
- 10- That the appellant feeling aggrieved and having no other remedy but to file the instant writ petition on the following grounds amongst the others.

GROUND:

- A- That the action and inaction of the respondent Department by issuing separate seniority lists and not preparing/issuing joint and inter-se-seniority list of the Ministerial Staff of Health Department i.e. DG Health Services cadre and Sub cadre (Sub Offices) is against the law, facts, norms of natural justice and materials on the record.
- B- That the appellant has not been treated by the respondent No.4 in accordance with law and rules on the subject noted above and as such the respondents violated Article-4, 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the respondent No.4 acted in arbitrary and malafide manner by not preparing joint and inter-se-seniority list of the Ministerial Staff i.e. Junior/Senior Clerks working in DG Health Service cadre and Sub-Cadre (Sub Offices) which is not tenable in the eye of law and rules.
- D- That being a provincial and a single separate seniority lists are illegal, unlawful and unjustifiable, hence the respondent department is duty bound to be issued a joint and inter-se-seniority list of the Ministerial staff.
- E- That the Ministerial staff divided into two cadres is illegal, unlawful, unconstitutional and ineffective upon the rights of appellant, therefore, the same is not tenable in the eye of law and liable to be merged in single cadre by preparing joint and inter-se-seniority lists.

F- That the separate seniority lists of DG Health Services cadre and Sub cadre (sub Offices) of Health Department continuously affecting the promotions of the employees working in the sub offices, while the same is only beneficial for the employees working in the Directorate.

G- That separate seniority lists for the cadres of DG Health Services cadre and Sub Cadre (Sub Offices) of Health Department only beneficial for the employees working in the Directorate of Health Department while the same is in-effective upon the rights of sub-cadre.

H- That the separate seniority list for a single cadre is clear violation of Section-8 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Rule-17 of the Civil Servants Appointment, Promotion and Transfer Rules, 1989.

I- That the separate seniority lists are issuing on the basis of Notifications dated 29.03.1982 and 22.06.1983 are illegal, unlawful and without lawful authority and the same are un-notified, therefore, the same are void-ab-initio and liable to be struck down.

J- That the appellant seeks permission to advance other grounds and proofs at time of hearing.

It is, therefore, most humbly prayed that the appeal of the may be accepted as prayed for.

DEPARTMENTAL APPEAL FOR PREPARING/ISSUING JOINT AND INTER-SE-SENIORITY LIST OF MINISTERIAL STAFF I.E. JUNIOR CLERKS & SENIOR CLERKS IN HEALTH DEPARTMENT AND FOR GRANTING OF ANTE DATED PROMOTIONS TO THE NEXT HIGHER SCALE ON SENIORITY BASIS AS PER LAW AND RULES AND FOR DECLARING THE UN-SINGED NOTIFICATIONS/RULES AS ILLEGAL, WITHOUT LAWFUL AUTHORITY AND INEFFECTIVE UPON THE RIGHTS OF THE APPELLANT

Respected Sir,

With great reverence it is stated that the appellant is the employee of your good self department and is working as junior clerk at DHQ Hospital, Kohat quite efficiently and upto the entire satisfaction of his superiors.

That the appellant is the senior most employee of Health Department and is serving against the same post i.e. Junior Clerk from the date of initial appointment and the Department has never granted any benefit of promotion to the appellant till date.

That it is pertinent to mention here that the Department unlawfully divided the Ministerial Staff into two cadres i.e. DG Health Services cadre and sub cadre (Sub Offices) of Health Department. That it is also pertinent to mention here that the department prepared separate seniority lists of both the employees i.e. working at the strength of Directorate General of Health Department and of those employees who are working in Sub Offices of Health Department.

That those employees who are working in the Directorate of Health Department having the chances of promotions to the next higher scale i.e. from the post of junior clerk to senior clerk, office assistant and Superintendent (BPS-17) on the basis of separate seniority list and as such the junior most employees to the appellant have availed the benefit of promotions to the post of Senior Clerk and subsequent promotions to the posts of Assistant (BPS-16) and Superintendent (BPS-17) while the appellant and all those employees who are working in the Sub Offices/Hospitals are still working against the post of Junior Clerks which is clear violation of the Fundamental rights of the appellant and other employees.

That in this regard the appellant and his other colleagues preferred several applications/objections to the high ups regarding separate seniority lists whereas proper covering letters have been circulated to your good self for preparing a draft regarding joint and inter-se-seniority list on the analogy of Elementary & Secondary Education Department and Higher Education Department but no satisfactory reply has been received so far.

That the cadre of Ministerial staff divided into two parts by DG Health Services cadre and Sub cadre (Sub Offices) of Health Department is unjustified, unlawful, unconstitutional and ineffective upon the rights of appellant and other employees working in the sub offices throughout Khyber Pakhtunkhwa. That the separate seniority lists of DG Health Services cadre and Sub cadre (sub Offices) of Health Department

continuously affecting the promotions of the employees working in the sub offices, while the same is only beneficial for the employees working in the Directorate.

That the above mentioned cadres have been divided on the basis of un-notified notifications which are not tenable in the eye of law and rules. That even the separate seniority lists are issued without the support of any law, and even the un-notified Notifications and law under which the Supra notifications are allegedly issued, has also been repealed.

That separate seniority lists for the cadres of DG Health Services cadre and Sub Cadre (Sub Offices) of Health Department only beneficial for the employees working in the Directorate of Health Department while the same is in-effective upon the rights of employees of sub-cadre (Sub Offices).

That the separate seniority lists for a single cadre is clear violation of Section-8 of the Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Rule-17 of the Civil Servants Appointment, Promotion and Transfer Rules, 1989.


That the Health Department is bound to reduce disparity amongst the employees and issued/circulated joint and inter-se-seniority of the Ministerial Staff as per analogy of Elementary and Secondary Education Department and Higher Education Department, Khyber Pakhtunkhwa.

That by not issuing/circulating joint and inter-se-seniority list of the Ministerial Staff continuously affecting the promotions of the Sub Cadre which is clear violation of Article-38(e) of the Constitution of Islamic Republic of Pakistan, 1973.

It is, therefore, most humbly prayed that on acceptance of this departmental appeal the joint and inter-se-seniority list of the Ministerial Staff i.e. Junior Clerks/Senior Clerks of Health Department may very kindly be prepared and as such ante dated promotion to the next higher scale may also be granted to the appellant as per seniority position in the joint and inter-se-seniority list and as such declare the illegal promotions granted on the basis of separate seniority lists as null and void as well as declare the unsigned Notifications/rules as illegal, unlawful and ineffective upon the rights of the appellant. Any other relief which your good self deems appropriate may also be granted in favor of the appellant.




