



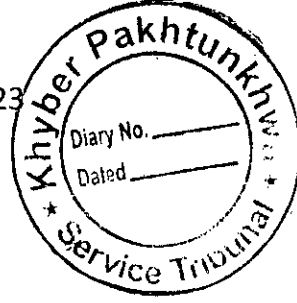

In compliance to order sheet, Service Tribunal camp Court Abbottabad Dated 21.02.2023 (Copy attached) and In supersession of this office letter No.3916-21 dated 26.09.2022 and letter No.7942-47 dated 14.02.2023 on the above cited subject, wherein the undersigned has been directed to arrange and pay the back benefits to Mst.Safia Bibi and come up on 29.03.2023 before S.B at Camp Court Abbottabad.

It is pertinent to mention, that Mst.Safia Bibi was re-Instated in to her service with all back benefits vide judgment of Honourable Service Tribunal dated 17.11.2021. in service appeal No.916/2018. Consequently she was re-Instated, posted and getting regular salary since the date of re-Instatment. However her back benefits amounting to Rs.2033720/- has not yet been paid, being beyond the powers and competency of DHO.

Now to avoid further legal complication and Contempt Of Court you are requested to approach the concerned department for sanction of special grant budget to comply with the orders of Honourable Service Tribunal judgment/Order.

Moreover the deopertment has filed CPLA in the Supreme Court Of Pakistan against the said judgment.
