Respectfully sheweth:

PRELIMINARY OBJECTION:

1. That the appellant has got no cause of action.

- 2. The appellant has not come with clean hand and concealed material facts from this Honorable Tribunal.
- 3. The appellant of appeal is bad in eye of law being infructuous.
- 4. The appellant raised frivolous and illegal demand in the instant appeal.
- 5. That the appellant is estopped by his own conduct to file this appeal.
- 6. That no vested rights or accrued rights of the appellant have been infringed to warrant interference.
- 7. That this appeal is neither competent nor maintainable under the prevailing Rules and Regulation.

REPLY ON FACTS:

1) Incorrect, The Government of Khyber Pakhtunkhwa, Finance Department Advertised (63) posts of Auditor BPS-14 in the Directorate of local Fund Audit Khyber Pakhtunkhwa, through Khyber Pakhtunkhwa Public Services Commission vide Advertisement No.03/2018 serial Number 48,49,50,51. dated 09/02/2018,detail as below,

- 48). (49) posts were filled on General Quota.
- 49). (9) Posts were filled in Female Quota.
- 50). (04) post were filled in Minority Quota.
- 51). (01) post had filled in Disable Quota.
- 2) The Para relates to Khyber Pakhtunkhwa Public Service Commission record.
- 3) The Para relates to Khyber Pakhtunkhwa Public Service Commission record.
- 4) On the recommendation of Khyber Pakhtunkhwa public services commission, the Directorate of Local fund Audit Khyber Pakhtunkhwa Peshawar, issued order of appointment of "Female Quota." vides No:LFA/Estt:/Recruitment /2019/2218-31.dated 09-10-2019, "Minority Quota" vide No:LFA/Estt:/ Recruitment /2019/2232-40. dated 09-10-2019 and "Disable Quota" vide No:LFA/Estt:/ Recruitment /2019/2241-46 dated 09-10-2019. (Copies Enclosed as Annex-A, B, C)
- 5) The Para relates to Khyber Pakhtunkhwa Public Service Commission record.
- 6) No Comments.
- 7) Incorrect, In pursuance of sub-section (i) section 8 of the Khyber Pakhtunkhwa civil servants act, 1973(Khyber Pakhtunkhwa) act no. xviii of 1973). The directorate of local fund audit Khyber Pakhtunkhwa Peshawar, issued seniority list of all auditors BPS-14/15 as stood on 31-12-2019 except newly recruited Auditors of General Quota, vide Advertisement No.03/2018 serial Number 48. which was under process at the Khyber

- Pakhtunkhwa Public Service Commission and recommendations were issued as on 22-01-2020 (Copy of Recommendation Enclosed as Annex-D)
- 8) Incorrect, the Inter-se-seniority list of all (63) Auditors BPS-14 was not yet provided due to non-acceptance of offer by some Candidates, and the Commission recommended next Candidates from the waiting list which delayed the process of communicating the Inter-se-Seniority by the Khyber Pakhtunkhwa Public Services Commission. That's why The Directorate of Local fund Audit issued Seniority List of 2020 of Auditor BPS-14/15 on the basis of Chronological recommendation i.e Female Quota, Minority Quota, Disable Quota and General Quota. (Copies of Seniority List Enclosed as Annex-E)
- 9) Incorrect, The Directorate of local fund Audit, requested finance department vide letter No.LFA/Estt:/Recruitment/2020/ 1695-96 dated 26/10/2021 to approach to Khyber Pakhtunkhwa public services commission to provide inter-se-seniority/merit list of all quotas (i.e General, female, Minority and Disable) of newly Recruited 63 Auditors BPS-14 through Khyber Pakhtunkhwa Public Service Commission vide Advertisement No.03/2018 (Letter copy Enclosed as Annex-F).as per KPPSC Regulation, Para 34.Sub Para "C" which states that "At the time of advertisement, separate serial numbers/sub-serial number shall be given to each subject. Subject-wise recommendations alongwith inter-se-seniority shall also be conveyed to the department" (Copy Of Kp-Psc Regulations 2017 Amended Upto 30-05-2022, Enclosed as Annex-G). The finance department forward the letter to the Public service Commission vide letter No:SO(ESTT-II)FD/3-14/2013/LFA dated 29-10-2021 (Copy of letter Enclosed as Annex-H). The Respondent-1 received reply from Respondent -2 vide letter No:SO(ESTT-II)FD/1-45/2021 dated 17-01-2022 which was communicated by the Khyber Pakhtunkhwa Public Service Commission along with inter-se-seniority/Merit List of (63) selectees(Auditor BPS-14) (Copies Enclosed as Annex-I). Based on inter-seseniority/Merit List of (63) selectees(Auditor BPS-14) the Directorate of Local Fund Audit issued rectified Seniority List of All. Auditors BPS-14/15 stood on 31-12-2021(Copies of Seniority List Enclosed as Annex-J). Moreover, according to the Khyber Pakhtunkhwa Civil Servant (APPOINTMENT, PROMOTION AND TRANSFER) Rules 1989, wherein under PART VI of SENIORITY, SECTION 17, SUB SECTION "A" which is reproduced as under " In The Case Of Persons Appointed By Initial Recruitment, In Accordance With The Order Of merit Assigned By The Commission. (Copy Enclosed as Annex-K). Moreover According to the Establishment Division, Civil Servant (Seniority Rules 1993), para 2, sub-section 2 wherein it is stated that if two or more persons are recommended by the selection authority, their inter se seniority shall be determined in order of merit assigned by the selection authority. (Copy Enclosed as Annex-L).
- 10) The appellant's application was forwarded to the Finance Department vide No.LFA/Estt:/Recruitment/2020/206, dated 21-01-2022 (Copy Enclosed as Annex-M) for onward submission to the Khyber Pakhtunkhwa Public Service Commission. The Finance Department forwarded the reservation to the Khyber Pakhtunkhwa Public Service Commission vide letter No. SO (ESTT: II)/FD/3-14/201/LFA/Vol-IV dated 31-01-2022 (Copy Enclosed as N) wherein response, The Khyber Pakhtunkhwa Public Service Commission vide it's letter No.PSC/SR-VIII/023984, dated 04-04-2022 (Copy Enclosed as Annex-O) has stated that according to the rule 17(1)(A) (seniority), ESTA Code "The Seniority shall be determined in order of merit assigned by the selection Authority (Copy Already Enclosed as Annex-K). Therefore, the inter-se-merit conveyed by the commission may be considered as final". Moreover, The Finance Department asked advised from Establishment Department KPK vide letter No. SO (ESTT-II)/FD/3-14/2022/Recruitment/LFA, dated 21-06-2022 (Copy Enclosed as Annex-P), wherein response of Establishment Department KPK vide its letter No. SOR-VI/E&AD/Misc: Finance/2022, dated 05-Sept-2022 (Copy Enclosed as Q) was that "the case may be examined in light of Rule-17 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 which is very much clear in this

- regard". This letter received by Respondent No. 1 from Respondent No.2 vide letter No.SO(ESTT-II)/FD/3-14/2022/Rectt:/LFA dated 15-09-2022. (Copy Enclosed as R)
- 11) Incorrect, detailed reply has already been given in the Above Para No. 9 and 10.
- 12) Incorrect, detailed reply has already been given in the Above Para No. 10.
- 13) Incorrect, The Respondent 1 asked for advice again from the Finance Department and in response, the above quoted letter No. SOR-VI/E&AD/Misc: Finance/2022, dated 05-Sept-2022 (Already Annexed as Q) has regretted/refused in accordance with the Civil Servant Rules 1989, KPPSC Regulation wing, Establishment Department Advise and ESTA CODE. Moreover, The Director Local Fund Audit constituted a Committee regarding the observations/objections of Female Quota, Minority Quota & Disable Quota wherein after a brief discussion, the Committee concluded that "After thorough examination of the case, the committee decided that Rule 17 (1)(A) of Part-VI of the Civil Servants (Appointment Promotion, and Transfer Rules,1989)Commission advice dated 04-04-2022 on the subject issue is quite clear. As the Commission conveyed their inter-se-seniority by merit assigned which was accordingly reflected in the seniority list of auditors as stood on 31-12-2022, therefore, the department has no domain to make changes in the order of seniority assigned on merit by the Commission being mandate of Public Service Commission."

The Rule (17)(a) is reproduced as under:

"The Seniority inter -se-seniority of Civil Servants (Appointment to a service, cadre or post) shall be determined in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission or as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; whereas in the case, the appointment has been made through Khyber Pakhtunkhwa Public Service Commission, therefore the inter-se-seniority / Merit Assigned by the Commission is the mandate of Public Service Commission. (Copy Enclosed as Annex-S)

14) Incorrect, The appeal is against the laws/rules & regulations as on the grounds mentioned therein. Moreover, the appellants concealed the facts form the Hon'able Service Tribunal Peshawar as mentioned in the above paras.

GROUND:

Enclosed Annex-G),

- A) Incorrect, the appellants are not entitled towards repeated objections on the Seniority List in accordance with the laws and rules.
- B) Incorrect, the seniority list issued in accordance with the law & rules and no violation has been made since the KPPSC, Finance Department, Establishment Department and Regulation wing advised that the inter-se-seniority issued is in accordance with the rules. Moreover, the Appellants are humiliating the dignity of the Government Departments due to their illegal & unproved allegations.
- C) Incorrect, according to the Khyber Pakhtunkhwa Civil Servant (APPOINTMENT, PROMOTION AND TRANSFER) Rules 1989, wherein under PART VI of SENIORITY, SECTION 17, SUB SECTION "A" which is reproduced as under "In The Case Of Persons Appointed By Initial Recruitment, In Accordance With The Order Of Assigned By The Commission, the appellants are appointed through Khyber Pakhtunkhwa Public Service Commission and not through Departmental Selection Committee wherein a person selected for appointment to a post in an earlier selection shall rank senior to the person selected in a later selection. However, in the instant case, the recruitment was made through Khyber Pakhtunkhwa Public Service Commission having its own rules & Regulations and according to the KP-PSC Regulations 2017 amended up to 30-05-2022, Serial No.34, sub-serial C which is reproduced as under as "At the time of advertisement, separate serial numbers and sub-serial number shall be given to each subject. Subject[serial -wise/sub serial -wise] recommendations alongwith inter-se-seniority shall also be conveyed to the department" (Copy

- D) Incorrect, detail reply has been given in the para No.8 and 9.
- E) Incorrect, the inter-se-seniority was communicated to the Department from the Khyber Pakhtunkhwa Public Service Commission which has the domain to provide the Inter-se-Seniority, hence no violation has been made and seniority list issued is in accordance with the Laws and Rules as mentioned in above detailed paras.
- F) Incorrect, no violation has been made and all the course of action has been made in accordance with the Laws, Rules & Regulations.
- G) Incorrect, detail reply has been given in the paras.
- H) Incorrect, the Khyber Pakhtunkhwa Public Service Commission is an autonomous body and also deals in service matters and working under the Establishment Department KPK having its KP-PSC Rules & Regulations 2017. Moreover, the Khyber Pakhtunkhwa public service commission communicated inter-se-seniority according to it's Rules & Regulations 2017 as mentioned in above paras and also responsible for provision of Merit/Inter-se-seniority in accordance with the Civil Servant Act 1989, Serial No.17 (A). Moreover, the appellant concealed the facts form this Hon'able Service Tribunal that the departmental appeals are filed/rejected by the KP-PSC, but the decisions was made by the Govt. Departments, i.e Finance Department, Establishment Department and committee constituted by the Director, Local Fund Audit in accordance with the Civil Servant Act 1989 Seniority Rules 17 (a) and KP-PSC Regulations 2017 which are very much clear and detailed reply has been given in the above paras.
- I) Incorrect, all course of action has been made in accordance with the Laws, Rules & Regulations and no violation has been made.
- J) That further grounds will be raised at the time of hearing with permission of this Honorable Tribunal.

It is humbly, requested that appeal may please be dismissed being baseless and contradictory to the act/rules/policy of the Government.



MERIT LIST / ZONAL ALLOCATION / RECOMMENDATION

32. MERIT LIST.

- (a) When all the eligible candidates called for interview for particular post have been interviewed, the Director Recruitment, Director Examination or any other authorized officer, as the case may be, shall prepare the merit list as per the marks recorded on the evaluation sheet and submit the case for the Commission's approval.
- (b) Merit list shall be prepared keeping in view the aggregate marks secured by all the qualified candidates.
- (c) When two or more than two candidates have secured equal marks in aggregate the candidate who has secured higher marks in the interview shall be marked senior. In case the marks in aggregate and also the marks in the interview are the same, the candidate who is older in age shall be placed senior to the one who is younger. THE KHYBER PAKHTUNKHWA CIVIL SERVANTS (APPOINTMENT, PROMOTION & TRANSFER) RULES, 1989

PART-I

GENERAL

- 1. Short title and commencement: (1) These rules may be called the ²[Khyber Pakhtunkhwa] Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.
 - (2) They shall come into force at once.
- 2. Definitions:-(1) In these rules, unless the context otherwise requires:-
 - (a) "Appointing Authority" in relation to a post, means the persons authorized under rule 4 to make appointment to that post;
 - (b) "Basic Pay Scale" means the Basic Pay Scale for the time being sanctioned by Government, in which a post or a group of posts is placed;
 - (c) "Commission" means the ³[Khyber Pakhtunkhwa] Public Service Commission;
 - ⁴(d) "Departmental Promotion Committee" mean a committee constituted for making selection for promotion or transfer to such posts under a Department, or offices of Government, which do not fall within the purview of the Provincial Selection Board;
- ⁵(dd)"Departmental Selection Board" means a Board constituted for the purpose of making selection for initial recruitment /appointment to posts under a Department or office of Government in Basic Pay Scale 17 not falling within the purview of the Commission:

Provided that more than one such committees may be constituted for civil servants holding different scales of pay".

- (e) "Departmental Selection Committee" means a committee constituted for the purpose of making selection for initial appointment to posts under a department, or office of Government [in Basic Pay Scale 17 and below not falling within the purview of the Commission];
- (f) "Post" means a post sanctioned in connection with the affairs of the Province, but not allocated to all Pakistan Unified Grades; and

SENIORITY

Seniority:-(1) the seniority inter se of civil servants ⁴⁷ (appointed to a service, cadre or post) shall be determined:-

- in the case of persons appointed by initial recruitment, in accordance with the order (a) of merit assigned by the Commission 48 [or as the case may be, the Departmental Selection Committee: provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
- in the case of civil servants appointed otherwise, with reference to the date of their (b) continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post.

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher post, it would not adversely effect the interest of his seniors in fixation of his seniority in the higher post.

Explanation-II:- If a junior person in a lower post is promoted to a higher post by superseding a senior person and subsequently that senior person is also promoted the person promoted first shall rank senior to the person promoted subsequently; provided that junior person shall not be deemed to have superseded a senior person if the case of the senior person is deferred for the time being for want of certain information or for incomplete record or for any other reason not attributing to his fault or demerit.

Explanation-III:- A junior person shall be deemed to have superseded a senior person only if both the junior and the senior persons were considered for the higher post and the junior person was appointed in preference to the senior person.

- (2) Seniority in various cadres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment.
- ⁴⁹(3) In the event of merger/restructuring of the Departments, Attached Departments or Subordinate Offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.
- The inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servants in the lower post.

Provided that if the date of regular appointment of two or more civil servants in the

CIVIL, SERVANTS (SENIORITY) RULES, 1993.

S.R.O. 163 (I)/93.— In exercise of the powers conferred by section 25 of the Civil Servants Act, 1973 (LXXI of 1973), read with section 8 thereof, the President is pleased to make the following rules, namely:-

- 1. Short title, application and commencement.— (1) These rules may be called the Civil Servants (Seniority) Rules, 1993.
 - (2) They shall apply to all civil Servants except those governed under:-
 - the Police Service of Pakistan (Composition Cadre and Seniority) Rules, 1985;
 - the Occupational Groups and Services (Probation, Training and Seniority) Rules, 1990; and
 - (iii) the Establishment Division's O.M No. 1/2/74-ARC, dated 23rd January, 1974, amended vide O.M No. 2/1/75.ARC dated 3rd March, 1976, and as amended from time to time.
 - (3) They shall come into force at once.
- 2. Seniority on initial appointment.—(1) Persons initially appointed on the recommendations of the selection authority through an earlier open advertisement shall rank senior to those appointed through a subsequent open advertisement.
 - (2) If two or more persons are recommended in open advertisement by the selection authority their inter se seniority shall be determined in order of merit assigned by the selection authority.
 - (3) If only one candidate is recommended in open advertisement by the selection authority, he shall count his seniority from—
 - (a) the date of recommendation by the selection authority, if he was already holding the same on ad hoc basis; and
 - (b) the date of his joining the post after being recommended by the selection authority, if he was not already holding the same post.

- 12. "(Reversion to a lower post etc.—(1) A civil servant appointed to a higher post on ad hoc, temporary or officiating basis shall be table to reversion to his lower post.
- (2) No civil servant shall be dismissed or removed from service or reduced in rank by an authority subordinate to that by which he was appointed.
- (3) No such civil servant as aforesaid shall be dismissed or removed from service, or reduced in rank, until he has been given a reasonable opportunity of showing cause against the action proposed to be taken against him:

Provided that this sub-section shall not apply:-

- Where a civil servant is dismissed or removed from service or reduced in rank on the ground of conduct which has led to his conviction on a criminal charge; or
- (ii) Where the President or any person authorised by him under the rules is satisfied, for reasons to be recorded in writing, that in the interest of the security of Pakistan or any part thereof, it is not expedient to give to that civil servant such an opportunity).

PART-V

PROBATION AND CONFIRMATION

(1) Persons appointed to posts by initial recruitment, promotion or transfer shall be on probation for a period of one year.

- (2) The appointing authority, if considers necessary, may extend the probation period for one year as may be specified at the time of appointment.
- (3) On the successful completion of probation period, the appointing authority shall, by specific order, terminate the probation:

Provided that if no specific order is issued on the expiry of the first year of probation period, the period of probation shall be deemed to have been extended under sub-rule (2):

Provided further that if no specific order is issued on the expiry of the extended period of probation, the period of probation shall be deemed to have been successfully completed.

16. Confirmation:-After satisfactory completion of the probationary period, a civil servant shall be confirmed; provided that he holds a substantive post, provided further that a civil servant shall not be deemed to have satisfactorily completed his period of probation, if he has failed to pass an examination, test or course or has failed to complete successfully a training prescribed within the meaning of sub-section (3) of Section 6 of the North West Frontier Province Civil Servants Act. 1973.

PART-V

SENIORITY

17. Seniority:-(1) the seniority inter se of civil servants 35(appointed to a service, cadre or post) shall be determined:-

- (a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission ⁵⁶ (or as the case may be, the Departmental Selection Committee;) provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection; and
- (b) in the case of civil servants appointed otherwise, with reference to the date of their continuous regular appointment in the post; provided that civil servants selected for promotion to a higher post in one batch shall, on their promotion to the higher post, retain their inter se semicinty as in the lower post.

Explanation-I:- If a junior person in a lower post is promoted to a higher post temporarily in the public interest, even though continuing later permanently in the higher

I am directed to refer to the Subject noted above and to state that Auditors (BS-14) recruited by Khyber Pakhtunkhka Public Service Commission under Female, Minority and Disabled quota's, has submitted an application, stating wherein that their test / interviews were conducted 6/7 months earlier than those appointed under general quota. Accordingly they join the cadre on 10-10-2019 and placed in Final Seniority Lists as stood on 31-12-2019 and placed senior in the Final Seniority Lists as stood on 31-12-2020 to those appointed under general quota in later selection and who joined service on 01-06-2020 (copies enclosed) However, in the Tentative Seniority List as stood on 31-12-2021 (copy enclosed) issued by Directorate on the basis of inter-se-seniority provided by the Public Service Commission (copy enclosed), with considerable changes. The observations of the Auditors on the Tentative Seniority lists were forwarded to the Commission for comments, who informed that the rules quoted in the application relates to promotion and stated that inter-se-seniority forwarded by them is covered under Rule 17(a) of the Seniority Rules, 1993 and advised that the inter-se-seniority provided by the Commission is correct and may be considered as final (copy enclosed).

Now the applicants have raised another observation stating that the inter-se-seniority issued by the Commission is itself against the rules quoted by them (copy enclosed). The main contention of the applicants is that when they join the cadre on 10-10-2019 i.e. 7/8 months earlier and placed in Final Seniority Lists as stood on 31-12-2019 and 31-12-2020 then how they are placed junior in the Tentative Seniority List as stood on 31-12-2021 to those who joined the cadre on 01-06-2020.

Keeping in view of the above, advice of Establishment Department to the above observation is solicited, please.

MINUTES OF THE MEETING HELD ON 06-02-2023

UBJECT:

OBSERVATIONS / OBJECTIONS ON TENTATIVE SENIORITY LISTS STOOD ON 31-12-2022

A meeting of the committee constituted on the subject above was held on 06-02-2023 under the Chairmanship of Mr. Fida Hussain Deputy Director in the Directorate of Local Fund Audit Khyber Pakhtunkhwa, Peshawar to discuss the subject issue. The following attended the meeting.

- 4. Mr. M. Jabir Ahmad, Auditor (E&A)

The Chairman welcomed the participants and invited Mr. M. Jabir Ahmad Auditor (E&A) to brief the participants about the subject cases. He briefed the participants that the following objections were raised on the seniority lists of Junior Clerks and Auditors respectively.

OBSERVATION / OBJECTION OF MR. MUSADDIO ZIKRIA ON TENTATIVE I. SENIORITY LIST OF JUNIOR CLERKS AS STOOD ON 31-12-2022

Two posts of Junior Clerks became vacant and each required to be filled through promotion and initial appointment respectively as per service rules of Local Fund Audit Department. Mr. Sahibzada Arshad Mchmood (Daftari) was promoted to the post of junior clerk under 20% quota reserved for promotion whereas Mr. Musaddiq Zikria son of Zikria Nooh was appointed as Junior Clerk under 80% quota reserved for initial appointment; He was appointed under retired employee's son quota on medical ground on request as his father Mr. Zikria Nooh Ex-Senior Scale Stenographer was retired on medical grounds on 20-01-2020.

Mr. Musadiq Zikria raised objection on the seniority list of junior clerks and requested that he may be placed senior from Mr. Sahibzada Arshad Malimood on the plea that he has been appointed against the post vacated by Mr. Sarjan Dass Junior Glerk whereas Mr. Sahibzada Arshad Mahmood was promoted against the post vacated by Mr. Alif Ali Junior Clerk who is junior to Mr. Sarjan Dass.

Decision

After thorough examination of the case the committee decided that the request of Mr. Musaddig Zakria cannot be acceded to in light of rules a produced below and hence found the seniority list in order.

Local Fund Audit Department,

Rule=17-(2)-of-PareVI-8[Rules, 1989)

"Scalarity in various endres of civil servants appointed by initial recruitment vis-à-vis those appointed otherwise shall be determined with reference to the dates of their regular appointment to a post in that cadre; provided that if two dates are the same, the person appointed otherwise shall rank senior to the person appointed by initial recruitment."

Rule 17 (4) "The inter-se-seniority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment/promotion of the civil servants in the lower post. Provided that if the date of regular appointment of two or more civil servants in the lower post is the same, the civil servant older in age, shall be treated senior."

OBSERVATION / OBJECTIONS ON TENTATIVE SENIORITY LIST OF AUDITORS (BS-14-15) AS STOOD ON 31-12-2022

Sixty Three (63) posts of Auditors were advertised by the Khyber Pakhtunkhwa Public Service Commission vide Advertisement NO.03-/2018 (Scrial No. 48, 49, 50, 51) dated 09-02-2018 under quota reserved for Merit, Women, Minority and Disable Persons. The Commission communicated recommendations in piece meal to the Department and appointment orders were issued accordingly. Consequently the appointees gradually submitted their arrival reports for duty on receiving appointment orders.

On issuance of seniority list of auditors as stood on 31-12-2022, some of the auditors raised objections that they have been recommended earlier but placed junior in the seniority list from those recommended later. They plead that they also submit their arrival reports well before to those who were recommended later.

Department forwarded their request to Khyber Pakhtunkhwa Public Service Commission through Finance Department for advice. The Commission conveyed inter-se-merit of all the 63 Auditors to be considered as final.

After thorough examination of the case, the committee decided that Rule 17 (1)(a) of Part-VI of the Civil Servants (Appointment, Promotion and Transfer Rules, 1989) and the Khyber Pakhtunkhwa Services Commission advice dated 04-04-2022 on the subject issue is quite clear. As the Commission conveyed their inter-se-seniority by merit assigned which was accordingly reflected in the seniority list of auditors as stood on 31-12-2022, therefore, the department has no domain to make changes in the order of seniority assigned on merit by the Commission being mandate of the Public Service Commission.

Rule 17 (1) (a) "The seniority inter se of civil servants (appointed to a service, cadre or post) shall be determined in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission or as the case may be, the Departmental Selection Committee; provided that persons selected for appointment to post in an earlier selection shall rank senior to the persons selected in a later selection;

The meeting ended with the vote of thanks.
