VIDE WHICH THE RESPONDENTS HAVE PLACED THE
COMPUTER OPERATORS IN 5% QUOTA ALREADY
RESERVED FOR THE ASSISTANTS AND SENIOR SCALE
STENOGRAPHER FOR PROMOTION TO THE POST OF
TEHSILDAR AND SUBSEQUENTLY THE
DEPARTMENTAL APPEAL OF THE APPELLANT WAS
REGRETTED BY HIGHLY NON-SPEAKING ORDER,
MAY KINDLY BE DECLARED AS ILLEGAL, WITHOUT
JURISDICTIOIN AND WITHOUT LAWFUL AUTHORITY.

PRAYER:

It is therefore most humbly prayed that on acceptance of this appeal, the arbitrary and unwarranted act of respondents by placing the computer operators in 5% Quota already reserved for the Assistants and Senior Scale Stenographer for promotion to the post of Tehsildar, may kindly be declared as null and void being against the law and facts.

Respectfully Sheweth:

1. That appellant being a civil servant and chosen representative, work for the welfare of servants, designated as Deputy Secretary General of the Employees Welfare Association, Board of Revenue thus, serving the province by functioning different positions.

- 2. That initially in terms of Notification dated 04-02-2009, Post of Tehsildar has been filled through 3 different methods wherein, in light of S. No 01, Column No.07 and Clause (c), 20% Quota was allocated to Assistants and Senior Scale Stenographers of Board of Revenue and Director Land Records. (Copy of Notification dated 04-02-2009 is attached as Annex-A)
- 3. That thereafter, Serial No. 01 of Column No.07 of the said Notification was further amended on dated 30-03-2011 vide which, in that very 20% Quota of Assistants, Senior Scale Stenographers of Board of Revenue, Director Land Records, Senior Scale Stenographer of the offices of Commissioners, Additional Commissioners, Political Agents and Sub-Registrar has also been included for promotion to Tehsildar. (Copy of Notification dated 30-03-2011 is attached as Annex-B)
- 4. That thereafter, Serial No 1 of Column No.7 was again amended on dated 30-06-2016 wherein, with addition to Clause C, Clause D has been inserted and 20% Quota was sub-divided, vide which, 16% Quota was allocated to the Assistants and Senior Scale Stenographers of the offices of Commissioners, Deputy Commissioners, Political Agents and Sub-Registrar while remaining 04% Quota was allocated to the Assistants, Senior Scale Stenographers of Board of Revenue for promotion to Tehsildar. (Copy of Notification dated 30-06-2016 is attached as Annex-C)
- 5. That thereafter, Serial No. 01 of Column No.07 was again amended on dated 13-05-2019 vide which, 15% Quota was allocated to the Assistants and Senior Scale Stenographers of the offices of Commissioners, Deputy Commissioners while remaining 05% Quota was allocated to the Assistants, Senior Scale Stenographers of Board of Revenue and Director Land Records for promotion to Tehsildar by maintaining Joint Seniority List.

(Copy of Notification dated 13-05-2019 is attached as Annex-D)

6. That thereafter, Serial No. 01 of Column No.07 was again amended on dated 30-05-2023 vide which, <u>Computer Operators</u> have been included in 05% Quota already allocated to the Assistants, Senior Scale Stenographers of Board of Revenue and Director Land Records for promotion leading to Tehsildar, which is arbitrary and unwarranted.

(Copy of Notification dated 30-05-2023 is attached as Annex-E)

7. That Feeling aggrieved, appellant being a representative of civil servants, designated as Deputy Secretary General of Employees Welfare Association, Board of Revenue, filed Departmental Appeal / Representation against the Amended Notification dated 30-05-2023 before the competent Authority within prescribed period but the same was regretted vide order dated 19-07-2023 by the Non-Speaking Order which is also against the Section 24-A of the General Clauses Act 1956.

(Copy of Departmental Appeal and Order dated 19-07-2023 is attached as **Annex-F**)

8. That now, appellant have been left with no adequate remedy and have no other option but to file the instant service appeal on the following grounds:

GROUNDS:

A. That Computer Operators have their own separate well-defined Promotion Channel / Service Structure, Finance Department expressly for Computer Operators through Notification dated 16-12-2021 created 02 (Two) posts of Assistant Director (MIS) (BPS-17) in order to provide ample promotion opportunities to them in their own separate Technical Cadre, while placing of Computer Operators being a Technical Cadre Staff in the 05% Promotion Quota allocated to the Assistants and Senior Scale Stenographer of Board of Revenue and Direct Land Records leading to Tehsildar through Amended Notification dated 30-05-2023 is against the law, facts and is made with malafide intentions in order to grant undue benefit to the blue eyed people by using their discretionary powers.

(Copy of Notification dated 16-12-2021 is attached as Annex-G)

B. That discretionary powers are not unchecked or unfettered but said discretion is required by law to be exercised in judicial manner which means that same must be exercised on sound judicial principles. In case titled, "Walayat Ali Mir vs Pakistan International Airlines Corporation" (1995 SCMR 650), the Hon'ble Supreme Court has observed as under:-

"The discretion is not to be exercised on whims, caprices and moods of the authorities. It is now well-settled that exercise of discretion is circumscribed by principles of justice and fairness. The authority exercising discretion should take into consideration and advance the aim and object of the enactment, rule or regulation under which it is authorized to act.

C. That the Job description, work and function of Computer Operators and Ministerial Cadre employees are altogether different from one another which are as under:

IT Cadre / Computer Operators is a specialized technical cadre which only carries out IT related activities i.e. presentation, Web designing, Network Administration etc.

Ministerial Cadre duties are entirely managerial, clerical and files related work.

In case reported as 2010 PLC (CS) 240, Hon'ble Court observed:

Discretion exercised by public functionary must be structured, i.e. regularizing, organizing, producing order in it so that decision should achieve higher quality of justice. Discretion should be not be reasonable, irrational or disproportionate.

D. That for promotion, respondents allocated 5% Quota to Assistants and Senior Scale Stenographers amongst the employees of Board of Revenue, Director Land Records Staff leading to the post of Tehsildar, <u>for the reason</u> that the appellants on their official duty gain vast experience of Revenue and Land Records such as Land Revenue Assessments, Land Disputes,



Boundaries disputes, Land Partition, Land Produce and Maintaining Land Records etc and deal the Land Related issues with great zeal and zest.

E. That Computers Operators are directly recruited in BS-16 unlike the other Ministerial Staff of Board of Revenue, most of whom have to get promotion after a long hectic period from Junior Clerk (BS-11) to Senior Clerk (BS-14) and then to Assistant (BS-16) in their own separate Ministerial Cadre.

Likewise

Computer Operators have their own separate service structure, be initially appointed as Computer Operator (BS-16) further Promoted to Assistant Director (MIS) (BS-17) in their own separate IT Cadre.

In case reported as 2012 PLC (CS) 1119, Hon'ble court observed:

When an authority has been conferred discretion, it must be exercised fairly according to rational and intelligible reasons. Any action or decision which does not meet such thresh-hold requirements has to be considered arbitrary.

- F. That due to their own Separate Service Structure thus being a Specialized Technical Cadre specifically associated with Computers, the prospects of promotion for Computer Operators have been enhanced. They are getting IT / Computer Professional Allowance each month and more which is not admissible to the Ministerial Staff i.e. Junior Clerks, Senior Clerks and Assistants. (Copy of Notification is attached as **Annex-H**)
- G. That IT Cadre / Computer Operators have already been treated in accordance with Law and Rules; they have been given all the Fundamental rights. They were in different grades in different departments in BS-08 to BS-11 and they were upgraded and re-designated to BS-12 as Computer Operator in April 2009 and July 2010. Furthermore, now the post of Computer Operators has been upgraded to BS-16 on 29-07-2016. (Copy of Notifications are attached as **Annex-I**)

H. That on one hand Computer Operators having their separate promotion channel while on the other hand the impugned amendment Notification in promotion policy has adversely affected the terms and condition of the service of appellant and other member of service.

In Human Rights cases reported as (2010 SCMR 1301), while dilating upon the object of the good governance has observed that:-

"It is a settled principle of law that object of good governance cannot be achieved by exercising discretionary powers unreasonably or arbitrarily and without application of mind but objective can be achieved by following the rules of justness, fairness and openness in consonance with the command of the Constitution enshrined in different articles including Articles 4 and 25

It is therefore, humbly submitted that the instant service appeal may kindly be accepted as prayed for.

Any other relief, the court deems fit, may also granted.





Respectfully stated:

1. That in the previous service rules Assistants with 5 years service and Senior Scale Stenographers amongst the employees of Board of Revenue and Directorate of Land records had the 5% quota for promotion to Tehsildar (BPS-16). (Annex-A)

That most of the Assistants had not only to complete five years service for promotion to Tehsildar but they had to also get promotion all the way from Junior Clerk (BPS-11) to Senior Clerk (BPS-14), and then to the Assistant (BPS-16) for further promotion.

3. That this process enabled such employees to gain vast experience of official matters related to revenue etc.

4. That it takes a long period of time for an Assistant to get promoted to Tehsildar and that too in same Pay Scale.

5. That now Computer Operators (BPS-16) have been included in the joint seniority list of the Assistants and Senior Scale Stenographers for promotion to Tehsildar in the new service rules, notified on 30.05.2023. (Annex-B)

That the inclusion of Computer Operators in the seniority list is unjustified, and that recently two posts of Assistant Director IT (BPS-17) have been created for Computer Operators.

7. That the Computer Operators are direct recruited against Pay Scale BPS-16 unlike the other ministerial staff of Board of Revenue, most of whom have to get promotion from BPS-11 to BPS-16 to qualify for promotion to Tehsildar.

8. That the Computer Operator is totally IT related and Technical Post with no experience of official procedures and revenue.

 That not only Assistants but Junior Clerks, Senior Clerks and Junior Scale Stenographers will suffer a huge loss in shape of slow promotions on inclusion of Computer Operators in the seniority list for promotion to Tehsildar.

10. That the future of around seventy ministerial staff will be affected as compared to eight Computer Operators of Board of Revenue.




