

Respectfully Sheweth;

As to Preliminary Objections:

- 1) Para No.1 is incorrect, hence denied. No malafide has been shown by the answering respondents.
- 2) Incorrect, hence denied. The petitioner has been discriminated due to the pick and choose policy of respondents and violation of law/ constitution by the respondents.
- 3) Incorrect, hence denied.
- 4) Incorrect as replied earlier.
- 5) Incorrect, hence denied. These are the respondents who have violated the law/ rules.
- 6) Incorrect.
- 7) Incorrect, hence denied.
- 8) Incorrect. The law fully supports the stance of the petitioner/ appellant.

ON FACTS:



- 1) Documents are annexed as proof.
- 2) Record is annexed.
- 3) Record is annexed for ready reference.
- 4) Record is annexed with appeal.
- 5) Incorrect, hence denied. The petitioner/ appellant has come to this Hon'ble Tribunal for the implementation of wedlock policy in her case which was introduced keeping in view the socio-economic problems and hardships faced by husband and wife in Govt. service due to posting at different stations. The rest of para is incorrect. Several teachers belonging to different Districts have been posted in Peshawar without any exigency of service or public interest. Moreover, the seats in their own districts are lying vacant. Moreover, some BPS-18 teachers are posted on BPS-19 seats on the whims and wishes of the respondents (list annexed) whereas, during pendency of the appeal of the petitioner/ appellant, several other teachers were transferred to Peshawar under wedlock policy while the petitioner was not granted the same benefit despite pending his service appeal. (List of such teachers is annexed).
- 6) Record is annexed with the appeal. Moreover, petitioner/ appellant was not given the benefit of wedlock policy without any reason while several others were extended the same benefit during the pendency of appeal of petitioner/ appellant, under pick and choose policy and other extraneous reasons.
- 7) Para No.7 is incorrect, hence denied. The proof of illegalities and irregularities of respondents is annexed with the instant rejoinder, which speaks volume.
- 8) Para No.8 is incorrect.

- 9) Para No.9 is incorrect. It is not shown that how the case of petitioner is different. Moreso, no reason, according to the General Clauses Act is given.
- 10) Para No.10 is incorrect as replied earlier.
- 11) Incorrect. Several posts were available but the same were filled in violation of law/ policy.

ON GROUNDS:

All the grounds taken in the main appeal may kindly be treated as grounds of the instant rejoinder.

It is, therefore, humbly prayed that on acceptance of the instant rejoinder, the appeal of the appellant may kindly be accepted/ allowed as prayed for, along with imposing heavy cost on the respondents.

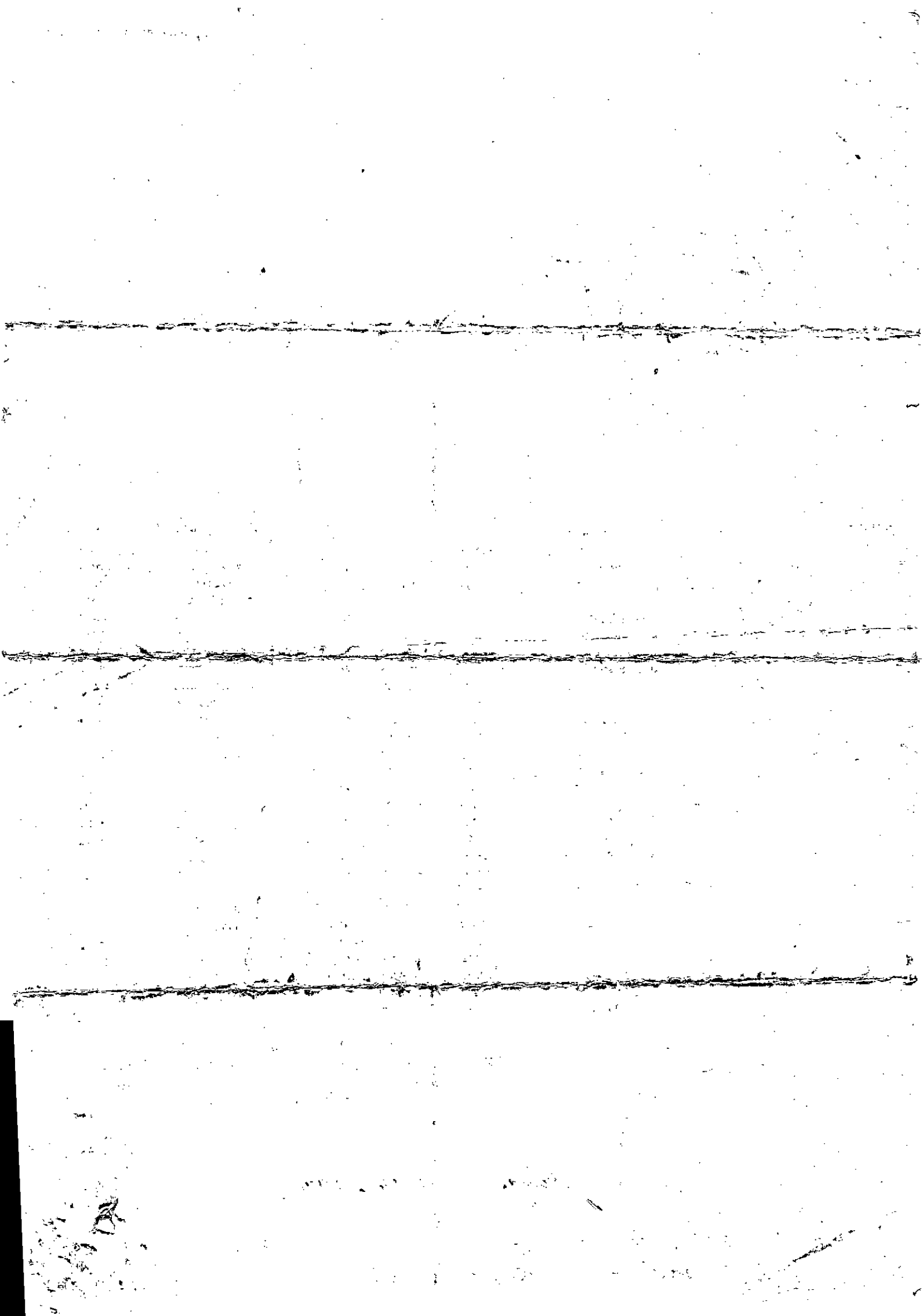

متعلقہ اضلاع میں ان کی اساسیاں خالی پڑی ہیں تدریسی عملے کو متعلقہ اضلاع کو واپس پالیسی مصلحتوں کا شکار

پشاور (نور پورٹر) پشاور کے سرکاری سکولز میں دوسرے اضلاع کے اساتذہ کی تعیناتوں کا مسئلہ نہ ہو سکا ہے زیادہ تر سکولز میں تاحال انتظامی عہدوں سے لے کر تدریسی عہدوں تک پر بھی دور دراز علاقوں سے تبدیل ہونے والے افسران اور تدریسی عملے کو تعینات کیا گیا ہے جس کے نتیجے میں اساتذہ کے متعلقہ اضلاع میں تدریسی اساسیاں خالی پڑی ہیں ذرائع کے مطابق اس وقت پشاور کے شہری اور مضائقہ علاقوں کے سرکاری سکولز میں سیاسی بنیادوں اور اثر رسوخ کی بنیاد پر سکولز کی تعداد میں مختلف کیڈز کے ٹیچرز تک سٹی الاؤنس کے چکر میں دوسرے اضلاع منتلا کوٹ، کرک، بنوں، ڈی آئی خان، چارسدہ، مروان، سوات، صوابی اور مگلو سمیت کئی اور اضلاع سے تبدیل ہو کر پشاور کے سکولز میں ڈیوٹیاں کر رہے ہیں اور متعلقہ اضلاع میں ان کی اساسیاں خالی پڑی ہیں ذرائع نے بتایا کہ اس حوالے سے صوبائی حکومت نے ایک پالیسی جاری کی تھی جس کے تحت پشاور میں دوسرے اضلاع سے تبدیل ہونے والے تدریسی عملے کو اپنے متعلقہ اضلاع کو واپس کرنے پر زور دیا گیا تھا لیکن بعض سیاسی مصلحتوں پر اس پالیسی پر عملدرآمد نہیں ہو سکا ہے۔
