Counsel for the appellant Mst. Nusrat. Shaheen present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant was appointed as Physical Education Teacher (PET) vide order dated 31.05.2004 on contract basis. It was further contended that under Regularization Act, 2005, she was regularized from the date of her appointment as revealed from the copy of her service book (available at page-9). It was further contended that appellant was transferred from Mardan to Peshawar therefore, on her transfer her name was placed at the bottom of seniority list pertaining to Physical Education Teachers Peshawar. It was further contended that again she was transferred from Peshawar to Mardan and again her name was placed at the bottom of seniority list pertaining to Physical Education Teachers Mardan. It was further contended that the appellant filed departmental appeal against the same but the same was rejected vide order dated 03.10.2019 hence, the present service appeal. It was further contended that since the appellant was not permanently absorb in Peshawar, therefore, the appellant could not be placed at the bottom of seniority list, therefore, it was vehemently contended that the impugned seniority list is liable to be rectification.

The contention raised by the learned counsel for the appellant needs consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 19.03.2020 before S.B.







**PRAYER:**

Filed to-day That on acceptance of this appeal the impugned appellate order dated 03.10.2019 may very kindly be set aside and the respondents may kindly be directed to enlist the name of appellant at the right/correct position in the seniority list circulated/prepared for the cadre of PET's i.e. w.e.f. the date of her 1<sup>st</sup> appointment i.e. w.e.f. 01.09.2004. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**PR/SHEWETH:**

**ON FACTS:**

- 1- That appellant was initially appointed as PET (BPS-09 now BPS-15) in the respondent Department vide order dated 31.05.2004. That after appointment the appellant submitted her charge report and started performing her duty at the concerned station quite efficiently and up

to the entire satisfaction of her superiors. Copy of the appointment order is attached as annexure.....**A.**

2- That appellant while serving as PET at GGMS Shah Zaman Qilla, District Mardan, the services of appellant were regularized w.e.f. the date of her 1<sup>st</sup> appointment i.e. 31.05.2004 in light of the NWFP civil servant regularization Act, 2005. Copy of the service book is attached as annexure ..... **B.**

3- That during service the appellant was transferred from GGMS Shah Zaman Qala, District Mardan to GGHS Badaber, District Peshawar vide order dated 12.07.2008. That in response to the said order the appellant took over the charge at GGHS Badaber, Peshawar and started performing her duty efficiently. Copy of the service book is already attached as annexure-**B**

4- That vide order dated 05.01.2011 the appellant was transferred back to her home District i.e. District Mardan and posted at GGHS Kati Ghari, District Mardan and in pursuance of the order dated 05.01.2011 the appellant submitted her charge report and started performing her duty with devotion. Copy of the order is attached as annexure.....**C.**

5- That the respondent Department circulated final seniority list of female PET mistresses vide dated 25.01.2017 wherein the name of the appellant was enlisted at serial No.106 below of her junior colleagues though colleagues of the appellant have been promoted to the post of SPET (BPS-16) while the appellant has been ignored on the reason that her seniority have been disturbed due to transfer. Copies of the seniority lists are attached as annexure.....**D & E.**

6- That appellant feeling aggrieved from the inaction of the respondents by not maintaining/enlisting the name of appellant in the seniority list in District Mardan w.e.f. the date of initial appointment filed Departmental appeal before the respondent No.2 which was forwarded to the respondent No.3 vide letter dated 19.04.2019. Copies of the Departmental appeal and letter is attached as annexure.....**F & G.**

7- That the respondent No.3 without lawful justification rejected the Departmental appeal of appellant vide appellate order dated 03.10.2019. Copy of the appellate order is attached as annexure.....**H.**

8- That appellant feeling aggrieved from the impugned appellate order dated 03/10/2019 having no other remedy filed the instant appeal on the following grounds amongst the others.

**GROUND:**

- A- That the impugned appellate order dated 03.10.2019 issued by the respondent No.3 is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B- That appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the respondent Department acted in arbitrary and malafide while issuing the impugned appellate order dated 03.10.2019 which is not tenable and liable to set aside.
- D- That the seniority of the appellant has been affected by the respondents on the reason of transfer to district Peshawar which is not a valid reason, therefore the seniority position is liable to be corrected.
- E- That the impugned appellate order dated 03.10.2019 has not been passed by the respondent No.3 in accordance with law and rules, therefore the same is liable to be set aside.
- F- That the inaction of the respondents by not correcting/enlisting the name of appellant in the seniority list from the date of her 1<sup>st</sup> appointment in District Mardan is violative of Section-8 of the Civil Servant Act, 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servants Appointment/Promotion & Transfer Rules, 1981.
- G- That not enlisting the name of appellant in her correct seniority position from the date of her initial appointment is ineffective upon the rights of appellant which is clear violation of principle of natural justice.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of appellant may be accepted as prayed for.
