SERVICE APPEAL U/S 4 OF THE KPK SERVICE TRIBUNAL ACT, 1974 AGAINST THE **ACTION/INACTION** IN DEPARTMENTAL APPEAL **FILED** 04.05.2023, WHEREIN THE APPELLANT HAS CHALLENGED THE NOTIFICATION BEARING NO. SO(SM)E&SED/5-17/2023/PT/G: DATED 14.04.2023 TO HIS EXTENT, WHEREBY THE APPELLANT HAS BEEN ILLEGALLY TRANSFERRED WITHOUT OBSERVING THE RULES / REGULATIONS / POLICY



Respectfully Sheweth:

Compendium of facts out of which the present service appeal arises are as under:

- 1. That after dissolution of the Provincial Assembly of Khyber Pakhtunkhwa on 18.01.2023, the Care Taker Chief Minister was appointed as provided under Article 224 clause (1A) of the constitution of Pakistan through the Order of the Governor dated 21.01.2023. That consequently on the very next day i.e. 22.01.2023, the Election Commission of Pakistan issued notification / Order through which a complete ban was imposed upon Government of Khyber Pakhtunkhwa and Punjab related to all kinds of Posting, Transfer inter alia developmental projects etc.
- 2. That the appellant has been serving as Subject Specialist (English) BPS-17 in the respondent department. Most recently the appellant was transferred and posted against post of SS (English) at GH\$ Ajmal Shah Barlashti Daud Shah Bannu on 07.10.2021. Copy of the Transfer is attached as Annexure A

- transferred by the respondents to GHS Doaba Hangu vide order 14.04.2023 after time lapse of some 1 year and 5 months approximately even though there has been a complete ban on posting / transfer on Government of Khyber Pakhtunkhwa and in utter violation of the article 224 of the constitution. Copy of the impugned order is attached as Annexure B
- 4. That being aggrieved from the impugned notification dated 14.03.2023, the appellant has filed a department appeal with respondent no. 1 on 04.05.2023 which has not been answered. Copy of Departmental Appeal is attached as Annexure C
- 5. That later on the impugned notification was modified to the extent of appellant and he was transferred to GHS Bachkan Ahmad Zai Lakki Marwat against SS Pashto post which is yet another violation. Copy of the modified notification is attached as Annexure D
- That the departmental appeal has not been decided till date while the statutory period of 90 days has already elapsed hence this service appeal inter alia, on the following grounds;

GROUNDS:

A. That as per article 224(1A) of the constitution 1973, where the powers of Care taker Government have

been discussed that the Care taker Government / Cabinet could not take policy decisions and permanent measures including recruitments, making appointments, transfer and posting of government servants during limited period where it held the office but in the impugned notification the said powers have been exercised which are beyond the mandate provided by the Constitution of Pakistan.

- B. That the impugned transfer/adjustment notification dated 14.04.2023 whereby appellant has been transferred has been made without obtaining the required NOC which is illegal, without lawful authority, corum non judice, void ab initio and of no legal effect upon the rights of the appellant, therefore liable to be declared as illegal:
- C. That the impugned notification dated 14.04.2023 issued by the respondents by completely disregarding the Constitution of Pakistan, Orders of the Election Commissioner and established dictum of the apex Court.
- D. That the impugned order is sheerly against the cadre/subject post of the appellant whereby despite the fact that he is Subject Specialist in English while he has been transferred against the post of Subject Specialist Pashto, therefore liable to set aside on the strong ground alone.



- E. That the impugned notification is also in blatant violation of the Transfer policy of the provincial government wherein it has been clearly mentioned that normal tenure of posting shall be three years but the appellant has been transferred twice in the time span of 17/18 months hence this ground alone is suffice to set aside the impugned notification to the extent of appellant.
- F. That the spouse/wife of the appellant namely Mrs. Gul Nazmina is presently working as Assistant Professor BPS-18 at Govt Post Graduate College for Women Bannu thus the case of appellant also falls under the umbrella of wedlock policy as protected by the Constitution of Pakistan 1973 and also followed strictly by the concerned government through notification and prescribed rules hence the husband/appellant may kindly posted back to serve in District Bannu. Copy of relevant documents are attached as Annexure E
- G. That the appellant may also take any other ground(s) with the permission of this honorable Court at the time of arguments.

It is, therefore, prayed that on acceptance of this Service Appeal, the impugned notification bearing No. SO(SM)E&SED/5-17/2023/PT/G: DATED 14.04.2023 and the Corrigendum dated 18th May, 2023 to extent of appellant may very kindly be

declared as illegal, unlawful, void ab initio, corum non judice, ineffective upon the rights of the appellant and may very kindly be set aside to the extent of the appellant.

The Respondents may very kindly be directed to allow the appellant to serve on the previous posting as Subject Specialist (English) BPS-17 at GHS Ajmal Shah Barlashti Daud Shah Bannu till the completion of his normal tenure as per posting transfer policy of Khyber Pakhtunkhwa and also to observe the wedlock policy.

Any other relief which this honourable Court thinks appropriate in favour of the appellant may also be granted in favour of the appellant.
