
BACKGROUND:

Mr. Sher Bahadar Khan, Ex Principal Govt. Degree College Khan Khoi, Mr. Abid Hussain Associate Professor of Statistics at Govt. Degree College Khan Khoi and Mr. Ikram Ullah Lecturer in Pashto, Govt. Degree College Khan Khoi were transferred from their station vide Provincial Government Notifications No. SO(E-I)/E&AD/9-88 Dated 14-11-2017, SO (E-I)/E&AD/9-88/2017 Dated 13-6-2017 and SO(Colleges-II)HED/2-5/2017/2870-2957 Dated 07-02-2017, respectively. The officers showed resistance in compliance of the order of the Provincial Government which put the educational atmosphere of the college into the state of disarray. Thus Department was compelled to initiate disciplinary proceedings against them and hence a summary was moved for the approval of the Competent Authority.

2. The Chief Secretary being the Competent Authority as per amendments in Khyber Pakhtunkhwa Govt. Servants (E&D) rules 2011 has constituted inquiry committee comprising of Mr. Zafar Iqbal OSD E&AD and Dr. Abdur Rashad Principal Govt. Degree College Wadpaggia vide Higher Education Archives & Libraries Department Letter No. SO(C-I)HE/1-5/2018/Summary for CM/Sher Bahadar Dated Peshawar the 30/07/2018 (**Annex-I**) to conduct a formal inquiry against the accused officers and to submit a report thereof to Department for appropriate necessary action.

3. Gist of charges/ statement of allegations leveled against the accused officers are given below.

- i. The services of Mr. **Sher Bahadar** were placed at the disposal of FATA Secretariat and directed through reminders to comply the order, but due to non-compliance, he put the college environment in to state of disarray.
- ii. Mr. **Abid Hussain** and Mr. **Ikramullah** were transferred and consequently relieved by the Principal, but they showed resistance in implementing Govt. Orders, either by making one excuse or the other and thus put the whole college environment into a state of disarray.



PROCEEDINGS:

4. The enquiry committee communicated the charge sheet to the accused officers and directed to submit their written reply within the stipulated time mentioned in the charge sheet. Furthermore, they were also summoned to appear before the committee on 16-8-2018 (**Annex-II**) regarding charges leveled vide ibid charge sheet and statement of allegation. The Directorate of Higher Education was also asked to depute Departmental representative, along with relevant record to assist committee during inquiry proceedings. In compliance, the accused officers submitted their written defense and are placed at **Annex- III, Annex-IV and Annex-V.**

5. The inquiry committee called the accused officers for personal hearing on 25-09-2018 as they have shown their desire to being heard in person. Statements of Departmental representative and the accused officers are reproduced below:

I. STATEMENT OF DEPARTMENTAL REPRESENTATIVE MR. IMRAN ASSISTANT DIRECTOR DIRECTORATE OF HIGHER EDUCATION (ANNEX-VI)

The Departmental Representative categorically informed that to maintain congenial environment in the College, these officers were transferred on administrative grounds

II. STATEMENT OF MR. SHER BAH DAR KHAN EX- PRINCIPAL GOVT. DEGREE COLLEGE KHAN KHOI NOWSHERA. (ANNEX-VII)

He stated that he submitted his arrival to the FATA Secretariat on 20-11-2017 in compliance of Provincial Government Notification, however due to observance of technical lacunas in the procedure adopted for the transfer, he submitted appeal to Chief Secretary for cancellation of his order as well as civil suit was also filed against the transfer order in the Civil Court Nowshera. Furthermore, shouldering of additional responsibilities for operationalizing newly established Govt. Girls Degree College Khan Khoi Nowshera was another reason which refrain him to take the charge within stipulated time period.

III. STATEMENT OF MR. ABID HUSSIAN ASSOCIATE PROFESSOR OF STATISTICS (BS-19) GOVT. DEGREE COLLEGE DAGGAR BUNER (ANNEX-VIII)

In his statement, he clearly shown his ignorance about his transfer, as no such Notification has been shared with him due to ongoing summer vacation in the college. Furthermore, he submitted an application to the Secretary Higher Education for release of his salary which was stopped by the college administration by relieving him in absentia on 1-7-2017. The application was entertained on 19-4-2018 and in compliance, he left the charge at GDC Khan Khoi Nowshera on 11-5-2108.

IV. STATEMENT OF MR. IKRAM ULLAH LECTURER IN PASHTO GOVT. DEGREE COLLEGE KHAN KHOI PESHAWAR (ANNEX-IX)

The accused officer was of the view that his transfer was against the prevailing policy as he only spent year and half in the said college. Aggrieved of the situation filed an appeal against the Transfer Notification in the Civil Court Nowshera on 10-02-2017, whereby the august court has issued temporary injunction in favour of him. Furthermore, the incumbent also approached the Khyber Pakhtunkhwa Service Tribunal for relief and the case is still pending there and the tribunal has also directed to maintain the status quo. He also expressed his concerns over his personal and family security from the militants being the domiciled of District Bajur. Latter on keeping in view the best interest of the public he relinquished the charge from the post of Lecturer at Govt. Degree College Khan Kohi, Nowshera on 07-09-2018.

FINDINGS:

6. The committee perused the available record, and the arguments submitted by the accused officers and ascertain the following factual positions
7. Mr. Sher Bahadar Khan Ex- Principal Govt. Degree College Khan Kohi could not assumed the charge at FATA within the stipulated time period, as Civil Court Nowshera has suspended the order of the Provincial Government. Meanwhile he filed an appeal to the Chief Secretary Khyber Pakhtunkhwa for non-observance of requisite procedure for transfer from settled to FATA. Latter on he withdrawn his case from the court on 6-2-18 and relinquished the charge on 18-04-2018 from the post of Principal Govt. Degree College Khan Kohi (Nowshera) after a lapse of almost two and half month. The charge against the accused officer has partially been proved.




8. Mr. Abid Hussain Associate Professor of Statistics BS-19 Govt. Degree College Daggar Buner, try to dodge the committee by presenting his ignorance regarding his transfer, however, during the course of cross questioning and the perusal of the record available with the Departmental Representative, it was clearly observed that accused officer was well aware of his transfer. He approached different quarters for the cancellation of his transfer as well as release of salary (**Annex- X & Annex-XI**) before complying the orders of the Provincial Government. The charges against the accused officer have been proved.

9. The committee also explored that claim of the Mr. Irfanullah Lectuere in Pashto BS-17 Govt. Degree College Khan Kohi Nowshera that temporary injunction has been issued in favor of him by the Civil Court Nowshera against his transfer is baseless, however, it has been acknowledged that Khyber Pakhtunkhwa, Service Tribunal has granted status quo in favor of him on 24/5/2017. Although the officer concerned has complied the orders of the Provincial Government on 07-09-2018 by relinquishing the charge from the post of Lecturer in Pashto at Govt. Degree College Khan Khoi Nowshera, however, the case is still pending in Khyber Pakhtunkhwa Service Tribunal, Peshawar. The charges against the accused officer have been proved.

RECOMMENDATIONS.

Since the charge against Mr. Sher Bahadar, Principal has partially been proved, therefore minor penalty of "Censure" is recommended. So far as Mr. Abid Hussain and Ikramullah is concerned, the charges against both the accused have been proved as they have not complied with the order of Provincial Government, therefore minor penalty of withholding of 02 increments for the period of 02 years is recommended to be imposed upon both the accused officers.



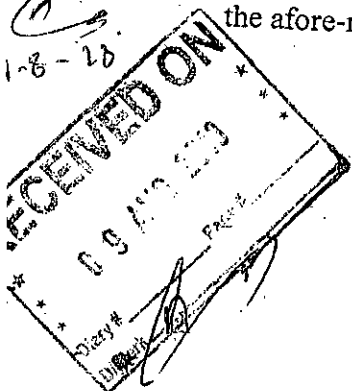

The charge no.2 is not applicable to me in the light of the above facts and letter as I have never committed any act or omission under the rules being an obedient govt servant.







With due respect it is submitted in written that:

i. I was transferred from GDC Khan Kohi, Nizampur (Nowshera) vide Notification No.SO (C-II)HED/2-5/2017/2870-2957 dated 07/02/2017 and my services are placed at the disposal of FATA directorate. The Principal relieved me in absentia and did not provide the relevant documents (Relieving slip and clearance certificate) intentionally therefore I submitted an appeal before the court of Senior Civil Judge Nowshera on 10/02/2017 and the temporary injunction was granted me by the august court against my transfer to FATA. (Copy of the appeal/temporary injunction is attached here).

I continued my duty at GDC Khan Kohi during the temporary injunction. After regular hearing the honorable court referred my case to the Khyber Pakhtunkhwa Service Tribunal Peshawar. Then I submitted a fresh appeal before the Khyber Pakhtunkhwa Service Tribunal Peshawar which was admitted for hearing and the court directed that meanwhile status quo be maintained. Appeal No-512/2017 dated 24/05/2017. (Copy attached)

When the case prolonged then I submitted another application before the court on 1/9/2018 for early hearing but the court still adjourned the case to next date. (Copy of the application attached). When the new principal Prof. Dr. Nisar took over the charge then I got relieved me properly and compliance the order in the best

interest of department and students. (Copies of the Relieving chit, clearance certificate and certificate of transfer of charge are attached here)

It is stated that I have not turned a deaf ear to this order rather I approached the court to get relief which is my legal right. Hence the allegation at S.No-i in charge sheet may be dropped please.

Appeal No.512/2017 dated: 24/05/2017. When the case is prolonged in the court then I submitted another application on 01/09/2018 in the court for early judgment but the court still adjourned the case to 27/09/2017. Lastly I compliance the order in the best public interest and I was relieved properly by the directive of DHE, KPK.

Other Facts

- 1- I stayed at GDC Khan kohi only one year and four months.
- 2- I belong to district Bajaur and have a serious threat from the militants.
- 3- I am residing at New Khanpur Township, district Haripur and my children are registered with the BISE Abbottabad.

The electricity transformer was stolen before my joining and the said college remained out of electricity power, water and computer Lab for more than one and a half year. - ii. That the transfer of the undersigned is against the policy and Rules of Government governing the transfer and posting and as such it is not in public interest.

- iv. That my mother, aged more than 70-years is also a cardiac and severe diabetic and high blood pressure patient and is under continuous medical treatment and need constants look after.

Posting and Transfer

Statutory Provision:

Section 10 of the NWFP Civil Servants Act, 1973.

Posting and Transfer. Every civil servant shall be liable to serve anywhere within or outside the Province, in any post under the Federal Government, or any Provincial Government or Local authority, or a Corporation or body set up or established by any such Government:-

Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

Provided further that, where a civil servant is required to serve in a post outside a service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled if he had not been so required to serve.

POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.

1) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained

2) While making postings/transfers of officers/officials up to BS-17; from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP

Para-1(v) regarding months of March and July for posting/transfer and authorities for relaxation of ban deleted vide letter No: SOR-VI (E&AD) 1-4/2008/Vol-VI, dated 3-6-2008. Consequently authorities competent under the NWFP Government Rules of Business, 1985, District Government Rules of 2001, Posting/Transfer Policy and other rules for the time being in make posting/transfer subject to observance of the

needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice-versa specific approval of the Governor NWFP/shall be obtained.

- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers. (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station. (Thaana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.
- xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement
1 DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such posting would be against non-administrative posts of equivalent scales;
- xii) In terms of Rule-17(1) and (2) read with Schedule-III of the NWFP Government Rules of Business 1985, transfer of officers shown in column 1 of the following table shall be made by the authorities shown against each officer in column 2 thereof:

Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

- i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule- IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

S. No.	Officers	Authority
1.	Posting of District Coordination Officer and Executive District Officer in a District.	Provincial Government.
2.	Posting of District Police Officer.	Provincial Government
3.	Other Officers in BPS-17 and above posted in the District.	Provincial Government
4.	Official in BPS-16 and below	Executive District Officer in consultation with District Coordination Officer.

3. As per Rule 25(2) of the Rules mentioned above the District Coordination Department shall consult the Government if it is proposed to:

- a) Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
- b) Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

5. All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.

{Authority: Letter No. SOR-VI/ESAD/1-4/2003 dated 24-6-2003}.

xiii) While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:

- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

Government servants including District Govt. employees feeling aggrieved by orders of posting/transfer authorities may seek remedy from the authority / the appointing authority as the case may be through the concerned authority within seven days of the receipt of such orders.

PLACEMENT POLICY.

In order to utilize the expertise of the officers who have received foreign training in various fields, the provincial Government has decided to adopt the Placement Policy, approved by the Prime Minister of Pakistan, and make it a part of its Posting/Transfer Policy. Placement Policy as follows:-

- i) All placements would be made on the basis of merit and keeping in view the needs of the organization.
- ii) The first priority in placement must go to the parent organization of the participant from where the individual had applied. This will be in consonance with the concept of establishing the "Need" for the department and fulfilling the need through "capacity building for the organization.
- iii) In order to follow the "bottom up approach" for Devolution, the priority within departments must go to the Districts, the Provinces and than the Federal Government.
- iv) The second priority in placement should go to up-grading the existing training Institution within the country. The knowledge gained by the officers, will be of immense value to bring about a qualitative change in the training institutions. The following proposals are made in this regard:
 - a) Permanent posting of an officer to the training institutions for 2-3 years;
 - b) Temporary attachment with the training intuitions for 3 to 6 months for some research project on helping in developing case studies;
 - c) Earmarked as a visiting faculty member for specific subject.
- v) Individuals posted to their parent organizations will also organize training for their subordinates within the department, in order to transfer the knowledge and bring about a qualitative change internally;
- vi) The Normal tenure of posting as already provided in the policy would be ensured;
- vii) No participant should be allowed to be posted on deputation to multinational donor agencies for at least 5 years;
- viii) No participant will decline/represent against his/her posting.

I am directed to refer to the subject noted above and to state that the Centrally Administered Tribal Areas-(Employees' Status) Order 1972 (President's Order No. 13 of 1972) provides that:

"Notwithstanding anything contained in their condition of service, the employees shall from the appointed day, be the employees of the Provincial government on deputation to the Federal Government and shall work under the overall administrative control of the Provincial government, on the same terms and conditions of service as respects remuneration, leave and pension and the same rights as respects disciplinary matters or tenure of office as were applicable to them immediately before that day; provided that the employees shall not be entitled to deputation allowance for their service after the appointed day".

2. According to the Posting/Transfer Policy of the Provincial Government, the Governor NWFP and the Chief Secretary NWFP are the competent authorities for posting/transfer of Civil Servants in BS-18 and above and up to BS-17 respectively. The policy prescribes two years normal tenure of posting in FATA. Similarly, it is obligatory for all the Provincial Government employees who have been selected against Zor-e-FATA Quota to compulsorily serve in FATA for at least eighteen months.

3. It is evident from the above that employees serving in FATA are under the administrative control of the Provincial Government. However, after establishment of FATA Secretariat, it was felt imperative to have linkage between the Provincial Departments and the FATA Secretariat so that public service delivery does not suffer due to frequent reshuffling of staff without knowledge of that Secretariat.

4. Taking cognizance of frequent posting/transfer of officers/officials from FATA to settled areas and vice versa by the respective Departments without prior consultation with the FATA Secretariat, it was emphasized on all the Administrative Departments, vide circular letter No SO(E-1) E&AD/9-126/2006/Vol-II dated 26th January, 2007 that the said Secretariat should invariably be consulted before issuing orders of Posting/Transfer of Government Servants from and to FATA. However, the FATA Secretariat have frequently conveyed their apprehensions that these instructions are not being followed, and at times a very embarrassing situation for the FATA Secretariat is created as work suffers due to shortage of staff which becomes a serious issue in the prevailing law and order situation in FATA.

5. In view of above, it is reiterated that:-

(i) All Provincial Government Departments are directed to move proposals for posting out of an employee from FATA only when a substitute is proposed in the same case.

(ii) On consent from the FATA Secretariat and approval of the proposal by the competent authority, the substitute to FATA would invariably give his arrival for duty before the employee being transferred out of FATA is relieved.

Master to be true copy

- (iii) Provincial Government Departments may not accept the arrival report of an employee transferred out of FATA till his proper relieving order is issued by the FATA Secretariat.
- (iv) The Accountant General (PR) is also requested that Last Pay Certificate of an employee transferred out of FATA but not relieved properly by the FATA Secretariat may not be issued in any circumstances.
- (v) Instruction issued vide letter No.SO (E-I) E&AD /9-126/2006/Vol-II dated 26th January, 2007 (quoted in Para-4 above) should be followed strictly.
- (vi) No NOC in respect of transfer from FATA to settled area issued by any Head of Line Department of FATA Secretariat should be accepted. Only those NOCs, which have been issued by the Administration & Coordination Department, FATA Secretariat, should be considered.
- (vii) Tenure of Civil Servants must be kept in view while issuing NOC for posting/transfer or considering postings/transfers.
- (viii) No NOCs should be issued in respect of employees in BS-1-15 who is from agency cadre and in whose respect Political Agent and Agency officer have been declared as appointing authorities.
- (ix) Persons appointed in agency cadre, if appointed in the settled areas will resign from service in FATA and will resume service in settled areas as a fresh candidate.
- (x) NOCs may be issued in respect of employees of the Provincial cadres i.e. BS-16 and above only after completion of their normal tenure and they shall not be transferred out of FATA unless their substitutes are provided simultaneously.

6. It is requested that the above Policy may be followed in letter and spirit, in further, in public interest.

Change in policy to fill vacant posts in FATA to ensure better human resource management

I am directed to refer to the subject and to state that the competent authority has been pleased to make following changes to the posting/transfer Policy of Government in respect of candidates selected from Zone-I (FATA:-

- a) Secretariat who shall endorse it to the concerned administrative department in the Provincial Government. The FATA Secretariat shall arrange medical and security clearance and thereafter submit a case through the respective administrative department seeking approval of the appointing authority. The appointment letter shall be issued by FATA Secretariat on behalf of the respective administrative department. Posting orders shall also be issued by FATA endorsing copies to the respective department where personal file of the civil servant is to be maintained. This arrangement shall be confined to recruitments made in BS-16 and 17 but shall be exclusive PMS.
- b) In case of disciplinary action, while the appointing and appellate authorities shall remain the same charge sheets/statement of allegations and show cause shall be prepared by FATA Secretariat and submitted in the form of a summary through Establishment Department. Leave accounts and GP Fund withdrawals shall also be dealt by FATA Secretariat based on the codal formalities as observed by the Provincial Government Departments.
- c) Copies of all necessary orders in respect of such officers/officials made by FATA Secretariat shall be endorsed to respective administrative departments for record.

(Authority: letter No.SOR-VI/E&AD/1-10/2009, dated 30th July, 2010.)

**Guidelines for transfer/posting of Naib Tehsildars/
 Political Naib Tehsildars / Assistant Political Agents.**

I am directed to refer to the subject and to say that the competent authority has been pleased to approve the following guidelines for posting/ transfer of Naib Tehsildars/Political Naib Tehsildars/Assistant Political Agents:-

1. The proposal will be initiated by the respective Political Agent or DCO and addressed to the concerned commissioner. If there is no disagreement the proposal will be forwarded to FATA Secretariat for further processing.
 - ii. In case of disagreement, Commissioner will try to find a consensus candidate in consultation with Political Agent or DCO. However, if disagreement continues FATA Secretariat will make the final decision.
 - iii. Political Agent/DCO will ensure that while proposing the officer for transfer/posting all the stakeholders have been consulted, particularly the LEAs who are conducting active operations in the tribal belt these days.
 - iv. It should be ensured that the officers are not posted to the same appointments repeatedly; and that the proposal is purely based on merit and has not been influenced by the outside elements.

The service profile of the proposed officer needs to be attached with every proposal.

- vi. Posting of officer from Hard area to Soft area or vice versa should be one of the factor in determining the suitability.
- vii. A routine tenure may be respected. However, due to the current situation in FATA there are cases of burnt out due to continuous emergency duties. In such circumstances an officer may be recommended for posing before the normal tenure.
- viii. Political Tehsildars (PT)/Naib Tehsildars (NT) will not stay in the same division for more than five years continuously and may only be posted back to the same Division after serving minimum of three (3) years in any other Division.

2. It is requested that above guidelines may be followed in letter and spirit, in future, in public interest.

Inter Provincial Transfer

Attention is invited to Rule-8 of the NWFP, Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 where under Inter-Provincial Transfers of employees in BPS 1 to 15 and 16 and above are permissible subject to the fulfilment of conditions laid down in the aforesaid rule. However, in most of the cases, the requests for Inter-Provincial Transfers are not strictly scrutinized in the light of the aforesaid rules which creates not only embarrassment for the S&GAD but also causes delays in finalizing of such cases.

2. While examining cases, it has been noticed that inter-provincial transfer results in an over all increase of officials in the NWFP, which is against the downsizing policy of the Government. The un-employment situation in NWFP is more acute than in any other province. Large scale transfers of officials from other provinces would also deprive the people of NWFP from employment in other Provinces. It may, therefore, be necessary to restrict the inter-provincial transfers to very exceptional cases where a strong humanitarian ground exists or where technical expertise, which is not available in the province, is required.

3. It is requested that the provisions of Rule-8 of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 may be observed strictly while recommending cases of inter-provincial transfers, with full justification for consideration of the competent authority.

Identification of Unattractive/Hard Areas policy;

I am directed to refer to the subject and to say that the Provincial Cabinet in its meeting held on 30th March, 2010 inter-alia approved the following for the purpose of Posting/ Transfer Policy:-

- 1. The distinction between unattractive/hard areas should be done away with and both should be labeled as Unattractive areas.
- 2. Existing list of FATA areas be retained.
- 3. The following areas were recommended/approved to constitute unattractive areas in NWFP:-

- a. Kohistan District.
- b. Tank District.
- c. Chitral District.
- d. Battagram District.
- e. Shangla District.
- f. Hangu District.
- g. PATA areas of Mansehra (Kala Dhaka)

Tenure of posting.

- i. The erstwhile normal tenure of 2 years be retained.
- ii. Existing tenure for unattractive areas be retained. However, in case of married civil servants, transfer should be made just at the beginning of school session and tenure should be one year instead of 1.5 year, so that academic disruptions are avoided.
- iii. At the time of entry in service, all civil servants be asked to give 4 options from unattractive areas.
- iv. After a stint of service in unattractive area, employees may be offered option to serve in district of choice.



Plaintiff alongwith counsel present. Admits the contents of the plaint. Be registered. Alongwith the plaint, plaintiff also moved an application for grant of temporary injunction.

Counsel for plaintiff argued that according to the posting/transfer policy of Provincial Government of Khyber Pakhtunkhwa, all the transferred shall be made in the public interest and not based on malafide and under political pressure. The basic condition of obtaining NOC from the Governor of Khyber Pakhtunkhwa is a pre-condition specifically for transferring civil servant BPS-18 and above from settled area to FATA. The petitioner/plaintiff was appointed initially against Zonal Allocation for Zone-2 through Public Service Commission. The respondents/defendants Chief Secretary under political pressure and with malafide intention without procuring NOC from Governor Khyber Pakhtunkhwa placed the services of the petitioner/plaintiff with FATA Secretariat. The respondents/defendants Chief Secretary is a coram non iudice to transfer a civil servant (BPS-18 and above) of settled area of Khyber Pakhtunkhwa to FATA Secretariat without procuring NOC of governor Khyber Pakhtunkhwa. Notice of the application be issued to respondents/defendants for 15/11/17. Meanwhile the operation of impugned transfer order No. SO(E-1)E&AD9-88/2017 dated 14.11.2017 is suspended subject to NOC of Governor Khyber Pakhtunkhwa.
