- **D.** Incorrect, already explained vide above para.
- **E.** The matter was dealt with as per law and the necessary procedure has been adapted before awarded appellant the major punishment.
- **F.** Incorrect, as appellant has totally denied his presence with accused PASI.
- **G.** Incorrect, the competent authority upon receipt of Enquiry findings, issued the appellant Final Show Cause Notice and after due consideration to all the circumstances of the case, issued order of dismissal.
- **H.** Needs no comments as already explained above para.
- **I.** Incorrect, facts and circumstances of the appellant are different from that of Faheem.
- J. Incorrect, the E.O in his finding report has proved the appellant guilty of misconduct. Therefore, upon receipt of such findings, he competent authority by taking into consideration all the circumstances of the matter, awarded him major punishment to the appellant he has liable to.
- K. Pertains to record, needs no comments.
- **L.** It is lawful authority of appellant authority to modify the punishment awarded to him by the competent authority.
- **M.** Incorrect, period of the appellant remaining out of service does not entitle him for any monetary benefits. Therefore, punishment has been rightfully awarded to him as per law.
- N. Incorrect, departmental and judicial proceedings go side by side.
  Moreover, the appellant has been re-instated into service. Therefore, the instant appeal is not maintainable in the eyes of law.


Based on the above facts; I am satisfied that no enquiry is needed in this case as contained in section 5.3 clauses (a) & (c) under the said rules.
