



- 3) That on 17.04.2023 the appellant preferred Departmental appeal against the above mentioned order. But the same is not decided by appellate authority / respondent No. 1 till now, hence this appeal on following grounds inter alia. (Copy of departmental appeal is attached as Annexure C)

GROUND:

- a) That the impugned order is illegal, wrong and incorrect, based on malafide, hence needed to be corrected.

- b) That the impugned order is factually wrong and incorrect. Infact the original place of posting of the appellant is Bijli Ghar Mardan which is evident form service records of appellant.

- c) That if the impugned order is not corrected, then in long ran, the appellant will face with great sufferings and will affected her service in future.

- d) That the appellant is a poor woman and has school going children, hence dialy going from Bijli Ghar Mardan(her place of residence) to Kodinaka is so much difficult.

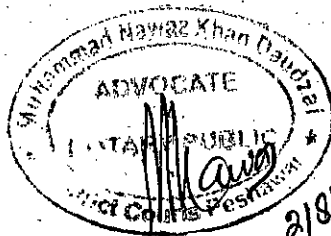



It is, therefore, humbly requested that on acceptance of the instant service appeal, both the impugned orders may kindly be set aside and salary of appellant may be released and impugned order dated 11.04.2023 may be corrected in respect of original post of place of the appellant.

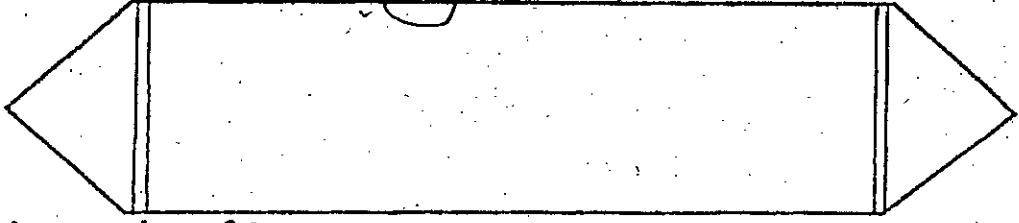
