

SERVICE APPEAL UNDER SECTION-4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNEL ACT, 1974, AGAINST IMPUNGED ORDER ISSUED VIDE ENDST; NO: 2708-14 DATED 01/04/2023 BY THE DISTRICT EDUCATION OFFICER (MALE) MANSEHRA, WHEREBY THE SERVICES OF THE APPELLANT WERE TRANSFERRED FROM GMS GHAZIKOT TO GMS TARHERI, MANSEHRA IS ARBITRARY, MALAFIDE IN LAW AND FACTS, WITHOUT LAWFUL AUTHORITY, DISCRIMINATORY AND UNDER EXTRANEOUS CONSIDERATION TO ACCOMMODATE RESPONDENT NO.3, BASED ON FAVOURITISM AND SIFARASH. THE SAME MAY PLEASE BE SET A SIDE, DECLARING THE SAME AS ILLEGAL VOID, AB-INITIO AND IN-EFFECTIVE UPON THE RIGHTS OF APPELLANT.

Respectfully Sheweth

Brief facts leading to the instant appeal are as under: -

- 1) That, the appellant was performing his duty against the post of CT at GMS Ghazikot Mansehra in result of his transfer from GHS Moorat Maira, hard, remote and un-attractive area of Tanawal. While performance of the appellant was up to the entire satisfaction of his immediate officers, was transferred to GMS Tarheri vide impugned notification dated 01/04/2023. Though, through impugned transfer order, the post of CT at GMS Ghazikot was kept vacant under extraneous consideration to accommodate a blue eyed chap, copy of impugned transfer/adjustment order date 01/04/2023 is attached as Annex; "A".
- 2) That, after a short span of five days, the District Education Officer Mansehra, Resp No.01, passed another transfer order vide No.2531-37 dated 05/04/2023 whereas one Mr. Muhammad Usman CT GMS Nara Doga, (Resp No.3) was accommodated against the newly vacated post at GMS Ghazikot, who was a contractual appointee and his services were regularized in the month of December 2022. Transfer of appellant through impugned order was pre-planned and based on malafide just to accommodate Resp No.3 in compliance with illegal direction of the Deputy Commissioner Mansehra in violation of transfer policy, as the Resp: No.3 having tenure of four (4) months, copy of transfer order of Resp No.03 & regularization order dated 23/12/2022 are attached and marked as Annex "B-1 & B-2-8" respectively.
- 3) That, impugned transfer order of appellant was without giving detail of compelling reasons of impugned transfer, as the post was kept vacant malafide and not in public interest but highly capricious based under alien consideration, hence the appellant made request to Resp No.01 under RTI Act for provision of copies/directions issued to Resp No.01 regarding un-warranted transfer order of appellant, copy of request dated 19/04/2023 under RTI Act is attached and marked as Annex: "C".

- 4) That, all the transfer proceeding of appellant was the result of compliance of illegal orders of Deputy Commissioner, Mansehra, as Resp: No.3 was the close relative of the Deputy Commissioner, Mansehra, resultantly Resp No.01, instead of providing copy of requisite documents, as per request of appellant under RTI Act, served explanation upon the appellant vide No.3873 dated 28/04/2023 under E&D Rules 2011, copy of explanation dated 28/04/2023 is attached and marked as Annex "D"
- 5) That, the appellant submitted reply of explanation with the contention that the appellant adopted proper procedure as per fundamental/constitutional rights of civil servants and appeal rules 1986 but office of the Resp No.01 adopted harsh and aggressive measures & refrained to fulfill his legal liability of releasing requisite documents. Copy of reply of explanation dated 12/05/2023 and its acknowledgment is attached and marked as Annex: "E & E-1".
- 6) That, the appellant feeling aggrieved due to the impugned transfer order dated 01/04/2023 sought remedy from Resp: No.2 through departmental appeal dated 03/05/2023, within stipulated period, with the submissions that father of appellant is an old man of more than 70 years and is permanent bed patient facing sever health issues, even not in position to attend bath room without supportive attendant, while appellant is the single male member to look after him, in such a critical situation. it is further submitted that younger brother of the appellant is serving in Pakistan Army, Copies of departmental appeal dated 03/05/2023 on humanitarian grounds, prescriptions and various test reports of ailing father are attached as Annex-"F-1-3" & "F-4~~46~~" respectively.
- 7) That, statutory period of ninety days has elapsed from the date of preferring departmental appeal but no reply to the departmental appeal has so far been conveyed to the appellant.
- 8) That, feeling aggrieved and finding no other remedy, the appellant is constrained to approach this hon,able tribunal for redressal of his grievances, respectfully mentioned that the impugned transfer order dated 01/04/2023 is arbitrary, malafide in law and facts, motivated, without lawful authority, discriminatory and under extraneous consideration to accommodate Resp; No.3 based on **FAVOURITISM** and **SIFARISH** which would not be sustainable in law.

GROUNDS

- a) That, posting transfer policy of Provincial Government provide the option of appeal against posting/transfer order on the basis of sound and grave personal (humanitarian) grounds that appellant approached to respondents with the request that the father of the appellant is an old man of more than 70 years and is permanent bed patient facing sever health issues, even not in position to attend bath room without supportive attendant, while appellant is the single male member for his look after in such a critical situation. it is further added that younger brother of the appellant is serving in Pakistan Army. The Respondents passed the impugned order in violation of provision of transfer policy.
- b) That, impugned transfer order of appellant was un-warranted, based on malafide, abuse/mis-use of authority to victimize the Government servant, without giving detail of compelling reasons of transfer as the post was kept vacant just entire proceeding of transfer was the result of direction of the superior officer to accommodate a blue eyed in a fanciful manner.
- c) That, after a short span of five days, the District Education Officer Mansehra, Resp No.01 passed another transfer order vide No.2531-37 dated 05/04/2023 whereas one Mr. Muhammad Usman CT GMS Nara Doga, (Resp No.3) was accommodated against the newly vacated post at GMS Ghazikot, who was a contractual appointee and his services were regularized in the month of ~~Dec~~ 2022. Transfer of appellant through impugned order was pre-planned and based on malafide just to accommodate Resp No.3 in compliance with illegal direction of the Deputy Commissioner Mansehra in violation of transfer policy, as the Resp: No.3 was in lack of tenure.

d) That, transfer of appellant was without any source/reasons, application, complaint or written direction of Deputy Commissioner Mansehra, hence the appellant made request to Resp No.01 for provision of such source of transfer that was the legal and constitutional right of the appellant but unfortunately Reap; No.01 served explanation upon the appellant under the charge of mis-conduct, dis-obedience and violation of departmental rules and regulations. The harsh act of Resp No.01 was just to compel the appellant to relinquish the charge of post from GMS Ghazikot hence the appellant relinquished the charge and submitted his arrival at his newly posting station i.e GMS Tarheri.

e) That, the appellant also relies on additional grounds at the time of arguments.

PRAYER

It is therefore, humbly prayed that on acceptance of instant appeal, this honorable tribunal may please be set aside impugned transfer order dated 01/04/2023 issued by Resp: No.01, declaring the same arbitrary, malafide in law and facts, without lawful authority, discriminatory, motivated and under extraneous consideration to accommodate Resp; No.3 vide order dated 05/04/2023 based on **FAVOURISM** and **SIFARISH**.

Any other relief which may deemed appropriate and has not specifically been prayed for may also be granted.

INTERIM RELIEF

It is therefore, requested that the operation of impugned transfer order dated 01/04/2023 passed by Resp No.01, may please be suspended till the disposal of instant/main service appeal.

Brief facts leading to the present departmental appeal are as under:

1. That, the appellant was promoted from the post of SPST to the post of CT on 23-07-2015 and was posted at GHS MORIT Maira (Hard Area of Tanawal). copy of promotion order is attached as **Annex-A**
2. That, appellant served more than two years in such a remote and unattractive area, was transferred on merit from GHS Morit Maira to GMS Ghazikot against the vacant post vide No.17138-43 dated 07-10-2017. copy attached and marked as **Annex-B**
3. That, posting transfer policy of provincial Government provides that all the posting/transfers shall be strictly in public interest and shall not be abused / misused to victimized the Government Servant but appellant was extremely shocked to see his impugned transfer order from GMS Ghazikot to GMS Tarehi dated 01-04-2023 received on 12-04-2023 through WhatsApp, without giving detail of compelling reasons of transfer as the post was kept vacant and transfer of the appellant was capricious and based on considerations not in the public interest but to accommodate the blue-eyed chap on the dictation of superior officer. Copy of impugned order dated 01-4-2023 and WhatsApp report dated 12-04-2023 are attached as **Annex: C to C2** respectively.
4. That, after a period of 5 days the District Education Officer passed another order vide No.2531—37 dated 05-04-2023, whereby one Mr.Muhammad Usman CT GMS Nara Doga was transferred, against fresh malafidly vacated post of undersigned at GMS Ghazikot while his services were regularized in the month of June 2022. 



