Under the provision of Rule-6(b) of the Government of NWFP, District Government Rules of Business, 2001 and as per recommendations of the Departmental Selection/Departmental Promotion Committee, the District Coordination Officer/District Magistrate Swat (Competent Authority) has been pleased to notify the appointment Mr. Inamullah Khan s/o Mr. Fazal Wadood of Saldu Sharif, Swat, as KPO (BPS-11) plus usual allowances, against the newly created post in the office of DISTRICT MAGISTRATE, Swat with immediate effect, with the following conditions:-

TERMS AND CONDITIONS.

- 1- His services will be on one year probation period as provided under Rule-6(2) of Civil servant Act, 1973.
- 2- He will not contribute any amount towards GP Fund nor will he be entitled to any benefits from the GP Fund.
- 3- His services will be liable to termination one month's notice from either side. In case of resignation without notice, one month's pay/allowance if any shall be profited to Government.
- 4- His services can be terminated at any time in case his performance is found unsatisfactory and he will be proceeded against under Removal from service Special Powers) Ordinance, 2000.
- 5- The Selectee should join duties within 15 days of the issue of this order.
- 6- He will produce fitness certificate from the Medical Superintendent/Civil Surgeon.
- 7- His age should not exceed 40 years or below 18 years.
