Service Appeal Under Section 4 of the Service Tribunal Act 1974, for issuance full LPR, G.P. Funds on retirement as per pension laws and rules, which have not been given / extended to the appellant on his retirement on medical ground w.e.f 05.12.2019 and his appeal dated 10.09.2020 and before that brought no fruit.

Prayer in Appeal:

On acceptance of the instant Service Appeal, the respondents may kindly be directed to pay the entire outstanding amount to the appellant as per law and prevalent rules.

Respectfully Sheweth

The appellant most humbly submits as under:

1. That the appellant initially appointed on 21.08.1984 and re-appointed on 24.11.1990 through Public Service commission as Sub-Engineer.
2. That the appellant served as Sub-Engineer in Mardan Scrop Project Directorate, Mardan till 1992 for one month in Swabi and in 1992 transferred to Nowshera in Local Government.

3. That in the year 1995 appellant was transferred to Mohmand Agency till 1998 on the same post and one month served in Timergara.
4. That in the year 1998 A.O. restored at the services of appellant was again transferred to Nowshera and he served there till 2001. After that the appellant was transferred to FR Peshawar where he served till 2003.
5. That in the year 2003 Local Government was abolished, and the appellant was kept as Surplus Pool and was sent to Tehsil Municipal Administration (TMA) Matta Swat in 2004.
6. That from 2004 till 2007 the appellant was on leave, the appellant rejoined the services at Samar Bagh (Lower Dir) from 2007 till 2010, the appellant also served for one year in Kohistan Daso from 2010 to 2011.
7. That thereafter the appellant was again sent to his parent department (FATA Local Govt) and served in Bajaur Agency as Sub-Engineer from 2011 to 2013. The appellant also drawn salary from Tank too for four months.
8. That appellant served with the D.G. local Government Office Peshawar from 2013 to 2015 and in the office of Peshawar Development Authority Peshawar in 2015 till 2019.
9. That in the year 2017 the appellant was posted as Assistant Director and he was extended leave as encashment of LPR under the leave rules 1981 through Letter No. PR-5/GAD/2020-21. (Copy attached) *As Annexure 'A'*
10. That in all this period the appellant G.P. funds was deducted and he was paid a minute amount of G.P. Funds at the time of retirement. The appellant during service was drawn Rs. 75,000/- per month salary, hence for the one year salary it was Rs. 75,000 x 12 = Rs. 900,000/- while

the appellant was paid only Rs. 500,000/-. (Relevant record of full service are attached with the appeal as Annexure B)

11. That from the above facts and record it is crystal clear that the appellant was not treated as per pension prevalent rules and law, hence the need of this appeal arose.
12. That the appeal to the respondent has not yet been decided, hence the same is treated to be dismissed by the respondents. (Copies of appeals are enclosed with this service appeal as Annexure C, D and E respectively)
13. That as per pension relevant rules and laws including GP funds rules the appellant is legally entitled for the withholding amount by the respondent in terms of his salary and G.P. Fund.

It is, therefore, most humbly prayed that on acceptance of this appeal, the respondents be directed to release arrears, benefits, salaries, G.P. Funds of the appellant as per prevalent laws and rules. Any other relief which is not specifically asked for but according to circumstances of the case if appellant is entitled may also be allowed.
