The Respondents No. 1-3 submit as under:

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action/locus standi.
- 2 That the Appellant is not an aggrieved person within the meaning of Section-4 Khyber Pakhtunkhwa Service Tribunal Act-1974 read with Article 212 of the constitution of Islamic Republic of Pakistan 1973.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal.
- 4 That the Appellant has not come to this Honorable Court with clean hands.
- 5 That the appeal in hand is based on mala fide intentions for illegal service benefits.
- 6 That the matter in hand is barred by law in view of the law of limitation Act 1908.
- 7 That the case is bad for mis-joinder and non-joinder of the necessary parties to the titled appeal.
- 8 *That* the appellant is a habitual litigant in filing baseless petition against the Department.
- **9** That the impugned Notifications dated 19-05-2023, whereby the Notification dated 18-05-2023 has been withdrawn under the rules in vouge resulted in the restoration of the notification dated 07-04-2023.
- 10 *That* no Departmental Appeal against the above said Notifications has been filed by the appellant to the appellate authority till date against the in action of the Department, hence, got finality under the law.

- 11 *That the* appellant is estopped by her own conduct to file the instant appeal before this Honorable Tribunal.
- 12 That the appellant has correctly been posted against her original post of SST in BPS-16 by the Department.

ON FACTS.

- 1 That Para-1 pertains to the service record of the appellant against the SST (G) in BPS-16 post & was adjusted as ASDEO (F) SDW Bannu on 11-02-2021 on stop gape arrangement till the arrival of an officer of management cadre attached as Annex-A.
- 2 That Para-2 is incorrect as the order under reference, whereby, Mst. Nayar & Raziya Bibi PSTs were directed to help out in the functionalization of the schools in the SDW Bannu which was not honored by the appellant being an ASDEO circle for no good reason attached as Annex-B.
- 3 That Para-3 is also incorrect the order attached as Annex B was legal & issued by the competent authority but not honored by the appellant being a circle ASDEO for no legal ground, hence, she was transferred from the ASDEO post by placing her services at the disposal of DEO Concerned vide Notification Dated 07-04-2023 attached as Annex-C.
- 4 That Para-4 is correct that the appeal of the appellant was referred to the Director E&SE vide letter 12-04-2023 by the Respondent No. 1 for necessary action attached as Annex-D & E.
- 5 That Para-5 is correct that the Departmental appeal of the appellant was allowed on darted 18-05-2023 attached as attached as Annex-F.

GOVERNMENT OF NWFP ESTABLISHMENT & ADMINISTRATION DEPARTMENT (Regulation Wing)

POSTING/TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- All the posting/transfers shall be strictly in public interest and shall not be tabused/misused to victimize the Government servants
 - ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) }
 While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained

While making postings/transfers of officers/officials up to BS-17, from settled areas-to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.

- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for attenst eightuen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP), Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thana) of his area/resulence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

DCOs and DPOs who are due to retire in the near future may also be posted in the District of their domicile subject to the condition that such posting would be against non-administrative posts of equivalent scales;

Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following against posting/ exercised only in the following cases.
 - Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
 - Serious and grave personal (humanitarian) grounds.
- To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier.
