**PARA WISE COMMENTS ON BEHALF OF RESPONDENTS NO.1, 2,
& 3**

Respectively Sheweth:

The Respondents submit below:

PRELIMINARY OBJECTS

1. That the appellant has got no cause of action/locus standi.
2. That the appellant has concealed material facts from this Hon'ble Tribunal.
3. That the appellant has been estopped by her own conduct to file the instant appeal before this Hon'ble Tribunal.
4. That the instant appeal is barred by law/limitation.
5. That the instant appeal is not maintainable in its present form.
6. That the instant appeal is bad for mis-joinder and non-joinder of necessary parties.
7. That the appellant has not come with clean hands to this Hon'ble Tribunal.

ON FACTS:

1. That Para-No.1 &2 Pertains to Appellant's personal record.
3. That Para-No.3 is incorrect and misleading, and against the facts, the appellant having irresponsible attitude toward her legal duties and often remained wellful absent from her duty.
4. That reply to Para -No 4 & 5, is incorrect and misleading against the facts, the appellant absenteeism was repeatedly reported by the Principal of GGHSS Nishterabad and have served various warning / Explanation letters at different time period yet she did not change her routine and remained same, It is pertinent to mention here that the appellant admitted by herself in para no .4 of the service appeal that she remained willful absent from 01/01/2022 to 14/07/2022. Therefore the responded department decided to conduct an inquiry (Dated 25-06-2022) to proceed the case further, in the said inquiry, the appellant

(EX. Sweeper) was proved guilty. The inquiry officer recommended the penalty of removal/ compulsory retirement from service. In the light of above facts and under E&D Rules the competent authority through Principal has served a charge sheet along with the statement of allegation for her misconduct and negligence of duty and tentatively decided to impose upon her major penalty of removal (vide letter No.2583 dated 23/05/2022)

However the appellant did not reply to her charge sheet and remained silent. Therefore, after keeping in view the recommendation of inquiry officer, the competent authority exercised the power under E&D Rules imposed major penalty of compulsory retirement upon the appellant on dated 15-07-2022.

(Copies of warning/explanation letters are attached as annexure-A, copy of inquiry report as annexure B, Charge Sheet through Principal as annexure C, Statement of allegation as annexure D)

6. Para No.6 is incorrect misleading against the facts, that the appellant often remained willful absent from her duty, the respondent department conducted an inquiry to dig out the realties. The inquiry officer recommended the penalty of removal/compulsory retirement from service, in the light of the above facts the competent authority duly severed a charge sheet along with statement of allegation but she did not submit reply to her charge sheet, after having considered the charges, evidence on record, facts of the case and keeping in view the recommendation of the inquiry officer the competent authority exercised the power conferred under E&D Rules and imposed major penalty of compulsory retirement upon the appellant.

While on the aforementioned grounds the department also rejected her department appeal.

7. Para No: 7 is incorrect misleading it is submitted that the appellant has no cause of action to knock at the door of this Hon'ble service tribunal.

REPLY TO GROUNDS

A: Ground-A&B is incorrect and misleading against the facts, the appellant was often remained willful absent from her duty. The competent authority served her various warning letters at different time period but she did not change her behavior, after fulfil all codal formalities and having considered the charge of willful absent, misconduct evidence on record, facts of the case and keeping in view the recommendation of



C: Ground C is incorrect and misleading the against facts, the instant service appeal does not fall in that nature of cases and the respondents did not violate any fundamental right of the appellant but they are bound to acted upon rules, law and policy.

D: Ground-D&E is incorrect misleading and against the facts, that the respondent department duly served a charge sheet along with statement of allegation to the appellant but she did not reply to them, after having considered inquiry officer recommendation and evidence on the record the respondent department take action against the appellant.

F: Ground-F the respondent department also seek permission to submit other Documents at the time of arguments.

It is therefore most humbly prayed that on acceptance of this Para wise comments, the instant service appeal may very kindly be dismissed with cost.

INQUIRY REPORT REGARDING MST. Noreen Nazli

PROBLEM REVIEWD

The following enquiry officer conducted a detailed enquiry in the light of the notification issued by the worthy DEO female Peshawar vide No 2447-48 dated 24/05/2022 regarding absent from duty of MST. Noreen Nazli sweeper of Gov't. Girls higher secondary School NISHTERABAD PESHAWAR (ANNEX I):

Data collection

Interview of both the principals and the abovementioned MST. Noreen Nazli has been taking place with the collections of documents regarding her job at the office of Principal GGHSS NISHTERABAD PESHAWAR.

Mode of proceedings.

The enquiry officer went to GGHSS NISHTERABAD PESHAWAR. On 27/05/2022 and interviewed concerned sweeper, Principal and office clerks.

Charge sheet

MST Samina Ghani herself has taken disciplinary action against MST. Noreen Nazli and put forwarded some statement of allegations against the respective sweeper. (ANNEX II)

1. You are disobedient/misbehaved and irregular in duties.
2. You used abusive language with the teachers and Principal.
3. You don't obey orders of your school Principal.

In light of the above facts MST Samina Ghani served her with the charge sheet and imposed major penalty of "Removal from Services" under Rule-4(b) III OF E & D rules 2011.

In order to further investigate this matter MST. Bilques Sethi was appointed as the enquiry officer, she has collected some relevant information regarding these allegations and provide some findings mentioned below. (ANNEX III).

The investigator reached the following findings

1. You are disobedient/misbehaved and irregular in duties.

This allegation was found correct as the same has been second by the Principal, and office Staff as well. Previous Principal has issued various show cause notices on different time periods yet she behaved the same (ANNEX III).

2. You used abusive language with the teachers and Principal.

This allegation was also found true in light of the different applications submitted by the students and the staff at the Principal office but the accused didn't accept this although staff members also confirmed her misbehavior. (ANNEX III & IV)

3. You don't obey orders of your school Principal

This allegation is also found true as the previous Principal has issued various notices against her but she was willing to cooperate with neither with the Principal nor with students or staff. (ANNEX III)


CONCLUSION

The problems mentioned by the principal and the respective DEO herself have definitely a proper weight and all are proven true in light of the in person investigation with the relevant documents attached with this report. MST Noreen Nazli although completely denied the fact and said that due to some her personal issues she was found absent but these issues are not of much serious concerned as her attendance record shown absentees from time to time. (ANNEX VI).

Yet with these absentees she has shown misconduct and false language with the Principal students and other staff member so how a professional personal come with this kind of unethical behavior.

She has been disposed to DEO OFFICE and her salary has been deducted from time to time under the IMU absentee notifications but she still kept on misconducting. (ANNEX VI-X).

Hence, on observations of all these allegations the enquiry officer representing following recommendations.




