RESPONDENT No. 1 to 3.

Respectfully sheweth:-

PRELIMINARY OBJECTIONS

1. That the Appellant is not the "aggrieved" person with the meaning of Article 212 of the Constitution of the Islamic Republic of Pakistan 1973.
2. That the Appellant has got no cause of action /locus standi to file this appeal because the Appellant did not come on merit.
3. That the Appellant has not come to this Honorable court with clean hands rather than the instant appeal is mainly based on malafide intentions just to put pressure on the respondent department for transfer/adjustment.
4. That the Appellant is estopped by his own conduct.
6. That the instant appeal suffers from laches, hence not maintainable in the present form.
7. That the petition in hand is badly barred by the relevant provision of Law/Rules/Policy in Field.

ON FACTS

- 1.** Para -1 of the facts is correct to the extent of the appointment of the appellant along with other candidates vide appointment order dated 10-09-2022, with the terms & condition that, No.17. If any meritorious candidate is deprived of appointment by this order, and the competent authority accepts her appeal appointment order of the low merit candidate will be withdrawn, and the adjustment order will be reviewed according to merit position."**(Copy of the appointment order dated 10-09-2022 is attached as "A")**.
- 2.** Para -2 of the facts is correct that the appellant was appointed and was posted as PST at GGPS Shahoor, with the condition No.17, mentioned in the Para-1 of the facts.
- 3.** Para-3 of the facts is incorrect, and further stated that after issuing of the appointment order dated 10-09-2022, a teacher named Mst. Nadia banoo having marks 90.512, filed a departmental appeal with the request that , she (Mst.Nadia Bano) is meritorious then the appellant , and seeks relief for placement at GGPS Shahoor instead of GGPS Sundrai. the appellate committee allowed/accepted her appeal and vide corrigendum order dated 17-10-2022, the appellant was re adjusted at GGPS Sundrai, while Mst. Nadia Bano was adjusted at GGPS Shahoor.**(Copy of the departmental appeal of Mst, Nadia Bano is attached as "B", copy of the corrigendum order dated 17-10-2022 is attached as "C")**.
- 4.** Para-4 of the facts is correct, and further stated that the appellant filed an appeal to the worthy Minister of E&SE, for redressal of her grievances, and on the recommendation of the worthy Minister E&SE, the appellant order was restored and

she was readjusted at GGPS Shahoor vide order dated 15-04-2023. (**Copy of the appeal of appellant to Worthy Minister E&SE is attached as "D", Copy of the order issued on the directions of the Minister E&SE is attached as "E"**)

5. Para-5 of the facts is also correct, and further stated that the appellant was regularized at GGPS Shahoor, because department always regularized, teachers who are serving at the time on the basis of 1st appointment order, and the appellant was placed at GGPS Shahoor, that's why she was regularized into service on the ibid school.
6. Para-6 of the facts is incorrect, and further stated that; resident/notable of the society filed a complaint regarding the transfer of the appellant. The worthy deputy commissioner, direct the respondent No.3, to retain the appellant at GGPS Sundrai, on the directions of the Deputy Commissioner Dir Upper, the appeal order dated 15-04-2023, was withdrawn vide order dated 08-05-2023, by adjusting the appellant back, at GGPS Sundrai. it is also pertinent to mention here that w,e,f 08-05-2023, the appellant is absent from duty till date, in this regard disciplinary action against her has been initiated as per law and rules. (**Copy of the appeal from the resident of the Area is attached as "F", copy of the order issued as per direction of the DC Dir Upper is attached as "G" Copies of the show cause notices/explanations/ letter for personal Hearing is attached as "H"**)
7. Para-7 of the facts pertains to record, needs no comments.
8. Para-8 of the facts is the reputation of the above para,s, however it is further stated that the competent authority/appellate authority have the power to allow or regret appeal of the appellant, and adjust any candidates anywhere as per law, rules and policies.

9. Needs No comments.

GROUNDS

A) In correct and not admitted .the stand of the Appellant is without any moral and legal justification on the grounds that the appellant was appointed as PST with the terms and conditions mentioned in the appointment order dated 10-09-2022.and the appellant by accepting the terms and conditions of the appointment order dated 10-09-2022, took over charge. Thus she is bound to obey rules/directions/policies instead of wasting of her precious time.


5. They should not be handed over charge if their age exceeds 35 years or falls below 18 years of age.
6. Appointment is subject to the condition that their certificates/documents will be verified from the concerned authorities by the undersigned, anyone found producing bogus certificates or degrees their appointment shall be cancelled and they will be reported to the Law enforcing agencies for further legal action.
7. Their services are liable to termination on one month's prior notice from either side. In case of resignation without notice their one month pay/allowances shall be forfeited to the Government treasury.
8. Their pay shall not be released till the verification of their documents from the concerned boards/university or institutions.
9. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
10. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
11. Their services shall be terminated at any time in case of their performance is found unsatisfactory during their service period. In case of misconduct, they shall be proceeded under the relevant rules & regulations announced from time to time.
12. Their appointment is Ad hoc and school based. They shall have to serve at their place of posting and their services are not transferable to any other station.
13. Before handing over charge to them, their documents may be checked and if found bogus or fake they may be reported to this office for necessary action.
14. All the SDEOs are required to collect an affidavit from each candidate that she will follow all the terms and conditions listed above and will keep it on record.
15. Errors and omissions will be acceptable within the specified period.
16. The appointees are bound to take 9th months mandatory training at DPD or RPDC.
17. If any meritorious candidate is deprived of appointment by this order, and the competent authority accepts her appeal appointment order of the low merit candidate will be withdrawn, and the adjustment order will be reviewed according to the merit position.

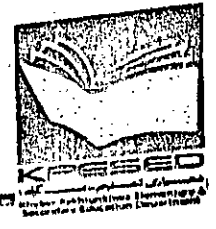

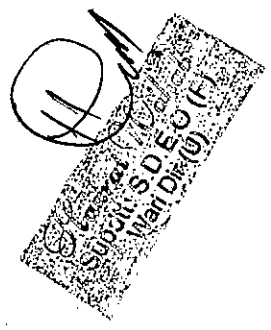



Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present writ petition are as under:

- 1- That appellant is the law abiding citizen of Pakistan and was initially appointed as Adhoc PST vide order dated 10-09-2022 in GGPS Shawoor Bala. Copies of the CNIC and appointment order are attached as annexure **A&B.**

- 2- That in pursuance to the mentioned order the appellant was posted as PST (BPS-12), and assumed the charge. Copy of the arrival report is attached as annexureC.
- 3- That astonishingly vide corrigendum dated 17.10.2022, the appellant was transferred from the GGPS Shahwoor Bala to GGPS Sundrai. Copy of the Corrigendum is attached as annexureD.
- 4- That it is pertinent to mention here that vide notification dated 14.12.2022 the appellant was regularized in GGPS Sundrai. Copy of the notification dated 14.12.2022 is attached as annexureE.
- 5- That vide order dated 15.04.2023 the appellant was restored/adjusted again in her previous station i.e. GGPS Shahoor Bala in her own pay and scale and on 15.04.2023 the appellant assumed the charge at GGPS shawoor bala. Copy of the office order dated 15.04.2023 and charge report are attached as annexure F&G.
- 6- That surprisingly once again vide impugned order dated 08.05.2023, the order dated 15.04.2023 was withdrawn and the appellant was transferred from the GGPS Shahnoor to GGPS Sundrai. Copy of the office order dated 08.05.2023 is attached as annexureH.
- 7- That appellant feeling aggrieved from the frequent transfer orders and from the impugned order dated 08-05-2023 preferred departmental appeal on 17-05-2023 before the appellate authority. Copy of the Departmental appeal is attached as annexureI.
- 8- That by not deciding the departmental appeal the appellant approached Peshawar High Court in writ petition No. 371-M/2023 and during the pendency the appellate order dated 03.07.2023 was issued whereby the departmental appeal of the appellant was regretted with no good reasons. Copy of the appellate order dated 03.07.2023 is attached as annexureJ.
- 9- That the appellant having no other remedy but to file the instant appeal on the following grounds amongst the others.

GROUND:

- A- That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 are against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.

- C-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023, have been issued by the respondent No.3 in arbitrary and mala fide manner, hence not tenable and liable to be set aside.
- D-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 is based on discrimination, favoritism and nepotism, hence not tenable in the eye of law.
- E-** That the impugned order dated 08-05-2023 and appellate order dated 03.07.2023 have neither been in the best interest of public service nor in exigencies of service, hence not tenable and liable to be set aside.
- F-** That the impugned order dated 08-05-2023, is violative of Clause-I, IV and XIII of the transfer/posting policy of the Government of Khyber Pakhtunkhwa. Copy of the transfer/posting policy is attached as annexure **K.**
- G-** That appellant seeks permission to advance other grounds and proofs at the time of hearing.

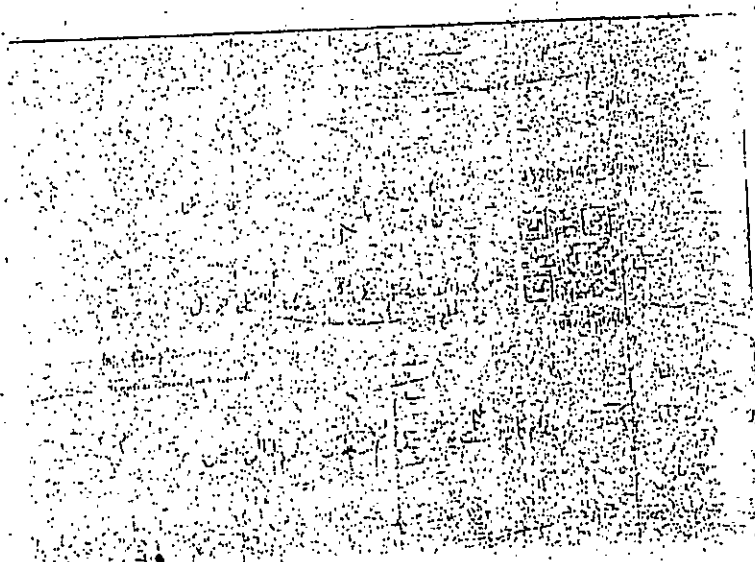

POSTING / TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posing/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) The normal tenure of posting shall be three years subject to the condition that for the officers/officials posted in unattractive areas the tenure shall be two years and for the hard areas the tenure shall be one year. The unattractive and hard areas will be notified by the Government.
- v) { }
- vi) While making postings/transfer from settled areas to FATA and vice-versa, specific approval of Governor, NWFP needs to be obtained

²While making postings/transfers of officers/officials up to BS-17, from settled areas to FATA and vice-versa approval of the Chief Secretary NWFP needs to be obtained. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor NWFP shall be obtained.
- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.
- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

- xiii) While considering posting/transfer proposals all the concerned authorities shall keep in mind the following:
- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

- i) Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule - IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

S. No.	Officers	Authority
1.	Posting of District Coordination Officer and Executive District Officer in a District.	Provincial Government.
2.	Posting of District Police Officer.	Provincial Government
3.	Other Officers in BPS-17 and above posted in the District.	Provincial Government
4.	Official in BPS-16 and below	Executive District Officer in consultation with District Coordination Officer.

3. As per Rule 25(2) of the Rules, mentioned above the District Coordination Department shall consult the Government if it is proposed to:

- a) Transfer the holder of a tenure post before the completion of his tenure or extend the period of his tenure.
- b) Require an officer to hold charge of more than one post for a period exceeding two months.

4. I am further directed to request that the above noted policy may be strictly observed /implemented.

All concerned are requested to ensure that tenures of the concerned officers/officials are invariably mentioned in summaries submitted to the Competent Authorities for Posting/Transfer.

It has been decided by the Provincial Government that posting/transfer orders of all the officers up to BS-19 except Heads of Attached Departments irrespective of grades will be notified by the concerned Administrative Departments with prior approval of the Competent Authority obtained on the Summary. The Notifications/orders should be issued as per specimen given below for guidance.

All posting/transfer orders of BS-20 and above and Heads of Attached Departments (HAD) shall be issued by the Establishment Department and the Administrative Departments shall send approved Summaries to E&A Department for issuance of Notifications.
