

REPLY ON BEHALF OF RESPONDENTS NO 5 TO 9

Respectfully Sheweth:-

It is submitted as under:-

PRELIMINARY OBJECTIONS:-

- A) That the Appellant has no cause of action/locus standi to file the instant appeal.
- B) That the appeal in hand is hopelessly time barred.
- C) That the appeal is not maintainable in its present form and it is liable to dismissal.
- D) That the Appellant has not come to the Tribunal with clean hands and the appeal has been filed with mala-fide intention to harass the replying respondent.
- E) That this Honourable Tribunal has no jurisdiction, therefore, the appeal may kindly be dismissed with compensatory cost.

ON FACTS:-

- 1) Need no reply.
- 2) Need no reply.

- 3) Para No 3 of the appeal is correct to the extent that as per notification dated 02-08-2012, the Appellant was upgraded to BPS-12, but unfortunately the Appellant forgo the up-gradation by not taking charge of the post of Senior Clinical Technician (Cardiology) at LRH, Peshawar
- 4) Para No 4 of the appeal is incorrect, hence denied. As the Appellant did not acknowledged the notification dated 02<sup>nd</sup> August, 2012, therefore, the Appellant was in BPS 9 at the time of notification dated 11-08-2015, hence comes under para 1 of the notification was upgraded to BPS-12. Moreover, service book of the Appellant was in BPS-9 at the time of said notification.
- 5) Para No 5 of the Appeal is wrong, incorrect and has no effect on the Answering Respondents. The details reply has been given in the above paras.
- 6) Para No 6 of the appeal is incorrect, hence denied. The Appellant was rightly promoted vide order dated 27<sup>th</sup> April, 2020 for the reason that at the time of said notification, the Appellant was in BPS-12. Moreover, the Appellant have accepted the promotion to BPS-14 and never approached the Respondent's department for the claim before this appeal.
- 7) Para No 7 of the appeal is also incorrect and wrongly drafted. The Appellant was rightly made promoted to BPS-

16, for the reason as per law the Appellant deserved to be promoted BPS-16.

- 8) Para No 8 of the appeal is incorrect and illegal, hence denied. The Appellant remained silent for a considerable time, therefore, impliedly accepted the earlier promotions timeline.
- 9) Para No 9 of the appeal is also wrong, hence vehemently denied. The vacancy cannot be filled at the whim and wishes of Medical Superintendent; rather on merits by competent authority.
- 10) Para No 10 of the appeal is incorrect, hence denied. The Appellant is not entitled for the claim, for the reason earlier promotion orders were not challenged within time.
- 11) Para No 11 of the appeal needs no reply.

GROUNDS:-

- A) Ground A is incorrect. The details reply has already been given in the above paras.
- B) Ground B is wrong and no violation has been committed of any provision of law.
- C) Ground C is incorrect. Moreover, it does not relate to replying respondent.
- D) Ground D is incorrect. It does not relate to Replying Respondent.
- E) Ground E is incorrect.


F) Ground F is incorrect and irrelevant to Replied Respondent.
