- 4. The appellant is estopped by her own conduct to file the present appellant u/s 12(2) CPC.
- 5. The present appeal is against the prevailing law and rules hence not maintainable in the eye of law.

On Grounds:

- B. Incorrect, the appellant is not an innocent person but was guilty being negligent therefore, the penalty was awarded to him as per law.
- C. Incorrect, the facts finding committee discussed each and everything and therefore the appellant was awarded penalty for withholding annual increment for one year.
- D. Incorrect mis-statement and hence denied. The appellant was guilty of negligence.
- E. Incorrect, the leaking of paper by itself is an evidence of negligence on the part of appellant which is not justifiable nor excusable by law.
- F. Incorrect, the detail reply is given in the above para's.
- G. Incorrect, the penalty on appellant is in accordance with law and nothing is illegal in it.

INTRODUCTION

The Govt. of Khyber Pakhtunkhwa Elementary and Secondary Education, initiated a fact finding inquiry on the charges of leaking of English Paper Class 10th in SSC Annual Examination 2019 for BISE, Kohat The Committee submitted its report and responsibility was fixed on two officers 1 officials of the Department i.e. Mr. Waqar Ahmad (BPS-18) Ex-Control er of Examinations and Mst. Farzana SCT (BPS-16) GGHS Nari Panoos Karak.

The Competent Authority i.e Chief Secretary Khyber Pakhtunkhwa served Charge Sheet, to both the accused separately under Efficiency and Discipline Rules 2011 based on the fact finding inquiry.

The accused officer / officials were informed through written letter No. HD/PA/AC(PER)/P/2019 dated Peshawar the 11th February 2020, to appear report before the Inquiry Committee on 18 2-2020 at 11.00 AM. (Annexure B) Mr. Wagar Ahmad the Ex-Controller of Examinations appeared and the Charge sheet was placed before him. While Mst Farzana SCT did not confirm her attendance. Mr. Waqar Ahmad was asked to submit his written reply which he did not do before. Another arrangement was made at BISE, Kohat for the connivance /facilitation of accused and provision of documents required for the inquiry proceedings. They were again informed through written letter vide No. 19/PA/BISE-B/2020 dated 19-2-2020 to appear before the Committee on 19-2-2020 at 10.00 AM. (Annexure-C) Both the accused officers appeared before the committee in the office of the Chairman BSE, Kohat . Both of them also submitted their written defence. They were given ample time to plead the Charges leveled against them. All the replies were Cross -examined through questioning in the light of available fact and

CONCLUSION.

Two main issues surfaced during this whole inquiry proceedings. One is related to appointment of Mst Farzana SCT BPS-16 as Superintendent GGHS Nari Panoos Karak. This issue is confronted by all the Boards of Intermediate and Secondary Education in hard and backward areas in Khyber Pakhtunkhwa especially in female supervisory staff and all the Boards go out of turn and violate the draw and shadow draw as well as Gove instruction time to time. The Education Department is equally responsible for not taking disciplinary action and creating space to these teachers/Heads who are appointed through draw/shadow draw and refuse to perform duties at Eleventh hour. The BsISE therefore taking all possible options to conduct the examination. The Controller of Examinations may not be maligned for any appointment which can ensure the smooth conduct of examination.

Second major issue is the reliance of all BISEs on National and Commercial banks, the institutions who are shouldered a responsibility without direct hold on them. This system needs a structural change /transformation so that any breach of system have a built in mechanism for discouraging all these male practices.

Keeping in view these issues it is concluded that an illwill at the part of a single member i.e Superintendent Mst Farzana in the system will bear the cost of another institution i.e Habib Bank Limited Nari Panoos Karak Branch which is equally responsible but not under the control of BISE Kohat or Elementary and Secondary Education.
