#### RESPECTFULLY SHEWETH:

#### **FACTS**

- 1. That the appellant was appointed is respondent department and performing his duties with entire satisfaction of his superior.
- 2. That the appellant has completed all the requisite/mandatory and professional training and courses including intermediate course in year 2012 along with his bathmats. Copy of the courses certificate order is attached as annexure-A.
- 3. That in the year 2016 the department issued standing order no; 02/2016 wherein all the police officials working in central units consider on deputation and their lien was transferred to their concerned district. Thereafter, the lien of the appellant was also transferred to parent district. But posted at Peshawar. Copy of standing order and posting order is attached as annexure-B & C.
- 4. That thereafter, the appellant was promoted as Officiating ASI w.e.from 17/09/2019 vide order dated 20 September 2019. The appellant was confirmed in the rank of ASI we.from 17/09/2021 and promoted to List E vide order dated 31/01/2022. Copy of the orders are attached as annexure-D & E.
  - 5. That thereafter the appellant got knowledge about his batches whom were promoted to List E in the year 2018, thereafter the appellant filed departmental appeal dated 14/02/2022 for proper seniority and confirmation with his batchmats. The appeal of the appellant was

seen and filed by authority on 23/08/2022 but the rejection was not handed over to the appellant. Copy of the list and departmental appeal is attached as annexure-F & G.

6. That now the appellant come to this Hon'ble Tribunal for his claim on the following grounds amongst others.

#### **GROUNDS:**

- A) That not considering the appellant for confirmation as ASI with his batchamates and rejection order is against the facts, law, rules, norms of Justice and fair Play therefore liable to be set aside.
- B) That the appellant was deprived from his rights of promotion in an arbitrary manner which is the violation of Article-2,4 and 25 of the Constitution of Pakistan.
- C) That the appellant was entitled for confirmation w.e.f from his batchmates / juniors were promoted but he was deprived from his legal and constitutional right for the fault of others.
- D) That the standing order is silent about the seniority provision and there is not deprivation of seniority in the standing order but department malafide deprive the appellant from seniority and kept him on bottom. Which is illegal and against the law and rules.
- E) That the appellant was entitled for Seniority and position with their batch mates according to superior court judgment but he was deprived from his legal and constitutional right for the fault of others.
- F) That according to Superior Court Judgment reported as 1997 SCMR 515 in which it is held that delay in making promotion had entirely due to reason that officer of that department not carry out fairly simple exercise with reasonable period so the appellant is entitled to the promotion from back date.
- G) That it is well settled principle of justice that no one should be suffered from the arbitrary acts of public functionaries and the public functionaries are required to act in accordance with rules and law with fair means. But in case of appellant such principle has been violated.
  - H) That the appellant was not treated according to the law and rules and deprive from the legal right of the promotion.

I) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant maybe accepted as prayed for.

## STANDING ORDER NO. 02/2016 Quotas of Districts in Central Units

This Standing Order is issued under Article 10(3) of Police Order 2002 and in pursuance of the Police Policy Board decision taken in its 20th meeting held on 15

- Aim: This Standing Order aims at fixing the contributory quota of District and Regions in the executive strength of the Central Units.
- Existing Sanctioned Strength in Rank as determining Factor: (1)The executive strength from Constable to Sub-Inspector of all Central Units including Frontier Reserve Police, Elite force, Central Police Office, Special Branch, Traffic Khyber Pakhlunkhwa, CPC Investigation, Central Police Office, PQR and Training Schools and College will be provided by the Police Districts/Regions of the Province in accordance with the ratio of their existing sanctioned strength in overall sanctioned strength for each rank as detailed in attached
- (2) CTD Strength will be determined as per their requirement and deployment plan which has already been approved and issued vide CPO letter No. 3229-80/E-II date:
- Recruitment, Promotions in Central Units:- Recruitment and promotion in the ranks from constable to Sub-Inspector will be carried out and be regulate in concerned Districts and Regions, only. Central Units will neither recruit nor promote any officer unless is specifically provided and allowed. All personnel serving in the central Units will be zdeputation from concerned Districts and Regions and their lien will be in their parents District/Region. If in the past any recruitment has been carried out directly in the central units and lien of such recruits has not been fixed so far; it will be fixed in District of domicile of the concerned recruit. Furthermore for retirement purposes personnel will be posted back -their parent Districts.
- Tenure:- The period in the central unit will be considered on deputation in TE meaning of Police Rules and shall not exceed 03 years.
- Application:- This Standing Order will come into force with immediate effect and transition to this scheme of things will not be at once but be in phased manner subject to occurrence of vacancies in central units and capacity of the contributing Districts contribute as per quota in due course of time.
- Power to remove difficulties:- If any difficulty arises in giving effect to this order. Provincial Police Officer may by notification make such provisions as deemed appropriate
- Amendment: All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.





#### PRELIMINARY OBJECTIONS

- i. That the appellant has not approached this Hon'ble Tribunal with clean hands.
- 2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
- 3. That the appellant has got no cause of action or locus standi to file the instant appeal.
- 4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
- 5. That the appeal is unjustifiable, baseless, false and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.
- 6. That the appeal is bad for miss-joinder and non-joinder of necessary parties.

#### Reply on Facts

- 1. Para to the extent of enlistment in Police Department pertains to record needs no comments. While rest of para is incorrect, because every Police Officer is under obligation to perform his duty upto the entire satisfaction of his superiors.
- 2. Para to the extent of completion of requisite/mandatory and professional trainings pertains to record needs no comments.
- 3. Correct to the extent that Standing Order No. 02/2016 was issued according to which Regions/Districts have been accorded share in different ranks in Central Units.
- 4. Correct to the extent that the appellant was promoted as officiating ASI in the Departmental Promotion Committee meeting held in Region Office Mardan dated 20.09.2019 and subsequently confirmed in the same rank after fulfillment of all legal and codal formalities including completion of probation period as enunciated in Police Rules 1934 Chapter 13 and his name was brought on promotion list "E" with immediate effect.
- 5. Para to the extent of getting knowledge by the appellant regarding promotion of his batch is not related needs no comments while para regarding filing application is correct as the application of the appellant was received by the office of respondent No. 04 but iten of the appellant was attached to Mardan Region vide Central Police Office Peshawar order No. 2274-76/E-IV dated 24.02.2016 with the condition of according bottom seniority while placing his name on promotion list "D". Hence, the appellant was promoted as officiating Assistant Sub Inspector and subsequently confirmed in accordance with order of merit/seniority. However, para to the extent of not handing over the rejection

- order to the appellant is not plausible rather he has taken this plea just to save his skin from the issue of limitation.
- 6. That appeal of the appellant is liable to be dismissed on the following grounds amongst the others.

#### REPLY ON GROUNDS:

- A. Incorrect. Stance of the appellant is totally devoid of merit because the appellant has been promoted to the rank of officiating ASI in accordance with his seniority accorded to him in light of lien transfer order, hence the same is in accordance with facts, law, rules, norms of justice and fair play therefore the same is liable to be maintained.
- B. Incorrect. Plea taken by the appellant is totally ill based as discussed earlier he has been promoted on account of his turn.
- C. Para already explained needs no comments.
- D. Incorrect. The appellant has not been deprived of any of his right because the respondent department has no grudges against him.
- E. Para explained earlier needs no comments.
- F. Plea taken by the appellant is not plausible because every case has its own facts and circumstances, therefore, the instant issue does not fall within the ambit of judgment mentioned by the appellant.
- G. Para already explained needs no comments.
- H. Plea taken by the appellant is bereft of any substance.
- I. The respondents also seek permission of this honorable tribunal to adduce additional grounds at the time of arguments.

#### PRAYER:-

Keeping in view the above narrated facts, it is most humbly prayed that the appeal of the appellant being badly barred by law and limitation, may kindly be dismissed with costs please.
