#### Preliminary Objections

- I. The appellant has no locus standi to file the Appeal in hands.
- II. That the appellant has concealed material facts from this Hon'able Court hence the Appeal in hands is not maintainable.
- III. The appointment order of the appellant was not in accordance with the prescribed manner as provided in the Appointment and Promotion rules.
- IV. That the appeal is badly time barred.
- V. That the appellant has been estopped by his own conduct to file the instant appeal.
- VI. That the appellant has no cause of action.
- VII. That the Hon'able Tribunal has no jurisdiction to entertain the appeal.
- VIII. That the appellant has no come to the court with clean hands.

#### **Facts**

- 1. Incorrect. The appointment order dated 03/11/2012 was not according to the strict codal formalities as it was made in undue haste. A lecturer in (BPS-17) has issued the appointments orders which fall beyond his jurisdiction. Above that this committee has interviewed all these 11 candidates and issued their orders on the same day to the extent that they have taken their charge of offices. Furthermore, a thick cloud of malafide is visible as evident from the inquiry report dated 26/11/2012(Annexure-A) wherein three main objections have been raised by the Inquiry Officers:
  - i. There is a variation between the date of requisition of the College Administration for the candidates i.e. 08/10/2012 and provision of the candidates by employment exchange Bannu i.e. 02/10/2012. Another disputed point is that the Manager Employment Exchange, Bannu only sent the same names of those 11 candidates who were later on appointed. However in the eyes of law and procedural experiences he should have sent more than 11 candidates.
  - **ii.** No call letters to candidates were issued, which is pre- requisite for such like appointments.
  - iii. The DDO being a lecturer in BPS-17 and not an officer of category-II is not competent to issue these appointments orders.
- Incorrect. The DDO concerned was informed to held in abeyance the appointment orders vide Endst No.SO (COLLEGES-II)28-1/2012 dated 05/11/2012<sup>48</sup> per Annexure-D of the appeal.
- **3.** Incorrect. The pay was stopped due to the gross irregularities reported to the Provincial Government in the appointments of the appellants.
- 4. Incorrect. His Departmental appeal has been considered and filed being meritless.

#### <u>Geounds</u>

- **A.** Not admitted. The action of the Respondents is legal, lawful and in the best interest of public.
- **B.** Not admitted. The appellant is trying to misguide the Court by claiming that he is still performing his duties but, in Para-2 of the Departmental appeal he himself admits that the DDO has stopped his salary and cancelled his appointment order. According to the inquiry report (Annexure-A) supra the appointments orders are made purely on temporary basis and are liable to termination at any time with out any notice or assigning any reason.





## **Preliminary Objections**

- I. The appellant has no locus standi to file the Appeal in hands.

# Facts

i.

1. Incorrect. The appointment order dated 03/11/2012 was not according to the strict codal formalities as it was made in undue haste. A lecturer in (BPS-17) has issued the appointments orders which fall beyond his jurisdiction. Above that this committee has interviewed all these 11 candidates and issued their orders on the same day to the extent that they have taken their charge of offices. Furthermore, a thick cloud of malafide is visible as evident from the inquiry report dated 26/11/2012(Annexure-A) wherein three main objections have been raised by the Inquiry Officers:-

There is a variation between the date of requisition of the College Administration for the candidates i.e. 08/10/2012 and provision of the candidates by employment exchange Bannu i.e. 02/10/2012. Another disputed point is that the Manager Employment Exchange, Bannu only sent the same names of those 11 candidates who were later on appointed However in the eyes of law and procedural experiences he should have sent more than 11 candidates.

3- Govt Degree College Landi Jalandar Bannu :- According to available record and statement of the DDO/, Incharge Principal Mr. Ahmad Raza Lecturer in Political Science, there are eleven vacant. Posts consisting of 3 Lab attendant, 2 chowkidars, 2 Naib Qasid, 2 sweepers, 1 Mali and 1tube well operator. A letter was sent to the Manager Eployment Exchange Bannu on 08-10-2012(Annex-G) asking for the provision of suitable candidates and DCO for NOC on the same date (Annex-H)but the List of 11 persons had sent by Manager employment Exchange Bannu on 02-10-2012, prior to the requisition (Annex-I). The DCO, however, granted NOC on the same date(Annex-J). Interview was conducted on 03-11-2012 at 12.30 P.M. and the following persons conducted the interview.

No call letter for the interview was issued to candidates nor it was published through local notice. However all of the 11 cndidates were selected, their appointment orders were issued on the same date i.e. 03-11-2012, they were handed over charge of their duties inspite of the facts that only 7 persons had submitted their Medical fitness.

Therefore the following discrepancies are pointed out;

There is a variation between the date of requisition of the college administration for 1 the candidates i.e. 08 10 2012, and provision of the list of candidates by Employment-Exchange Bannu 1.e. 02-10-2012. Provision before requisition establishes malafide.

No call letter to the candidates was issued to appear for interview but all were 2i., present for.

The Employment Exchange Bannu provided a list of exactly 11 candidates so that 3selection committee had no option but to select all. This aspect of the case also speaks of malafide and intransparancy of the process.

It is worth mentioning that interview started on 03-11-2012, at 12.30 , completed the 5process on the same day and appointment orders issued on the same day too. Therefore, such hasty decisions, shows pre planning.

It is noted from the record of Higher Education Department that Mr. Muhammad 6-Zaman Deputy CPO was nominated for the said college (Annex-K) and then Mr. Habibur Rehman was nominated(Annex-L).

It has been written in the appointment orders that "The appointments are being made on purely temporary basis and is liable to termination at any time without notice and without assigning any reason." Therefore it is recommended that appointment orders of all the 11 person issued vide No.190-96 dated 03-11-2012 at Govt Degree College Landi Jalandar Bannu (Annex-M)may be cancelled and it may be reprocessed to maintain transparency in appointment pariticularly in view of the intransparancy in the process of selection and constitution of improper selection


