JUDGMENT

MUHAMMAD AAMIR NAZIR, MEMBER: Pervez Khan, PSHT GPS Muhammad

Khan Korona, Tehsil and District Nowshera, hereinafter referred to as appellant, through the instant appeal under section-4 of Khyber Pakhtunkhwa Service Tribunal Act 1974, has impugned order dated 22.11.2013 vide which the appellant was transferred to GPS Muhammad Khan Korona while private respondent No.3 was retained in GPS, PAF Academy Risalpur against the government policy.

2. Brief facts of the case giving rise to the instant appeal are that the appellant was initially appointed as Primary School Teacher in the year 1992. That as per promotion list for PSHT(BPS-15) issued on 12.04.2013, appellant was at S.No. 349 whereas private respondent No.3 at S.No. 352. That a result of up-gradation, appellant was promoted as principal in the same school i.e GPS, PAF Academy Risalpur while private respondent No.3 was transferred to GPS Muhammad Khan Korona Risalpur. That subsequently vide impugned order dated 22.11.2013 respondent No.3 Waqar Ahmad was given seniority and was transferred to GPS PAF Academy Risalpur while appellant was transferred to GPS Muhammad Khan Korona. That Feeling aggrieved, the appellant submitted departmental appeal which was not responded within statutory period, hence the instant appeal.

3. Learned counsel for the appellant argued before the court that as per Government policy, if two teachers serving in the same school are promoted to the higher rank, the teacher who is senior would be retained in the same school and the teacher junior in seniority would be transferred out to some other school. That as per seniority list available on file as Annex:C the appellant ranked senior to private respondent No.3. However, the respondent No.1 was mala fide given seniority to respondent No.3 vide impugned order dated 22.11.2013. That after promotion the appellant was transferred out to GPS Muhammad Khan Korona while respondent No. 3 was retained in the same school which is against the government policy. That the appellant has filed departmental appeal in this respect but of no avail, hence by acceptance the instant appeal the impugned order be cancelled and the appellant be allowed to performed his duties in his previous school i.e GPS, PAF Academy Risalpur.

4. On the contrary, learned Government Pleader assisted by counsel for private respondent No.3 argued before the court that after issuance of seniority list, private respondent No.3 submitted an application for rectification of seniority. That a proper enquiry was conducted and after enquiry a corrigendum was issued on 01.10.2013 vide which the private respondent No.3 was ranked senior to the appellant and after promotion he was adjusted in GPS PAF Academy Risalpur. That since the private respondent No.3 was senior to the appellant, therefore,

corrigendum was issued and private respondent No.3 was adjusted in GPS, PAF Academy Risalpur. That there is no violation of transfer policy and the impugned order is in accordance with law, hence the appeal be dismissed.

5. We have heard arguments of learned counsel for the appellant and learned Government Pleader for the respondents and have gone through the record available on file.

6. Perusal of the case file reveals that the appellant and respondent No.3 were serving in the same school i.e GPS, PAF Academy Risalpur. In the meanwhile, a seniority list of Senior Primary School Teacher, was issued on 12.4.2013 wherein the appellant was placed at S.No.349 while respondent No.3 was placed at S.No.352. Feeling aggrieved from the seniority list, respondent No.3 submitted an application for rectification of seniority. Consequently, an enquiry was ordered and after a thorough enquiry, it was held that as per documentary proof provided by respondent No.3 he shall rank senior to the appellant vide corrigendum dated 01.10.2013. Subsequently, impugned order dated 12.11.2013 was issued vide which private respondent No.3 who ranked senior to appellant was retained as PSHT, GPS, PAF Academy Risalpur while appellant was directed to take charge as PSHT, GPS Muhammad Khan Korona, Risalpur. It is quite evident from the record that as a consequence of enquiry, private respondent No.3 ranked senior to the appellant, hence as per Government policy he was retained in the same school as PSHT whereas the appellant who became junior, was posted out to another school i.e. GPS Muhammad Khan Korona, Risalpur. Since, there is no substance in the present appeal, therefore we are inclined to dismissed the appeal in hand. Parties are left to bear their own costs. File be consigned to the record room.

It is s submitted as under

1. That the Appellant was appointed as primary school teacher (PST) ON 14/03/1992 .annex (A)
2. That on 12/04/2013 through letter no 1817-22 the respondent no 1 issued the

list PB 14 in which the Appellant is on 359 while the respondent no 3 waqar ahmad raza is on 362 number the se list is annex (B)

3. That on the 12/04/2013 the promotion list for HPST 15 were issued by the respondent no1 in which the appellant is on 349 number while respondent no 3 is on 352 number the list is annex(C)
4. That the Appellant due to up gradation was promoted in the same school as principal of govt primary school PAF Academy Risalpur while the respondent no 3 was transferred to govt primary school muhamad Khan korona risalpure nowshera.
5. That on 13/09/2013 letter no 5236-40 the respondent no 1 issued ordered vide in which the appellant on 14/09/2013 promoted and taken charge as HPST the order and charge report is annex(D.E).
6. That before up gradation to BPS 15the Appellant and respondent no 3 were in the same school
7. That the respondent no 3 was discharged/releaved according to law/rules on dated 28/09/2013.
8. That the appellant against the order No. 5624/28 DATED 01/10/2013 moved an appeal/application and the respondent no 1 order on the application dated 22/11/2013which is annex (F;G.H)
9. That the impugned order/endorsement is totally against the law and fact and is yet to be sustainable in the following grounds,

GROUNDS

- a. That the respondent no 1 by issuing the impugned order /endorsement has acted illegally and against the law and justice and prescribe rules law about promotion..
- b. That the respondent no 1 order is the result of miss reading and non reading hence liable to be set aside.
- c. That the illegal proceedings of order may be justified in the eye of law.
- d. That the impugned order /endorsement is based on malafidy and is an attempt to favour the respondent no 3 through unjustified and illegal means for unlawful consideration.


- e. That the Appellant is senior from respondent no 3 and in this regard the relevant orders by the competent authority were issued time by time and in accordance with law, such fact was utterly ignored by the respondent no 1 at the time of issuing the order/endorsement in question .
- f. That the impugned order/endorsement has affected the valuable rights of petitioner without any legal justification therefore liable to be set aside.
- g. That prior to filing this /appeal the respondent no 1 was approached through form written application and the respondent no 1 made an illegal order hence liable to be set aside .

It is therefore humbly prayed that on acceptance of this appeal both the impugned order /endorsement may kindly be set aside and the appellant be allowed to work in the previous school PAF Risalpur and the seniority of the appellant may be maintained accordingly.

Any other relief may deemed fit in the circumstances of the fact may also be granted in favour of the Appellant.

The following PTC trained candidates are hereby appointed as PTC teachers on Rs:1095/-PM in BPS NO:7 of Rs:1095-60-1995 plus usual allowances as admissible under the rules with effect from the date of their taking over charge in the school noted against their names under the following terms and conditions:-

CONDITIONS.

1. Charge reports in duplicate should be submitted to all concerned.
2. No joining time is allowed except what is absolutely necessary for transit.
3. No TA/DA is allowed being First appointment.
4. The appointment is purely on temporary basis and subject to the termination at any time without assigning any reasons or prior notice.
In case they wish to leave the post they shall have to submit one month's prior notice in lieu thereof one month's pay will be forfeited to the Government of NWFP. Their Educational qualifications should be checked before the handing over the charge of the post.
5. They should produce their Health and Age certificate from the Civil Surgeon concerned within Seven days of reporting arrival for duty as required under the Rules (F.R.10 S.R.4).
6. In case the candidate fails to take over the charge within 10 days from the date of issue of this letter their appointment will stand cancelled automatically.
7. The verification roll of character and antecedent should be obtained from the candidates concerned on the prescribed form and submit to this office for further verification and record.
8. The candidate should not be handed over the charge, if their ages does not between 18-25 years.
9. They should execute necessary security bond in case they are required to handle Government money or property.
10. The pay scale and Service Rules would be subject to revision in accordance with orders to be passed by the Government of NWFP from time to time.
