Respectfully Sheweth:

1. That appellant has in her credit the educational qualification of PTC and M.A (Islamiyat) in her credit passed with distinction. (Copy as annex "A")
2. That after the advertisement of the posts of the PST and by going through the prescribed method of recruitment, on the recommendation of District Selection Committee, appellant was appointed as Primary School Teacher (F) on regular basis against the vacant post. Her name was figured at serial No. 16 of the appointment order dated 25.02.2011 of respondent No. 1. (Copy as annex "B")
3. That on 26.02.2011, charge of the said post was assumed at G.G.P.S, No. 2, Shakh Quli Khan. (Copy as annex "C")
4. That on 28.02.2011, Medical report was carried out by M.S, DHQ Hospital, Lakki Marwat. (Copy as annex "D")
5. That appellant used to attend the school daily since February 2011 but her monthly salaries were with held till November 2012. Thereafter she was paid her monthly salaries since December 2012 till May 2013. (Copies from Register Attendance of Treacherouses as annex "E")
6. That on 12.04.2012, appellant filed civil suit before the court of Senior Civil Judge, Lakki Marwat, for release of monthly salaries with held since February 2011 till December 2012 and then on 21.05.2012 the same were ordered to be released to appellant. (Copies as annex "F" & "G")
7. That on 28.05.2012, appellant submitted representation before respondent No. 1 for release of her monthly salaries on the basis of the judgment dated 21.05.2012 of the learned Civil Judge, Lakki Marwat. (Copy as annex "H")
8. That feeling aggrieved of the Judgment dated 21.05.2012, the department filed appeal before the District Judge, Lakki Marwat; which was accepted on 30.10.2012 by setting aside judgment

- and decree of the learned Civil Judge with direction to decide the question of Jurisdiction and thereafter learned Senior Civil Judge returned the plaint to appellant to seek his remedy before the proper forum vide order dated 02.11.2012. (Copy as annex "I")
9. That on 08.11.2012, respondent No. 1 directed Deputy District Officer Male/Female local officer of the Education Department to stop the salaries of those teachers whose salaries have already been released and also refused salaries to those whom have not been paid as per the attached list. (Copies as annex "J")
 10. That on 28.11.2012, appellant submitted representation to the then D.C.O, Lakki Marwat, regarding stoppage of monthly salaries. (Copy as annex "K")
 11. That on 02.07.2013, appellant submitted subsequent representations before respondents, stating therein that since June 2013, D.D.O female has stopped her monthly salaries, followed by subsequent representations dated 08.07.2013 and 19.08.2013 but no heed was paid to the same. (Copies as annex "L" "M" & "N")

Hence this appeal, inter alia, on the following grounds:

GR O U N D S:

- a. That since the date of appointment i.e 25.02.2011, appellant is performing her official duties to the best of her ability and to the entire satisfaction of the superiors without any complaint.
- b. That in order dated 08.11.2012, monthly salaries of Musarat Shaheen and Gul Rubani at serial No. 7 and 8 of the list of respondents being similarly and equally placed with appellant, their salaries has since been not only released but have also been paid to them from the date of appointment till date.
- c. That respondents has made appellant rolling stone as for some times the monthly salaries were released while for some time the same were stoped at their own will and wishes which is unwarranted under the law.

- d. That pay is equal to duty, when there is duty there would be pay and as stated earlier, appellant is performing her official duties till date diligently and with efficiency.
- e. That salary is a vested right and its refusal is not based on any legal footing, so the order of stoppage dated 08.11.2012 is of no legal effect, rather based on malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal, order dated 08.11.2012 of respondent No. 1 be set aside and they be directed to release monthly salaries to appellant since February 2011 till November 2012 and then since June 2013 till date and onward, with such other relief as may be deemed proper and just in circumstances of the case.

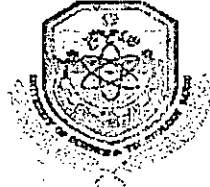

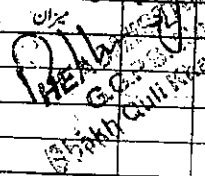

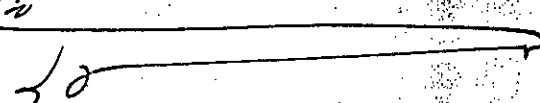

Plaintiff through husband present. Defendants through representative present.

By virtue of this order this Court has intended to dispose of an application filed by plaintiff for the grant of interim injunction and also to pass an order as to whether the instant suit is maintainable or not? Keeping in view the facts and circumstances of the case and arguments of the learned counsels for the parties, this Court has also to see as to whether this Court can dispose of the instant suit under Order 15 Rule 1 of Civil Procedure Code, 1908.

Brief facts of the instant case are that plaintiff was appointed as School Teacher vide order bearing Ends No.2074-79/PST(F) dated 25/02/2011 issued by defendant No.3 and she was posted in Government Girls Primary School, Shakh Quli Khan. After she was medically examined and submitted her medical fitness certificate to the quarter concerned, she took charge in the said School on 26/02/2011. Since then she is performing her duties regularly in the said school as is evident from the attendance register copies of which are placed on file. Copies of order of appointment, medical fitness certificate and charge assumption report is placed on file. Since the date she has taken her charge in the said school, defendants have refused to release her salary, hence the instant suit.

Arguments of learned counsel for the plaintiff and learned Government Pleader have already been heard on the preceding dates of hearings. Learned counsel for the plaintiff stated at the bar that plaintiff was duly appointed by the competent authority in accordance with law and she is performing her duties as Primary School Teacher since 26/02/2012. She has not yet been paid her salary, which is one of her fundamental rights. Learned counsel also stated at the bar that many other cases of similar nature have been disposed of by different other Civil Courts at Lakki Marwat and plaintiff may also be placed on equal footing with them by enforcing her Civil Right against the defendants.

Learned Government Pleader stated at the bar that not only the appointment of the plaintiff is illegal but there are so many other candidates whose appointment is also illegal as the posts against which they have taken their charge are not sanctioned by the competent authority. Learned Government Pleader further submitted that defendants had taken a departmental action against the persons appointed against the unsanctioned posts and inquiry was marked which has been concluded and is pending decision before the competent authority with recommendation that all illegal orders of

appointment issued on or after 11/05/2010 may be cancelled forthwith and recovery of pay and allowances may be made from Mr. Noor Hasan Ex-BDO and the drawing and disbursing officer concern. Learned Government Pleader finally stated that Section 17 of the Civil Servants Act, 1973 deals with pay which falls within the terms & conditions of the services of the Civil Servants contained in chapter 2 of the said Act and by virtue of Articles 212 of the Constitution of Islamic Republic of Pakistan read with N.W.F.P Civil Servant Act, 1973 and N.W.F.P Service Tribunal Act, 1974, the jurisdiction of the subject matter is without any doubt with service tribunal and plaintiff has no right to approach the Civil Court for redressal of her grievance. Learned Government Pleader placed his reliance on PLD 2001 SC 1032.

Keeping in view the facts and circumstances of the case, record of the case perused. Plaintiff has sought relief for the release of her salary since the date she has taken charge in the school as teacher and she is performing her duties regularly. The plea of the defendants is that the appointment of the plaintiff is illegal hence her salary can't be released. Under these circumstances there are few legal questions before the Court for decision / adjudication without recording evidence of the parties as these questions are legal in nature. The questions are as under;

1. Whether the plaintiff being a Civil Servant while performing her duties regularly is entitled to her salary?
2. Whether the appointment of the plaintiff is illegal and against the law?
3. Whether defendants are legally empowered to refuse the salary of the plaintiff?
4. Whether this court has got jurisdiction to entertain the instant suit?

So far as the question of salary of the plaintiff is concerned, every Civil Servant is entitled to his / her salary in accordance with law. Plaintiff being a Civil Servant is defiantly entitled to draw her salary till the time she is in service and performs her duties regularly. The order of appointment of plaintiff is still intact and has not been cancelled so for or otherwise the service of the plaintiff is not terminated by competent authority. As for as the contention of the defendants that appointment of plaintiff is illegal is concerned, this issue is pending decision before the competent authority (Chief Secretary) and no adverse order against the appointment of the plaintiff is yet passed. The above said inquiry was concluded on 23/06/2011, since then a sword is hanging on the head of the plaintiff having apprehension of termination of service on one side and on the other side her salary is refused by defendants. This is in a sense a kind of double jeopardy for the plaintiff.

The contention of the defendant's is that the appointment of the plaintiff is illegal and inquiry has been concluded, the report of which is submitted to the competent authority for final decision in the matter. Of course it is the prerogative of the defendants to take legal action in the matter but no adverse order is yet passed against the plaintiff

and she is performing her duty since 26/02/2011. The moment any adverse / termination order is passed against the plaintiff by competent authority in the light of recommendation of the inquiry report, she will no more be entitled to draw her salary but in the presence of any termination order, plaintiff is entitled to draw her salary with effect from the date she has taken charge as School Teacher and more importantly, her order of appointment is still intact and holds the field.

As for the question as to whether defendants can legally refused the salary of the plaintiff is concerned, N-W.F.P Civil Servant Act, 1973, governs the matters relating to the services of Civil Servant. Even under the N-W.F.P Government Servants (Efficiency and Discipline) Rules, 1973/2011, the salary of the Civil Servant can't be stopped / refused once a Civil Servant enters into a servant and so long he remains in service. Same is the case over here. Plaintiff is still in service and performs her duties and in such a situation, her salary can't legally be refused by the defendants. Admittedly, the salaries of some teacher appointed with plaintiff through the same order have been released by defendants through orders of the Civil Courts at Lakki Marwat. Denial of release of plaintiff's salary would definitely amount to discrimination and the order would be against the constitution principle of equality before law and equal treatment by law carried in Article 4 of the constitution of the Islamic Republic of Pakistan, 1973.

The question of jurisdiction in the instant case by this Court is very simple to be determined. The basic question before this Court is in fact release of salary of a civil servant which is refused by persons who are under the law not authorized to do so. Till the time plaintiff is in service and performs her duties regularly, she is entitled to draw her salary which is one of her Civil Right enforceable through Civil Courts. The moment she is terminated from her service, she will no more be entitled to draw her salary and in such an eventuality; plaintiff will have to approach to Service Tribunal for redressal her grievances.

In the light of above detail discussion, this Court has reached to the conclusion that there is no need to frame issues in the instant case and direct the parties to lead their evidence. The instant suit is hereby disposed of under Order 15 Rule 1 CPC with observation that plaintiff being a Civil Servant is entitled to draw her salary with effect from the date she has taken charge against the post and till the time she remains in service and performs her duties regularly in accordance with law. Her order of appointment is still intact and holds the field; therefore, defendants are directed to release the salary of the plaintiff immediately. This order shall not effect / pre-judice the decision of the competent authority on the recommendation of the inquiry report dated 23/06/2011. The competent authority has to determine as to whether the appointment of the plaintiff along with other candidates is in accordance with law or not and whether the services of the candidates can be terminated or not particularly in the light of the




