- 3. That CPLA is pending before the Apex Court and inspite of strong endeavours of respondents, the CPLA couldn't be fixed for hearing to issue interim/ stay orders.
- 4. Now, in pursuance of this Hon'ble Tribunal order dated 02.02.2022, the respondents have conditionally implemented the ibid Judgment. (Annex-A)
- 5. Thus the respondents have complied with the Judgment of the Tribunal in letter and spirit.
