DECLARATION TO THE EFFECT THAT**

RESPONDENT NO. 4 TO 17 ARE JUNIORS TO THE APPELLANT HAVE BEEN PROMOTED FROM THE POST OF ASSISTANT TO THE POST OF SUPERINTENDENT IN BPS-17 VIDE NOTIFICATION NO. SOH (E-VI)/IID/4-4/2022/23 MINISTERIAL STAFF DATED 12/04/2023 WHICH IS ILLEGAL, DISCRIMINATORY, AGAINST THE LAW AS WELL AS AGAINST PRINCIPLE OF SENIORITY CUM FITNESS AS PER KHYBER PAKHTUNKHWA (APT) RULES. 1989.

PRAYER:- ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, THE APPELLANT MAY BE PROMOTED FROM THE POST OF ASSISTANT TO THE POST OF SUPERINTENDENT W.E.F THE DATE OF PROMOTION OF JUNIOR EMPLOYEES I.E. 12/04/2023 WITH ALL SERVICE BACK BENEFITS AND THEREAFTER PLACE THE APPELLANT SENIOR TO RESPONDENTS NO. 4 TO 17. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEM FIT AND APPROPRIATE IN THE CIRCUMSTANCES OF

THE CASE MAY ALSO BE ALLOWED TO
THE APPELLANT.

Respectfully Sheweth:-

That the facts forming the back grounds of the instant service appeal are arrayed as under;-

1. That the appellant got appointment as Assistant through Khyber Pakhtunkhwa Public Service Commission in the year 2008 and as per law, 75% were to be promoted out of the same batch. The promotees of the same batch were declared seniors to the Appellant. Hence, the appellant was placed senior to other employees who were promoted in the year 2009 onward in the seniority list issued by the department from 2011 to 2019 but all of sudden in the seniority list dated 07/12/2022 the respondent No. 4 to 17 are shown senior to the appellant which is illegal and the appellant being senior to the said respondents is to be promoted to the post of superintendent w.e.f the date of promotion of the junior employees.

2. That the appellant in pursuance of the appointment order dated 04/05/2009 took over the charge of office Assistant at Bannu Medical College Bannu on 18/05/2009. Copy of Arrival report dated 18/05/2009 is attached as Annexure "A".
3. That the appellant was upgraded from BPS-14 to BPS-16 on 20/05/2014. Copy of Notification dated 20/05/2014 is attached as Annexure "B".
4. That presently appellant is performing his duties as Office Assistant BPS-16 at BBS Teaching Hospital Abbottabad. Copy of posting order is attached as Annexure "C".
5. That the appellant took over the charge of Office Assistant on 18/05/2009 and was placed as Serial No. 89 of the seniority list issued in the year 2014, at serial No. 57 in the seniority list of year 2017, at Serial No. 48 in seniority list of year 2018 and at serial No. 37 in the seniority list of year 2019. Copy of year wise seniority positions is attached as Annexure "D" and seniority list

of 2014, 2017, 2018 and 2019 are attached as Annexure "E".

6. That the final seniority list of office Assistant issued vide notification dated 07/12/2022, the appellant was placed Junior the respondents No. 4 to 17 inspite of mentioning their date of joining to the post of Office Assistant. Copy of final seniority list of the year 2022 is attached as Annexure "F".
7. That the appellant challenged the seniority list issued on 07/12/2022 wherein the present promotees were challenged being juniors to the appellant before this Honourable Tribunal vide Service Appeal No. 827/23 which is pending for adjudication. Copy of Service Appeal No. 827/23 is attached as Annexure "G".
8. That during the pendency of service appeal NO. 827/2023, the respondent No. 2 vide order notification dated 12/04/2023 promoted respondent No. 4 to 17 vide notification dated 12/04/2023 who are

juniors to the appellant and the appellant has already challenged his seniority in the service appeal No. 827/2023 pending adjudication. Copy of impugned promotion notification dated 12/04/2023 is annexed as Annexure "H".

9. That feeling aggrieved from the impugned notification dated 12/04/2023, the appellant filed appeal before Chief Secretary Govt. of Khyber Pakhtunkhwa, Peshawar. Copy of departmental appeal dated 05/05/2023 having diary No. 1950 dated 09/05/2023 is attached as Annexure "I". The departmental appeal is yet to be decided by the department.
10. That the matter relates to the term and condition of service. Hence this Honourable Tribunal has jurisdiction to entertain the service appeal of the appellant.
11. That the instant service appeal is well within the period of limitation.
12. That the valuable rights of the appellant are involved.

13. That other points shall be urged at the time of arguments.

It is therefore, humbly prayed that on acceptance of the instant service appeal, the appellant may be promoted from the post of assistant to the post of superintendent w.e.f the date of promotion of junior employees i.e. 12/04/2023 with all service back benefits and thereafter place the appellant senior to respondents no. 4 to 17. Any other relief which this honourable tribunal deem fit and appropriate in the circumstances of the case may also be allowed to the appellant.
