

The brief facts leading to the instant appeal are arrayed as follows: -

- 1) That, the appellant was selected in Frontier Corps as a constable where he served for about 01 year. The appellant was posted in Waziristan.
- 2) That, the appellant came to know about the vacancies of constables in Police Department and applied for the said vacancy as constable. The appellant had brought all these facts

in the notice of his immediate officer of F.C and he was permitted by his officer to appear for selection in Police Department.

- 3) That, the appellant qualified all the courses meant for selection in Police Department and an appointment order was also issued.

(The copy of appointment order is attached as Annexure "A").

- 4) That, the appellant submitted an application for issuance of No Objection Certificate to Commandant FC, Waziristan but the requisite No Objection Certificate was refused to be issued.

(The copy of application is attached as annexure "B").

- 5) That, a charge sheet was issued by respondent No. 1 and an inquiry was also conducted wherein the statement of the appellant was recorded.

(The copy of charges sheet and the statement of the appellant are attached as Annexure "C" & "D" respectively)

- 6) That, the appellant was dismissed from service by DPO Mansehra vide order book No. 85 dated 01.06.2023. The appellant aggrieved from the order of dismissal submitted an appeal before DIG

Hazara Range Abbottabad, but his appeal met the same fate.

That, the appellant assails the order of his dismissal on the following amongst other grounds: -

GROUNDS: -

- A) That, the order of dismissal of the appellant is against the facts and law and thus the order of dismissal is not maintainable in the eye of law.
- B) That, while being posted in FC, the appellant had informed his high-ups about his selection in Police Department and he was permitted by FC department to appear and to get himself selected.
- C) That, the appellant had applied, appeared, qualified the test with the express permission and consent of his previous employer.
- D) That, when the appellant qualified all the test and the para-meter laid down for selection in Police Deptt., he approached FC for the issuance of No Objection Certificate but the

same was blatantly refused by the said quarter.


- E) That, it was incumbent upon the police department to have probe into the reasons and the grounds but no any regular inquiry was conducted nor the official from FC were examined to come to the logical conclusion and instant passed an order violating the rules, regulations and deprived the appellant of the rights guaranteed to him by the Constitution and the other laws.
- F) That, the DPO was bound to have issued a final show cause notice but he had passed the order in a very haste manner which is quite alien to law.

It is, therefore, humbly prayed and requested that on acceptance of appeal the impugned order may kindly be set aside and the appellant may kindly be re-instated in service.





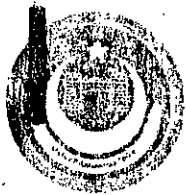
